#### AGREEMENT OF VARIATION #1

Relating to Contract Ref: C50936 (previously ecm\_6308) - PHE\_Scientific (Bristol and Cambridge) - Blood Borne Viruses (CapEx) under 2020/S 217-533940 National Microbiology Framework Terms and Conditions dated 23rd November 2018.

**THIS AGREEMENT** is signed and dated on the date of the Authority's signature (the "Agreement")

## **BETWEEN:**

- The Secretary of State for Health and Social Care as part of the Crown through the UK Health Security Agency of 10 South Colonnade, London, E14 4PU (the "Authority"); and
- Qiagen Limited, a company registered in England with registration number 02858916, whose registered office is at Citylabs 2.0 Hathersage Road, Manchester, England, M13 0BH.

(the "Supplier"),

together the "Parties" and each a "Party"

### **BACKGROUND:**

- A. The Authority and the Supplier are Parties to a contract: PHE\_Scientific (Bristol and Cambridge) Blood Borne Viruses (CapEx) dated 23<sup>rd</sup> November 2018 Contract Reference: C50936 (previously ecm\_6308) (the "Contract").
- B. The Parties wish to amend the Contract as set out in this Agreement.

# IT IS AGREED as follows:

#### 1 TERMS DEFINED IN THE CONTRACT

1.1 In this Agreement, unless stated to the contrary, terms defined in the Contract and used in this Agreement have the meanings set out in the Contract. The rules of interpretation set out in the Contract shall apply to this Agreement.

#### 2 VARIATION

- 2.1 With effect from the date of the Authority's signature of this variation, (the "Variation Date") the Parties agree to amend the Contract.
- 2.2 The Contract Reference number has changed from ecm\_6308 to C50936.
- Pursuant to clause 2.1 of Schedule 1 and in accordance with clause 15.2 of Schedule
  2 of the Framework Terms and Conditions, the Term of the Contract shall be extended
  by 12 months from 31<sup>st</sup> December 2023 to 31st December 2024.

- 2.4 The maximum Contract Price has been increased from £1,334,000.00 (one million, three hundred and thirty-four thousand pounds) to £1,384,000.00 (one million, three hundred and eighty-four thousand pounds).
- 2.5 The Contract Prices of the Consumables included in the Contract have been amended as below:

# 4 GOVERNING LAW AND JURISDICTION

- **4.1** This Agreement, and any dispute or claim arising out of or in connection with it or its subject matter (including any non-contractual claims), shall be governed by, and construed in accordance with, the laws of England and Wales.
- 4.2 The Parties irrevocably agree that the courts of England and Wales shall have nonexclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Agreement or its subject matter.
