Award of contract for the supply of Provision of Certified Drug Reference Standards Contract

Following your tender / proposal for the supply of certified drug reference standards contract to Home Office Centre for Applied Science and Technology (CAST), we are pleased to award this contract to you. The attached appendix provides detailed feedback on your submitted proposal.

- 1.6. The Term shall commence on Thursday 22nd June 2017 (the "Start Date") and the Expiry Date shall be 21st June 2018.
