### NAMED REPRESENTATIVES OF THE AUTHORITY

The Service Provider shall be advised in writing of those Authority staff who have delegated approval authority by the relevant Named Representatives, as listed above. In the event that the Service Provider carries out a Service without an instruction from either the Named Representative of the Authority or an individual with delegated authority, the Authority may withhold payment for those Services.
