





- Items denoted as Private Venture Funded (PVF) would generally indicate that it and all of its sub-componer HMG. In this instance there is no need to proceed down the product breakdown structure any further (see 1 PVF regarded item has incorporated a Previous Authority Funded (PAF) item (see 2.21).
- iii. The proposed design is making use of a PAF engine.
