1. The Secretary of State for Business, Energy and Industrial Strategy [("the Authority")] of 1 Victoria Street, London SW1H 0ET, acting as part of the Crown;

and

2. Protium Green Solutions Limited (the "Contractor") whose registered office is at Unit 110, 164-180 Union Street, London, EC1N 8DX.

INTRODUCTION

- (A) On 20th March 2021, the Authority issued an invitation to tender for the provision of Green Distilleries – Phase 2 Competition (TRN 4927/03/2021), including the specification, a copy of which is set out in Schedule 1 (the "Specification").
- (B) In response the Contractor submitted a proposal entitled Project HyLaddie (Lot 1: focus on fuel switching of the process and onsite power) explaining how it would provide the Services, a copy of which is set out in Schedule 2 (the "Proposal").

The parties agree as follows:-

1. SUPPLY OF SERVICES AND CONTRACT PRICE

In consideration of payment by the Authority to the Contractor of the sum of £2,650,041.64, (two million six hundred fifty thousand forty-one pounds and sixty-four pence), (exclusive of Value Added Tax) (the "Contract Price") and in accordance with (a) the Specification; (b) the Proposal; and (c) the Authority's Terms and Conditions of Contract for Services (as detailed in Appendix 4 of the Green Distilleries Phase 2 Guidance Notes, "Schedule 1", and attached in Schedule 3); the Contractor shall provide the Services described in the Specification and the Proposal to the Authority.

2. COMMENCEMENT AND CONTINUATION

- 2.1 This contract shall commence on ...03/11/2021..... and, subject to any provisions for earlier termination contained in the Terms and Conditions clause 2.2, 2.3 and 2.4, shall continue until 30th June 2023.
- 2.2 The continuation of this Contract shall be subject to completing and passing the stage gate review points provided in Schedule 2 ("BEIS Project Plan and Finance Tables_HyLaddie 05 10 21"), also summarised below:

1) FEED completion	25/01/2022

The Contractor will need to provide a report for each stage gate review point summarising the nature of the stage gate review point and how this stage gate review has been met, providing any supporting evidence. This report will need to be submitted by the stage date review deadline for each stage gate review point. The report will need sign off and approval from the Authority before the Contractor can continue with the project. The Authority reserves the right to terminate the contract in accordance with the Terms and Conditions if the Contractor fails to submit a report before the deadline or pass the stage gate review point.

- 3.3 This Contract is formed of these clauses and the Schedules hereto. Any other attachments are provided for information purposes only and are not intended to be legally binding. In the event of any conflict or inconsistency, the documents prevail in the following order:
 - a) these clauses;
 - b) the Terms and Conditions;
 - c) the Specification; and
 - d) the Proposal.
- 3.4 The Authority acknowledges that the Contractor intends to use or supply under this Contract certain Background Intellectual Property which is

licensed from a third party **This information has been redacted** To the extent any Arising Intellectual Property comprises (i) any improvement or modification to **This information has been redacted** or (ii) any other Intellectual Property Rights for which **This information has been redacted** is essential to their functioning and use (together, **This information has been redacted**), the Authority agrees that (x) the licence granted pursuant to Condition 27(3) and the licence(s) which may be required to be granted pursuant to Condition 28(7) shall be limited to the UK and Ireland only, and (y) Conditions 27(4), 27(5) and 28(5) shall not apply. For the avoidance of any doubt, the parties agree that any copyright in any report submitted by Contractor to Authority for publication does not constitute a **Method Schulter** and accordingly may be published by Authority on its website (not limited to readers in UK and Ireland) for non-commercial purposes in accordance with Condition 27(3).

4. CONTRACTOR'S OBLIGATIONS

- 4.1 Where the Contractor is supplying goods to the Authority these shall be delivered to the Authority in full compliance with the Specification and shall be of satisfactory quality and fit for purpose.
- 4.2 Where the Contractor is performing services for the Authority it shall do so in accordance with the Specification and exercise reasonable skill and care.

5. MANAGEMENT AND COMMUNICATIONS

- 5.1 The Contractor shall deliver and perform the Services under the direction of the Authority.
- 5.2 Any direction by the Authority may be given by **Introduction has been reducted** (the "Contract Manager") who is an officer in the Authority's Industry and CCUS Innovation Programme, 1 Victoria Street, London SW1H 0ET or such other person as is notified by the Authority to the Contractor in writing.

6.1 Subject to the Contractor providing the Services to the Authority in accordance with this Contract and submitting invoices to the Contract Manager in the manner reasonably required by the Contract Manager payment will be made by the Authority to the Contractor in accordance with (as referred to in Condition 11 of the Terms & Conditions).

Evidence of payments over £5,000 to suppliers and subcontractors is required via the submission of receipted invoices and/or bank statements.

7. TRANSPARENCY

7.1 The Authority is required to publish information about this contract through the Governments Transparency website and Contracts Finder. The Authority's decision not to publish full details of the Contract does not however preclude it publishing such information in the future (subject to applicable redactions) and the Authority may be required to disclose such information under the Freedom of Information Act 2000 (FOIA), the Environmental Information Regulations 2004 (EIR) or other legal requirement. The Contractor shall provide such assistance and information as the Authority may require to fulfil its obligations under FOIA and EIR. In such cases, the Authority would need to consider disclosure in the context of the particular circumstances of the request or requirement concerned.
