CONTRACT FOR: Strengthening Evidence for Programme on Unintended Pregnancy (STEPUP)

With reference to the contractual letter dated 23rd December 2010 (as most recently amended by the letter dated 22 May 2012) whereby your firm was engaged to carry out the services as defined in Section 3, I confirm that the UK Government wishes to make the following further amendments to the letter of 23rd December 2010:
