WHEREAS:

(A) The Supplier and Buyer entered into a Call-Off Contract with a start date of July 13, 2019 through to April 12, 2021 for the provision of G-Cloud Services as outlined below:

Workday Learning; and

o Workday Media Cloud.

(B) The initial Call-Off Contract value was £225,596.00 (excluding VAT) with the Subscription cost for the first year, as included in the Call-Off Contract, detailed below:

(C) As part of the Call-Off Contract a Supplier Subscription Order Form #00184246.0 was executed for the G-Cloud Service with a start term of July 13, 2019 through to April 12, 2021 (“Expiring Order Form”).

(D) As per the terms of the Expiring Order Form the Workday Planning Service has subsequently been novated to Workday Adaptive Planning Service and is subject to the terms and conditions set out in the Adaptive Insights Order Form and Adaptive Insights MSA.

By means of this variation (“Variation”), Buyer wishes to proceed with a twelve (12) month extension to the Call-Off Contract and to incorporate a new Supplier Order Form #00249061.0 under the Call-Off Contract, to extend the Subscription to the G-Cloud Services outlined above and setting out the additional Subscription Fees due in consideration for such extension.

THEREFORE:

The Call-Off Contract is varied as follows:

1. The Call-Off Contract is hereby extended for a period of twelve (12) months, from April 13, 2021 through to April 12, 2022.
2. The initial Call-Off Contract total value did not take into account any permitted extensions and as such in consideration for a twelve (12) month extension, Buyer shall pay Workday a fee of REDACTED (excluding VAT) as set out in Supplier Order Form #00249061.0 and executed herewith.
3. Workday Adaptive Planning is governed by the terms and conditions set out in Supplier Order Form #00249061.0 and, for the avoidance of doubt, it is not governed by the terms of the Call-Off Contract.
4. For the avoidance of doubt there are no further new services required as part of this extension and the requirement is an extension of the current subscriptions only. There are no changes to goods or services for the purposes of this variation.
5. Words and expressions in this Change Control Notice shall have the meanings given to them in the Call-Off Contract.
6. The Call-Off Contract, including any previous Call-Off Contract changes, authorised in writing by both Parties, shall remain effective and unaltered except as amended by this Change Control Notice.
