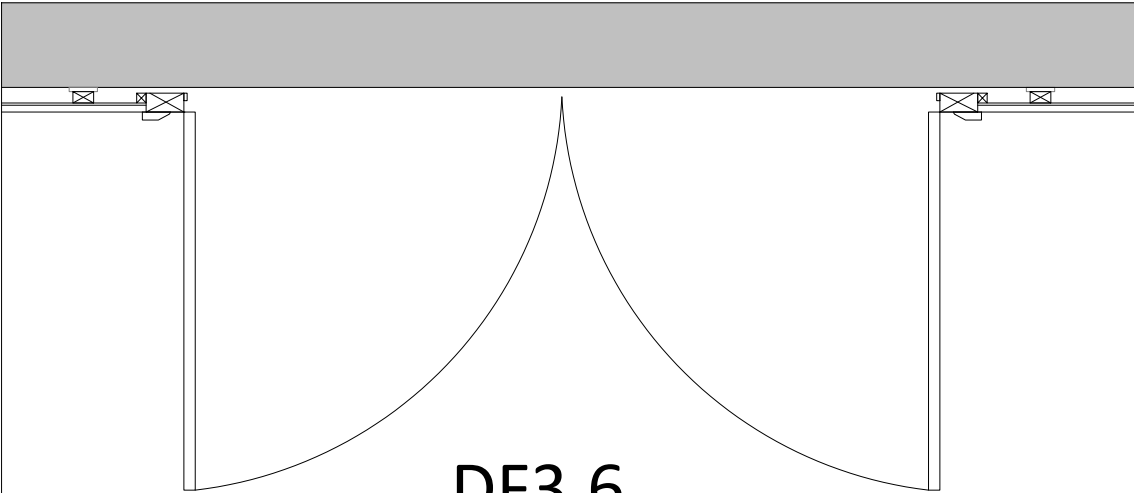
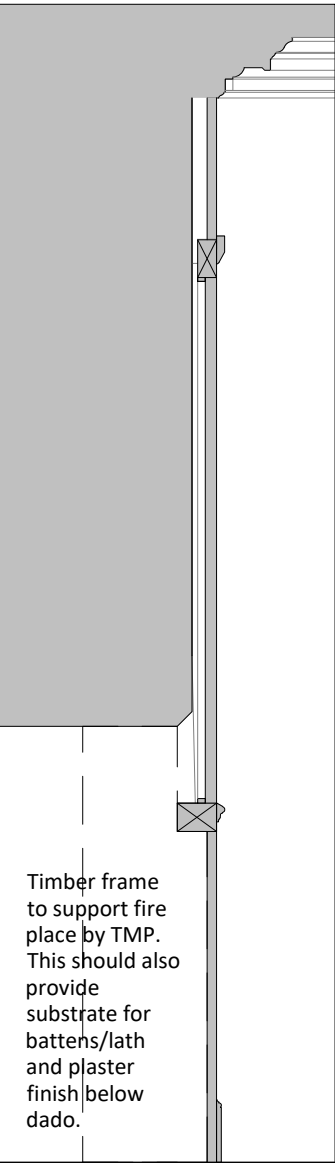


- All dimensions to be checked on site prior to orders:
- Allow for new frame formed from 100 x 75mm s/w timbers rebated to form stop on jambs and head, and with separate 12 x 20mm stop on dado transom. N.B. Transom to be fixed to support framing for fire place; head to act as trimmer to lath and plaster battens; Fixing locations into walling to be agreed on site. Include for screw fixing 25 x 25mm battens to the sides of jambs to carry the end of the laths.
 - New 30mm solid core plywood paint grade flush FD30 Door blank.
 - 2no Eclipse CF336 102x76x3mm grade 13 brass plated st/sl fire door hinges per leaf (4no total).
 - Fit with UNION 2277 3 lever mortice sash lock to brass finish, reeded brass door knobs and escutcheon; brushed Brass Flush Door Bolts (128mm) by Mucheln, locking into frame at top and bottom of slave leaf.
 - New architrave to match profile of existing to doors in adjacent partitions.
 - Reinstate existing dado rails. Replace to match existing where condition dictates.
 - Decorate door, frame and architrave with Oil Based Eggshell by Rose of Jericho, colour white (per CAL original NBS M60/160)

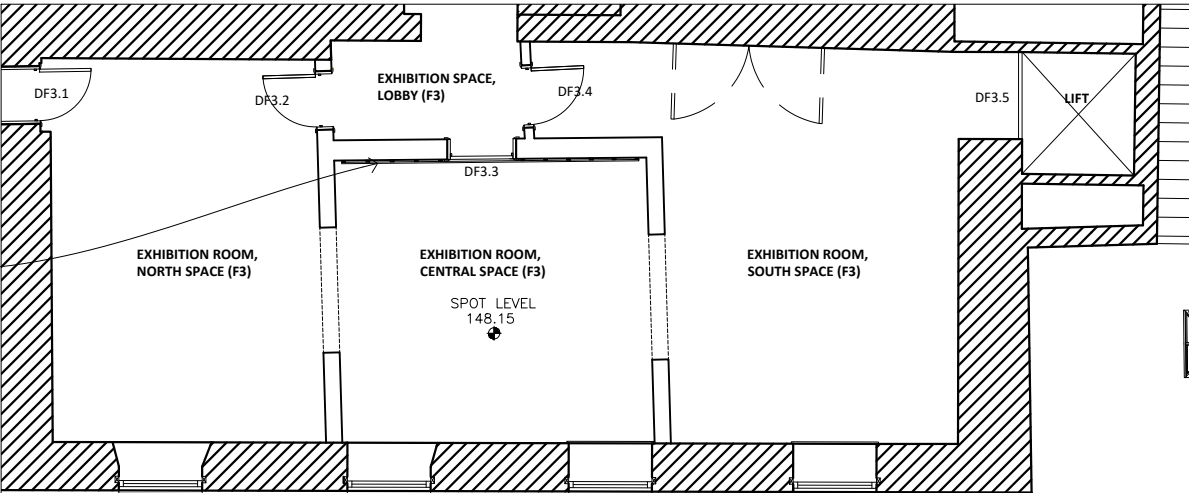
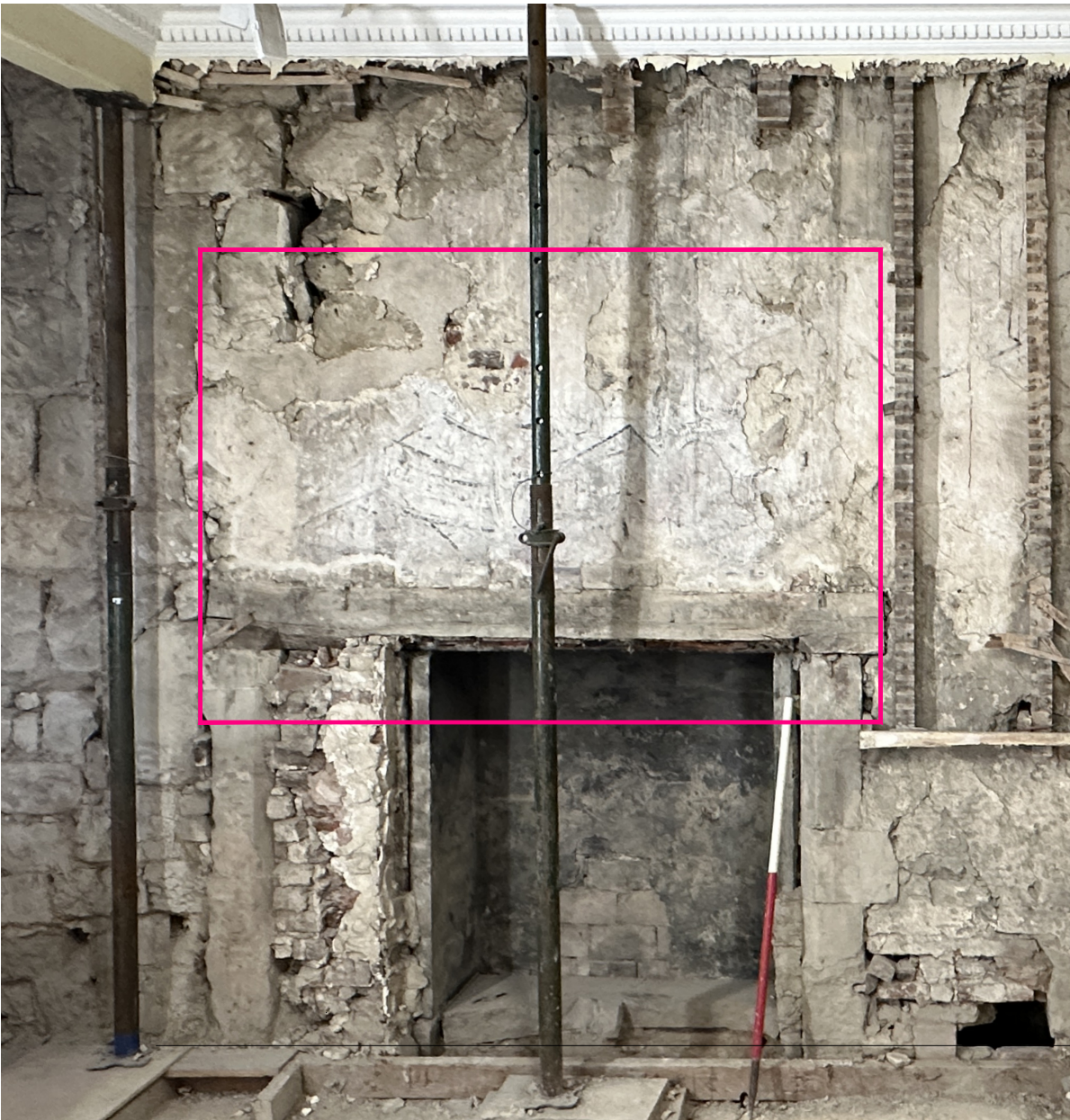
Elevation, 1:20@A3

Provisional: plasterboard or painted ply screen battened out from wall to provide screening across door for projected images if required. Size TBC.

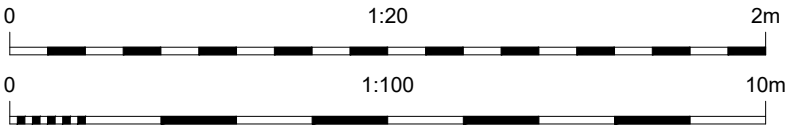
