All tenders submitted must include an itemised breakdown including materials and labour cost.

Evaluation criteria:

1. Degree to which the tender aligns with the established specification. 40%
2. Price 30%
3. Quality and durability warranty relating to workmanship, materials and fittings proposed to be used. 30%

The Council shall not be obligated to cover any costs associated with any tender, quote or estimate.

Specification:

Ladies' facilities:

1. Replacement of existing wash basin units, soap dispensers and hand dryers with 3 No. all-in-one units, including all associated works.
2. Replacement of 3 toilets and associated items.
3. Replacement of a total of 3 No. cubicle doors with hard-wearing (vandal proof) units. SGL doors with Burstcatch locking mechanism or equivalent.
4. Upgrading of a 1 No. radiator including protective cage.
5. Replacement of existing floor tiles with like for like. (non slip)
6. Keep existing wall tiles and re-cover with an anti-graffiti coating.
Any gaps in tiling to be replaced like for like or section replaced where appropriate.
7. Repaint ceilings throughout
8. Replacement of 3 No. toilet roll holders

Gents' facilities

1. Replacement of existing wash basin units, soap dispensers and hand dryers with 2. No. all-in-one units, including all associated works.
2. Replacement of 2 toilets and associated item.
3. Replacing urinals and associated items.
4. Replacement of a total of 2 No. cubicle doors with hard-wearing (vandal proof) units. SGL doors with Burstcatch locking mechanism.
5. Upgrading 1 No. radiator including protective cage.
6. Replace existing floor tiles with like for like. (non slip)
7. Keep existing wall tiles and re-cover with an anti-graffiti coating.
Any gaps in tiling to be replaced like for like or section replaced where appropriate.
8. Repaint ceilings throughout.
9. Replacement of 2 No. toilet roll holders.

Disabled facilities

1. Upgrading of disabled facilities ensuring they remain DDA compliant, complete with necessary grab rails, and (stationery, hinged) and DDA compliant replacement of existing wash basin units, soap dispensers and hand dryers with all-in-one units, including all associated works. All pipework to be boxed off.
2. Replacement of toilet and associated items ensuring DDA compliance.
3. Upgrading of 1 No. radiator including protective cage.
4. Replacement of existing floor tiles with like for like. (non slip)
5. Keep existing wall tiles and re-cover with an anti-graffiti coating.
Any gaps in tiling to be replaced like for like or section replaced where appropriate.
6. Repaint ceilings throughout.
7. Replacement of toilet roll holder.

Baby changing facility.

1. Replacement of existing wash basin units, soap dispensers and hand dryers with all-in-one units, including all associated works.
2. New hard wearing pull down baby changing unit.
3. Upgrading of 1 No. radiator including protective cage.
4. Replace existing floor tiles with like for like.
5. Keep existing wall tiles and re-cover with an anti-graffiti coating.
Any gaps in tiling to be replaced like for like or section replaced where appropriate.
6. Repaint ceilings throughout.

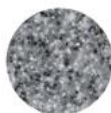

Proposed toilet roll holder:



High grade brushed stainless steel mini jumbo toilet roll dispenser.

The heavy duty full back plate gives the dispenser added strength and stability and has been designed for wash-rooms that may be subject to vandalism or have problems with toilet roll theft.

Key locking mechanism, with slam lock.

Additional notes:

- **This high traffic public toilet facility is prone to vandalism therefore robust, reliable, long lasting, highly durable and hard-wearing products are essential.**
- All products proposed should be clearly presented with detailed specification, including photographs.
- The council strongly advises that an on site survey is undertaken prior to quote.
- All items to be disposed of must be taken to a suitable waste disposal site and proof of correct disposal will be required.
- The Town Council is not in possession of an asbestos register for this building as it was built after the year 2000 and following HSE guidance a survey is not required.
- Proof of Public Liability and Employer Liability insurance must be provided.
- The contractor must provide all certificates required and related to the nature of the work undertaken.
- The Contractor shall undertake to always observe Newport Town Council's Health and Safety policy.
- The contractor will supply written Risk Assessments for the works to be undertaken.
- The Contractor will be required to submit a Method Statement for approval prior to commencement of works.
- Toilet facilities to be always maintained to members of the public if logistically possible.
- Three references will be required as part of your tender.
