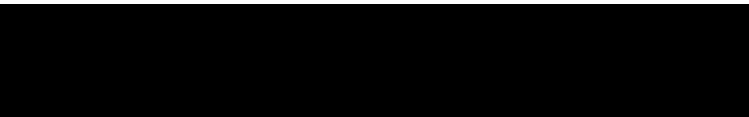

1.1 The Supplier shall take out and maintain, or procure the taking out and maintenance of the insurances as set out in the Annex to this Schedule, any additional insurances required under an Order Contract (specified in the applicable Order Form) ("**Additional Insurances**") and any other insurances as may be required by applicable Law (together the "**Insurances**"). The Supplier shall ensure that each of the Insurances is effective no later than:

1.1.1 the DPS Start Date in respect of those Insurances set out in the Annex to this Schedule and those required by applicable Law; and

1.1.2 the Order Contract Effective Date in respect of the Additional Insurances.

1.2 The Insurances shall be:

1.2.1 maintained in accordance with Good Industry Practice;

1.2.2 (so far as is reasonably practicable) on terms no less favourable than those generally available to a prudent contractor in respect of risks insured in the international insurance market from time to time;

1.2.3 taken out and maintained with insurers of good financial standing and good repute in the international insurance market; and

7.3 Where any Insurance requires payment of a premium, the Supplier shall be liable for and shall promptly pay such premium.

7.4 Where any Insurance is subject to an excess or deductible below which the indemnity from insurers is excluded, the Supplier shall be liable for such excess or deductible. The Supplier shall not be entitled to recover from the Relevant Authority any sum paid by way of excess or deductible under the Insurances whether under the terms of this Contract or otherwise.

 - 1.3.2 the proposed Key Subcontractor is unreliable and/or has not provided reliable goods and or reasonable services to its other customers; and/or
 - 1.3.3 the proposed Key Subcontractor employs unfit persons.
- 1.4 The Supplier shall provide CCS and the Buyer with the following information in respect of the proposed Key Subcontractor:
 - 1.4.1 the proposed Key Subcontractor's name, registered office and company registration number;
 - 1.4.2 the scope/description of any Deliverables to be provided by the proposed Key Subcontractor;
 - 1.4.3 where the proposed Key Subcontractor is an Affiliate of the Supplier, evidence that demonstrates to the reasonable satisfaction of the CCS and the Buyer that the proposed Key Sub-Contract has been agreed on "arm's-length" terms;

- 3.2 The SME Management Information Reports shall be provided by the Supplier in the correct format as required by the Supply Chain Information Report Template and any guidance issued by the Relevant Authority from time to time. The Supplier agrees that it shall use the Supply Chain Information Report Template to provide the information detailed at Paragraph 3.1(a) –(c) and acknowledges that the template may be changed from time to time (including the data required and/or format) by the Relevant Authority issuing a replacement version. The Relevant Authority agrees to give at least thirty (30) days’ notice in writing of any such change and shall specify the date from which it must be used.

Subcontractor fails to satisfy any claims under such indemnities the Supplier will be liable for satisfying any such claim as if it had provided the indemnity itself.

- 2.2 The provisions of Paragraphs 2.1 and 2.6 of Part A, Paragraph 3.1 of Part B, Paragraphs 1.5, 1.7 and 1.9 of Part C, Part D and Paragraphs 1.4, 2.3 and 2.8 of Part E of this Schedule (together “Third Party Provisions”) confer benefits on third parties (each such person a “Third Party Beneficiary”) and are intended to be enforceable by Third Party Beneficiaries by virtue of the CRTPA.

- 2.5 Any amendments or modifications to this Order Contract may be made, and any rights created under Paragraph 2.2 above may be altered or extinguished, by the Parties without the consent of any Third Party Beneficiary.

3. Which parts of this Schedule apply

Only the following parts of this Schedule shall apply to this Call Off Contract:

- Part C (No Staff Transfer on the Start Date)
- Part E (Staff Transfer on Exit)

Part C: No Staff Transfer on the Start Date

1. What happens if there is a staff transfer

- 1.1 The Buyer and the Supplier agree that the commencement of the provision of the Services or of any part of the Services will not be a Relevant Transfer in relation to any employees of the Buyer and/or any Former Supplier.
- 1.2 If any employee of the Buyer and/or a Former Supplier claims, or it is determined in relation to any employee of the Buyer and/or a Former Supplier, that his/her contract of employment has been transferred from the Buyer and/or the Former Supplier to the Supplier and/or any Subcontractor pursuant to the Employment Regulations or the Acquired Rights Directive then:
 - 1.2.1 the Supplier shall, and shall procure that the relevant Subcontractor shall, within 5 Working Days of becoming aware of that fact, notify the Buyer in writing and, where required by the Buyer, notify the Former Supplier in writing; and
 - 1.2.2 the Buyer and/or the Former Supplier may offer (or may procure that a third party may offer) employment to such person within 15 Working Days of the notification from the Supplier or the Subcontractor (as appropriate) or take such other reasonable steps as the Buyer or Former Supplier (as the case may be) it considers appropriate to deal with the matter provided always that such steps are in compliance with applicable Law.
- 1.3 If an offer referred to in Paragraph 1.2.2 is accepted (or if the situation has otherwise been resolved by the Buyer and/or the Former Supplier),, the Supplier shall, or shall procure that the Subcontractor shall, immediately release the person from his/her employment or alleged employment.
- 1.4 If by the end of the 15 Working Day period referred to in Paragraph 1.2.2:
 - 1.4.1 no such offer of employment has been made;
 - 1.4.2 such offer has been made but not accepted; or
 - 1.4.3 the situation has not otherwise been resolved;the Supplier may within 5 Working Days give notice to terminate the employment or alleged employment of such person.
- 1.5 Subject to the Supplier and/or the relevant Subcontractor acting in accordance with the provisions of Paragraphs 1.2 to 1.4 and in accordance with all applicable employment procedures set out in applicable Law and subject also to Paragraph 1.8 the Buyer shall:
 - 1.5.1 indemnify the Supplier and/or the relevant Subcontractor against all Employee Liabilities arising out of the termination of the employment of any of the Buyer's employees referred to in Paragraph 1.2 made pursuant to the provisions of Paragraph 1.4 provided that the Supplier takes, or shall procure that the

- Subcontractor takes, all reasonable steps to minimise any such Employee Liabilities; and
- 1.5.2 procure that the Former Supplier indemnifies the Supplier and/or any Subcontractor against all Employee Liabilities arising out of termination of the employment of the employees of the Former Supplier referred to in Paragraph 1.2 made pursuant to the provisions of Paragraph 1.4 provided that the Supplier takes, or shall procure that the relevant Subcontractor takes, all reasonable steps to minimise any such Employee Liabilities.
- 1.6 If any such person as is described in Paragraph 1.2 is neither re employed by the Buyer and/or the Former Supplier as appropriate nor dismissed by the Supplier and/or any Subcontractor within the 15 Working Day period referred to in Paragraph 1.4 such person shall be treated as having transferred to the Supplier and/or the Subcontractor (as appropriate) and the Supplier shall, or shall procure that the Subcontractor shall, comply with such obligations as may be imposed upon it under Law.
- 1.7 Where any person remains employed by the Supplier and/or any Subcontractor pursuant to Paragraph 1.6, all Employee Liabilities in relation to such employee shall remain with the Supplier and/or the Subcontractor and the Supplier shall indemnify the Buyer and any Former Supplier, and shall procure that the Subcontractor shall indemnify the Buyer and any Former Supplier, against any Employee Liabilities that either of them may incur in respect of any such employees of the Supplier and/or employees of the Subcontractor.
- 1.8 The indemnities in Paragraph 1.5:
- 1.8.1 shall not apply to:
- (a) any claim for:
- (i) discrimination, including on the grounds of sex, race, disability, age, gender reassignment, marriage or civil partnership, pregnancy and maternity or sexual orientation, religion or belief; or
- (ii) equal pay or compensation for less favourable treatment of part-time workers or fixed-term employees,
- in any case in relation to any alleged act or omission of the Supplier and/or Subcontractor; or
- (b) any claim that the termination of employment was unfair because the Supplier and/or any Subcontractor neglected to follow a fair dismissal procedure; and
- 1.8.2 shall apply only where the notification referred to in Paragraph 1.2.1 is made by the Supplier and/or any

Subcontractor to the Buyer and, if applicable, Former Supplier within 6 months of the Start Date.

- 1.9 If the Supplier and/or the Subcontractor does not comply with Paragraph 1.2, all Employee Liabilities in relation to such employees shall remain with the Supplier and/or the Subcontractor and the Supplier shall (i) comply with the provisions of Part D: Pensions of this Schedule, and (ii) indemnify the Buyer and any Former Supplier against any Employee Liabilities that either of them may incur in respect of any such employees of the Supplier and/or employees of the Subcontractor.

2. Limits on the Former Supplier's obligations

Where in this Part C the Buyer accepts an obligation to procure that a Former Supplier does or does not do something, such obligation shall be limited so that it extends only to the extent that the Buyer's contract with the Former Supplier contains a contractual right in that regard which the Buyer may enforce, or otherwise so that it requires only that the Buyer must use reasonable endeavours to procure that the Former Supplier does or does not act accordingly.

Part E: Staff Transfer on Exit

1. Obligations before a Staff Transfer

- 1.1 The Supplier agrees that within 20 Working Days of the earliest of:
- 1.1.1 receipt of a notification from the Buyer of a Service Transfer or intended Service Transfer;
 - 1.1.2 receipt of the giving of notice of early termination or any Partial Termination of the relevant Contract;
 - 1.1.3 the date which is 12 Months before the end of the Term; and
 - 1.1.4 receipt of a written request of the Buyer at any time (provided that the Buyer shall only be entitled to make one such request in any 6 Month period),
- it shall provide in a suitably anonymised format so as to comply with the Data Protection Legislation, the Supplier's Provisional Supplier Personnel List, together with the Staffing Information in relation to the Supplier's Provisional Supplier Personnel List and it shall provide an updated Supplier's Provisional Supplier Personnel List at such intervals as are reasonably requested by the Buyer.
- 1.2 At least 20 Working Days prior to the Service Transfer Date, the Supplier shall provide to the Buyer or at the direction of the Buyer to any Replacement Supplier and/or any Replacement Subcontractor (i) the Supplier's Final Supplier Personnel List, which shall identify the basis upon which they are Transferring Supplier Employees and (ii) the Staffing Information in relation to the Supplier's Final Supplier Personnel List (insofar as such information has not previously been provided).

- 1.3 The Buyer shall be permitted to use and disclose information provided by the Supplier under Paragraphs 1.1 and 1.2 for the purpose of informing any prospective Replacement Supplier and/or Replacement Subcontractor.
- 1.4 The Supplier warrants, for the benefit of The Buyer, any Replacement Supplier, and any Replacement Subcontractor that all information provided pursuant to Paragraphs 1.1 and 1.2 shall be true and accurate in all material respects at the time of providing the information.
- 1.5 From the date of the earliest event referred to in Paragraph 1.1.1, 1.1.2 and 1.1.3, the Supplier agrees that it shall not, and agrees to procure that each Subcontractor shall not, assign any person to the provision of the Services who is not listed on the Supplier's Provisional Supplier Personnel List and shall not without the approval of the Buyer (not to be unreasonably withheld or delayed):

:

- 1.5.1 replace or re-deploy any Supplier Staff listed on the Supplier Provisional Supplier Personnel List other than where any replacement is of equivalent grade, skills, experience and expertise and is employed on the same terms and conditions of employment as the person he/she replaces
- 1.5.2 make, promise, propose, permit or implement any material changes to the terms and conditions of employment of the Supplier Staff (including pensions and any payments connected with the termination of employment);
- 1.5.3 increase the proportion of working time spent on the Services (or the relevant part of the Services) by any of the Supplier Staff save for fulfilling assignments and projects previously scheduled and agreed;
- 1.5.4 introduce any new contractual or customary practice concerning the making of any lump sum payment on the termination of employment of any employees listed on the Supplier's Provisional Supplier Personnel List;
- 1.5.5 increase or reduce the total number of employees so engaged, or deploy any other person to perform the Services (or the relevant part of the Services);
- 1.5.6 terminate or give notice to terminate the employment or contracts of any persons on the Supplier's Provisional Supplier Personnel List save by due disciplinary process;

and shall promptly notify, and procure that each Subcontractor shall promptly notify, the Buyer or, at the direction of the Buyer, any Replacement Supplier and any Replacement Subcontractor of any notice to terminate employment given by the Supplier or relevant Subcontractor or received from any persons listed on the Supplier's Provisional Supplier Personnel List regardless of when such notice takes effect.

- 1.6 On or around each anniversary of the Start Date and up to four times during the last 12 Months of the Term, the Buyer may make written requests to the

 - 1.6.3 the extent to which each employee qualifies for membership of any of the Statutory Schemes or any Broadly Comparable scheme set up pursuant to the provisions of any of the Annexes to Part D (Pensions) (as appropriate); and
 - 1.6.4 a description of the nature of the work undertaken by each employee by location.
- 1.7 The Supplier shall provide, and shall procure that each Subcontractor shall provide, all reasonable cooperation and assistance to the Buyer, any Replacement Supplier and/or any Replacement Subcontractor to ensure the smooth transfer of the Transferring Supplier Employees on the Service Transfer Date including providing sufficient information in advance of the Service Transfer Date to ensure that all necessary payroll arrangements can be made to enable the Transferring Supplier Employees to be paid as appropriate. Without prejudice to the generality of the foregoing, within 5 Working Days following the Service Transfer Date, the Supplier shall provide, and shall procure that each Subcontractor shall provide, to the Buyer or, at the direction of the Buyer, to any Replacement Supplier and/or any Replacement Subcontractor (as appropriate), in respect of each person on the Supplier's Final Supplier Personnel List who is a Transferring Supplier Employee:

2. Staff Transfer when the contract ends

- 2.1 The Buyer and the Supplier acknowledge that subsequent to the commencement of the provision of the Services, the identity of the provider of the Services (or any part of the Services) may change (whether as a result of termination or Partial Termination of the relevant Contract or otherwise) resulting in the Services being undertaken by a Replacement Supplier and/or a Replacement Subcontractor. Such change in the identity of the supplier of such services may constitute a Relevant Transfer to which the Employment Regulations and/or the Acquired Rights Directive will apply. The Buyer and the Supplier agree that, as a result of the operation of the Employment Regulations, where a Relevant Transfer occurs, the contracts of employment between the

2. BUYER'S RIGHTS

- 2.1 The Buyer and the Supplier recognise that, where specified in DPS Schedule 4 (DPS Management), the Buyer may give CCS the right to enforce the Buyer's rights under this Schedule.

3. SUPPLIER'S OBLIGATIONS

- 3.1 The Supplier must, throughout the Contract Period, identify new or potential improvements to the provision of the Deliverables with a view to reducing the Buyer's costs (including the Charges) and/or improving the quality and efficiency of the Deliverables and their supply to the Buyer.
- 3.2 The Supplier must adopt a policy of continuous improvement in relation to the Deliverables, which must include regular reviews with the Buyer of the Deliverables and the way it provides them, with a view to reducing the Buyer's costs (including the Charges) and/or improving the quality and efficiency of the Deliverables. The Supplier and the Buyer must provide each other with any information relevant to meeting this objective.
- 3.3 In addition to Paragraph 3.1, the Supplier shall produce at the start of each Contract Year a plan for improving the provision of Deliverables and/or reducing the Charges (without adversely affecting the performance of this Contract) during that Contract Year ("**Continuous Improvement Plan**") for the Buyer's Approval. The Continuous Improvement Plan must include, as a minimum, proposals:
- 3.3.1 identifying the emergence of relevant new and evolving technologies;
 - 3.3.2 changes in business processes of the Supplier or the Buyer and ways of working that would provide cost savings and/or enhanced benefits to the Buyer (such as methods of interaction, supply chain efficiencies, reduction in energy consumption and methods of sale);
 - 3.3.3 new or potential improvements to the provision of the Deliverables including the quality, responsiveness, procedures, benchmarking methods, likely performance mechanisms and customer support services in relation to the Deliverables; and
 - 3.3.4 measuring and reducing the sustainability impacts of the Supplier's operations and supply-chains relating to the Deliverables, and identifying opportunities to assist the Buyer in meeting their sustainability objectives.
- 3.4 The initial Continuous Improvement Plan for the first (1st) Contract Year shall be submitted by the Supplier to the Buyer for Approval within one hundred (100) Working Days of the first Order or six (6) Months following the Start Date, whichever is earlier.
- 3.5 The Buyer shall notify the Supplier of its Approval or rejection of the proposed Continuous Improvement Plan or any updates to it within twenty (20) Working Days of receipt. If it is rejected then the Supplier shall, within ten (10) Working Days of receipt of notice of rejection, submit a revised Continuous Improvement Plan reflecting the changes required. Once

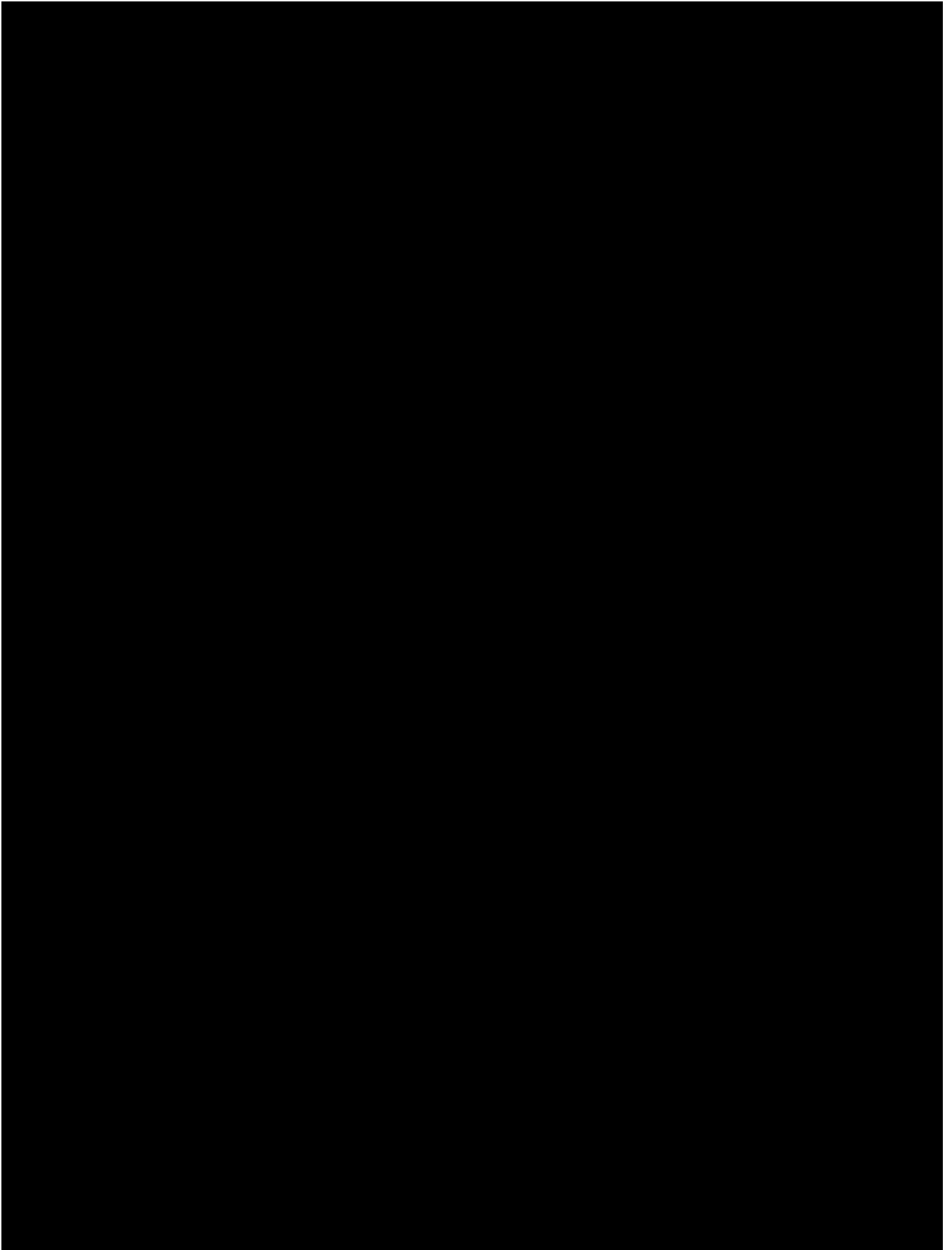

Approved, it becomes the Continuous Improvement Plan for the purposes of this Contract.

- 3.6 The Supplier must provide sufficient information with each suggested improvement to enable a decision on whether to implement it. The Supplier shall provide any further information as requested.
- 3.7 If the Buyer wishes to incorporate any improvement into this Contract, it must request a Variation in accordance with the Variation Procedure and the Supplier must implement such Variation at no additional cost to the Buyer or CCS.
- 3.8 Once the first Continuous Improvement Plan has been Approved in accordance with Paragraph 3.5:
 - 3.8.1 the Supplier shall use all reasonable endeavours to implement any agreed deliverables in accordance with the Continuous Improvement Plan; and
 - 3.8.2 the Parties agree to meet as soon as reasonably possible following the start of each quarter (or as otherwise agreed between the Parties) to review the Supplier's progress against the Continuous Improvement Plan.
- 3.9 The Supplier shall update the Continuous Improvement Plan as and when required but at least once every Contract Year (after the first (1st) Contract Year) in accordance with the procedure and timescales set out in Paragraph 3.3.
- 3.10 All costs relating to the compilation or updating of the Continuous Improvement Plan and the costs arising from any improvement made pursuant to it and the costs of implementing any improvement, shall have no effect on and are included in the Charges.
- 3.11 Should the Supplier's costs in providing the Deliverables to the Buyer be reduced as a result of any changes implemented, all of the cost savings shall be passed on to the Buyer by way of a consequential and immediate reduction in the Charges for the Deliverables.
- 3.12 At any time during the Contract Period of the Order Contract, the Supplier may make a proposal for gainshare. If the Buyer deems gainshare to be applicable then the Supplier shall update the Continuous Improvement Plan so as to include details of the way in which the proposal shall be implemented in accordance with an agreed gainshare ratio.

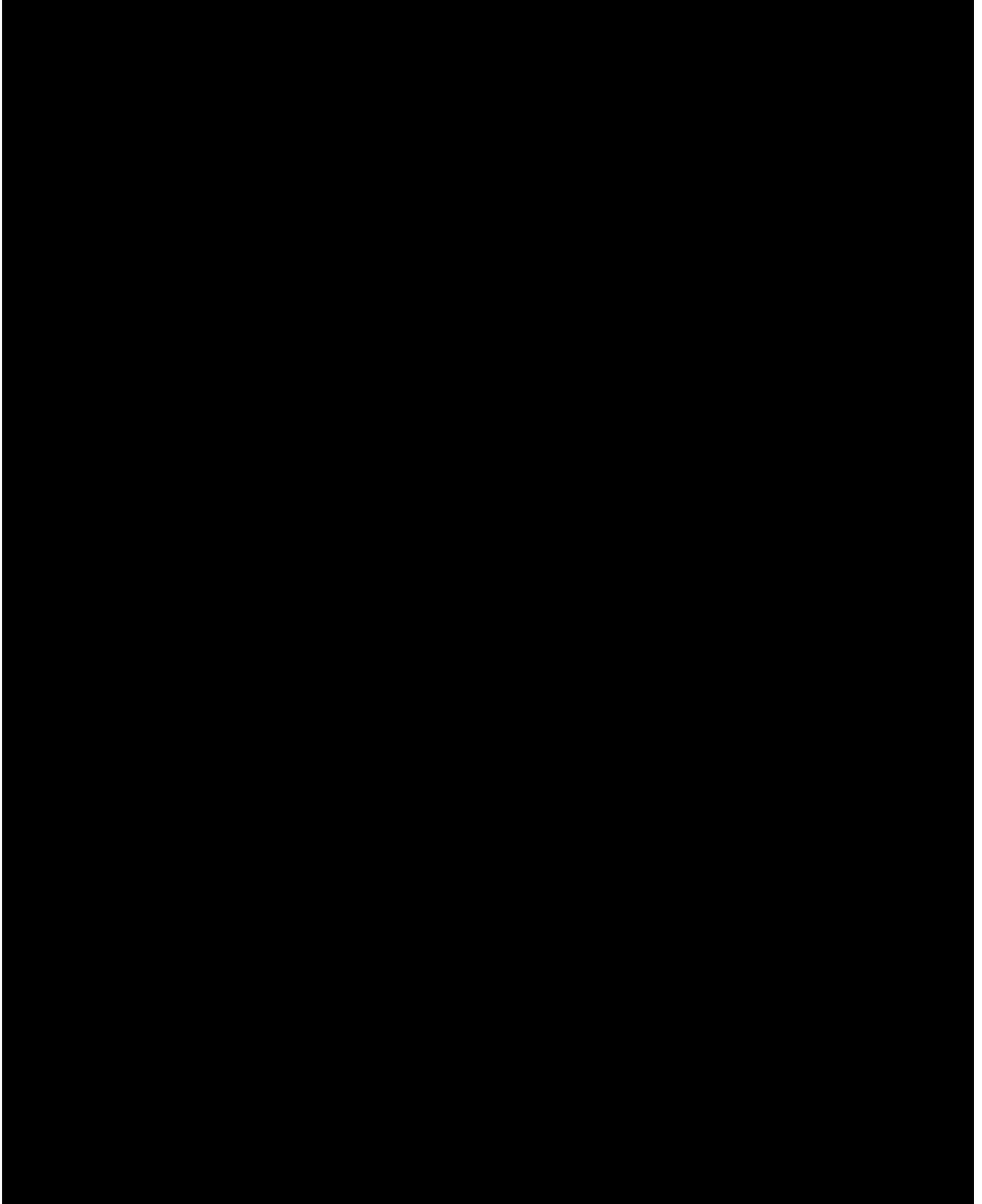

1. Background

What will this project do?

This project will conduct research with the future electricity networks workforce and other relevant stakeholders (e.g. major networks employers) to provide evidence of the barriers and motivations of those with the relevant skills to working in the sector, so that steps can be taken to overcome barriers and to leverage motivations. This will include mixed methods research (surveys, interview/focus groups) with students studying relevant subjects, qualitative research with a group of recent graduates in relevant subjects who have gone into networks and non-networks roles, and qualitative research with other stakeholders such as major networks employers and educational institutions.

This research will play a vital role in supporting long-term policy development for the networks sector and will also aim to provide insights in the nearer term to support existing government and industry commitments, including those announced in the Transmission Acceleration Action Plan.¹

Project Background and Context

The UK's carbon budget commitments critically rely on how quickly new renewables and associated electricity transmission infrastructure can be rolled out. The Net Zero Strategy committed the UK to deploy renewable technologies at significantly increased rates.² Since then, the British Energy Security Strategy (BESS) has gone further, setting out ambitions of up to 50GW of offshore wind by 2030, new community-backed onshore wind in England, and expectations of up to 70GW of solar capacity by 2035.³ Delivering on these ambitions will require an unprecedented scale-up of the transmission network, with four times as much new transmission network needed by 2030 as has been built since 1990. This will include building new overhead and underground lines, offshore transmission cables, substations, and landing infrastructure. Government has recently published the Transmission Acceleration Action Plan (TAAP), to aid this transition, which outlines measures to halve the end-to-end build time of electricity transmission network infrastructure from 14 to 7 years.⁴

It has been widely cited that the skills base and levels of resourcing needed for this network development is insufficient, including by the independent Electricity Networks Commissioner.⁵ Failure to secure the skilled workforce could lead to project delays, higher costs, and damage to the global competitiveness of the UK's economy. Part of the challenge is ensuring that there is a sufficient pipeline of skilled workers into network jobs and the associated supply chain to meet future needs. One aspect of addressing this challenge is ensuring that people are aware of and

inspired by the opportunities in the sector, for example through communications campaigns and ensuring there is easily accessible information on these roles available to the public.

Network jobs do not have a set definition. In this project the term refers to employment in an activity that contributes to the delivery of electricity network infrastructure. Examples of relevant network jobs can be found in Table 1. Networks jobs can be classified as green jobs. Green jobs are defined by the ONS as employment in an activity that contributes to protecting or restoring the environment, including those that mitigate or adapt to climate change⁶. This project will also explore attitudes towards green jobs more broadly.

Rationale

The Government published the Transmission Acceleration Action Plan (TAAP) responding to the Network Commissioner's recommendations. These recommendations included actions to raise awareness for the need for new electricity infrastructure and the job opportunities arising from this, as well as the actions required to attract, recruit, and retain the workforce needed to deliver the energy transition.⁷ These recommendations were accepted in TAAP, with Government setting out plans to create a joint entity alongside transmission networks companies, which will take forward the campaign recommendations.

To inform this and wider policy, it is essential to understand the motivations and barriers that currently exist to these roles. This evidence is very limited in relation to network jobs specifically. Thus, there is a need for evidence specific to network jobs to allow for sector specific challenges to be identified and addressed. However, there is some evidence on the potential drivers and barriers to green jobs more broadly.^{8 9}

Potential barriers include:

- A lack of knowledge or awareness of 'green jobs'
- Jobs being seen as physically challenging and dangerous
- A lack of diversity in the energy sector
- International competition for labour
- Difficult skill sets to obtain
- Geographic location of jobs

Potential drivers include:

- Higher than average salaries
- Job security

- Working in a career that contributes to combatting climate change

Through an improved understanding of the barriers and drivers, Government will be able to tailor policies and other interventions to address the needs of the sector, as well as improving the ability to anticipate future labour market trends – which can inform decisions related to workforce planning, education, and training programs.

Project focus: Early Careers

Whilst the future networks workforce will include experienced workers, this project will focus on early careers. More specifically, those working towards relevant degrees and qualifications, and those who have recently completed studying. The rationale for this includes:

1. Future proofing the workforce: The energy sector needs to recruit for 400,000 jobs between 2020 and 2050 for the UK to reach net zero¹⁰, therefore preparing and encouraging young people to work in the sector is essential.
2. Bridging the gap between climate concern and uptake of green jobs: Evidence suggests that young people have high motivation to work in environmentally friendly companies and sectors.¹¹ However, they do not always have the knowledge of specific roles to allow them to do this. Therefore, research is needed to establish what information government can provide to bridge this gap.
3. Diversity and Inclusion: A lack of diversity is a key barrier to network jobs. A report by the ECITB found that the engineering workforce is predominantly male (92% male) and white (91% white).¹² Therefore, it is important to speak to young people and employers to understand their views and experiences on this, and if any actions can be taken to help diversify the future workforce and increase uptake of opportunities in the sector.

2. Aims and Objectives of the Project

This project will engage with those studying and those who have recently completed studying STEM degrees (e.g. engineering) and vocational courses via non-graduate routes (colleges or apprenticeships) which provide the prerequisites to taking up key roles in electricity networks. The aim is to understand their motivations, drivers, and barriers to working in electricity network jobs. For ease, we refer to this study population as “networks relevant students” (NRSs). The project will also include research with other stakeholders such as major networks employers and educational institutions to gain their perspectives on training, recruiting, and retaining NRSs.

This project has the following objectives:

- To develop a typology for NRSs and establish existing statistics relating to them.
- To understand what career paths NRSs are considering.
- To understand the drivers / motivations behind the career paths considered by NRSs
- To explore NRSs’ awareness of the jobs or careers available to them in networks and other green sectors.
- To explore NRSs’ perceptions towards working in networks and other green sectors.
- To understand network employers’ and other stakeholders’ views and experiences of training, recruiting and retaining NRSs

- To understand what additional information (e.g. comms campaigns and jobs information hubs) on network jobs could help increase the number of NRSs considering careers in the sector.
- To understand what other interventions could help increase the number of NRSs considering careers in the networks sector.
- To understand to what extent the demographics and backgrounds of NRSs affect their likelihood of considering networks careers and how the networks sector can attract a diverse workforce.

Research questions

- 1. How should NRSs be defined (typology)?**
 - a. What courses are within scope of NRSs?
 - b. What are network employers' and other stakeholders' views on defining NRSs?
 - c. How can NRSs be summarised from existing statistics?
 - d. What data is not currently available on NRSs?
- 2. What jobs and sectors are NRSs considering working in on completion of their studies, and why?**
 - a. What proportion are considering networks jobs?
 - b. Why are networks jobs considered or not considered?
 - c. What proportion are considering other green jobs?
 - d. To what extent do NRSs feel that their courses have provided them with relevant skills for networks or green jobs?
- 3. What are the drivers / motivations behind the career paths considered by NRSs?**
 - a. What are the main motivations or deterrents NRSs find when looking at jobs?
 - b. What would motivate or deter NRSs from working in networks jobs?
 - c. What would motivate or deter NRSs from working in green jobs?
 - d. How important is the notion of working in "green jobs" or "tackling climate change" to career decisions?
- 4. What are NRSs' levels of awareness and perceptions of networks and green jobs?**
 - a. How aware are NRSs of the career options available to them in the networks sector?
 - b. What are perceptions of pay, working conditions, progression, and other features?
 - c. How do views vary between networks jobs, green jobs, and opportunities in other sectors?
- 5. What are employers' and other stakeholders' views and experiences of training, recruiting and retaining NRSs?**

 - c. Where do NRSs currently find out about and apply for jobs?
 - d. What information does a 'good' advert contain?
 - e. What information should be provided in information-based interventions?
 - f. How can educational institutions, careers services, and other messengers, help encourage consideration of networks jobs?
 - g. What other interventions could help improve consideration of networks jobs?
- 7. How do demographics and backgrounds affect views and awareness towards networks jobs and how can the sector attract a diverse future workforce?**
 - a. What are the main demographics and backgrounds of NRSs who said they would like to work in electricity networks?
 - b. How does this differ to other sectors NRSs are considering?
 - c. How important is the perceived demographic of a workforce an important factor to determining where participants choose to work?
 - d. Do participants have any views on how the networks sector can attract a diverse future workforce?

3. Suggested Methodology

In order to comprehensively answer the research questions and achieve the objectives of this project, DESNZ requires a mixed methods approach. The project will be delivered in multiple phases. The first phase will involve desk research and industry engagement to develop a typology of "networks relevant students" (NRSs). The second phase will include primary data collection with NRSs, recent graduates who have studied networks relevant subjects but have gone into networks and non-networks jobs, and other stakeholders such as industry and educational institutions. The methodology and requirements are discussed in further detail below.

Where appropriate and feasible DESNZ can utilise existing relationships within the department to help contractors engage with the stakeholders needed to deliver the project (e.g. industry and other government departments). Where appropriate and feasible DESNZ can also help facilitate new relationships needed to deliver the project (e.g. co-signing invite letters, sending emails, joining calls). However, bidders should not rely on DESNZ entirely and should outline how they will engage with these stakeholders.

Phase 1 – Developing a typology of "networks relevant students" (Desk research and industry engagement)

The primary study population for this research are those studying degrees at UK universities, and those studying or training towards relevant vocational skills via non-graduate routes (colleges or apprenticeships in the UK) in subjects which will provide the prerequisites to taking up key roles in electricity networks. This group is referred to as Networks Relevant Students (NRSs) for ease in this

proposal. NRSs in all years of study are eligible to take part in this study (undergraduate and master's for those studying at universities).

We have developed an initial list of the types of courses that NRSs may study in Table 2a and Table 2b. However, we would like to develop a thorough understanding of exactly what courses should be within scope to provide us with a comprehensive typology/definition for NRSs. We expect that engagement with industry (e.g. key networks employers) for example through a roundtable or other approaches will be essential to ensure our typology reflects their hiring practices. We also anticipate that desk research will be required. Views from DESNZ stakeholders should also be gathered and the final typology will be signed off by the DESNZ project team. Bidders should outline their approach to this in detail, including how they will work with DESNZ and other stakeholders.

Once the typology for NRSs has been finalised, we require key existing statistics regarding NRSs to be compiled. Depending upon the availability of data this could include data relating to the number of NRSs studying in the UK, the number of NRSs across subjects, how NRS numbers change overtime, the number of NRSs across institutions, and demographic data regarding NRSs (e.g. age, gender, socioeconomic background, ethnicity). We understand that there may not be publicly available information on all of these statistics, however this exercise will need to determine what information is available and what gaps exist. The DESNZ project team expects to be able to share some data with the contractors as a starting point and expects this to be a relatively light-touch exercise. Key sources will include:

Findings from this phase will be essential to developing a robust sampling approach for subsequent primary data collection and can support development of data collection tools by highlighting evidence gaps. Results may also identify potential changes/ refinements to the phase 2 strategy

that are required. For example, if this phase identifies that the networks apprentice population pool employers recruit from is too small for a survey, we would expect that the qualitative data collection with this group is expanded significantly. Another example may be that this phase identifies that other groups could also be sampled in the quantitative or qualitative research, such as students at different types of institutions or younger age groups than we've included in the initial NRS definition. In this case, changes would be needed to be agreed with DESNZ and delivered within the existing budget.

Bidders should outline their approach to this phase of the project, including any key data sets they have identified and recommended outputs within the allocated budget for the project (we expect a slide pack as a minimum).

Phase 2 – Primary data collection

Informed by findings from phase 1, the primary research phase of this project requires the following:

- Mixed methods research with NRSs currently studying/ training: representative quantitative survey(s) with NRSs in both university and apprenticeship routes; qualitative research with NRSs which may include interviews as well as group methods such as focus groups and workshops with purposively sampled participants.
- Qualitative research with NRS who have graduated and entered the workforce (both in networks and other sectors)
- Qualitative research with other stakeholders such as employers, trade-bodies and educational/ training institutions (note that it may be possible to collect some views from industry via phase 1).

We are open to bidders' suggestions about how primary data collection activities are sequenced. To feed into internal policy development milestones, it is essential that contractors can deliver interim findings by October 2024 providing initial insights into our research questions. We do not expect all data collection to be completed by this point, but we expect some meaningful results from initial data collection with NRSs to be available. Bidders should bear this in mind when choosing how to sequence data collection. Bidders should provide a clear rationale for their sequencing decisions, including how their approach will build on findings from prior phases of data collection and best achieve our objectives. Further details on requirements are provided below.

General Quantitative and Qualitative Research Requirements

- Bidders should provide a detailed outline of their overall approach and why it is most suitable to answer the research questions.
- The research questions and sub-questions provide guidance on the areas which respective data collection activities should focus on. Contractors will be expected to work closely with DESNZ to develop data collection tools and bidders should outline how they plan to do this.
- Bidders should outline how they will develop their sampling frame and recruit participants.
- Bidders should set out details of their suggested method(s) of analysis for both quantitative and qualitative data and explain how this will be used to answer the research questions. At a minimum, cross-tabulations and significance testing are required for quantitative survey data. We are open to suggestions for how more sophisticated techniques such as regression, ANOVA or factor analysis could be applied.
- Bidders should outline how analysis will be quality assured, how potential sources of biases will be mitigated and how evidence will be presented to show that the quality assurance has been executed.
- Bidders should say whether they expect incentives to be required. If incentives are proposed, the suitable amount and type of incentive should be outlined. Bidders should

ensure incentives are only used if necessary and in line with GSR Ethical Guidance¹³. Any incentives must be costed within the total budget available for this project.

- Due to the population of this research being with predominantly young people, we expect a low response rate. Bidders should outline their approach to mitigating this and achieving the required sample sizes.
 - Bidders should outline any additional considerations they will take to undertake research with these groups (e.g. to maintain their safety, ethical considerations, practical considerations).
- When reporting findings, participants should be anonymised. Bidders should outline their approach to this.

Quantitative Research Requirements

- We require a high-quality representative survey to develop the quantitative evidence base regarding NRSs' attitudes towards working on electricity infrastructure. This should cover NRSs in university routes as well as non-graduate routes (apprenticeships, etc.). We expect that this may require two different surveys to capture both populations, but we are open to alternative approaches.
- We expect that an online approach is most likely, but we are open to alternatives and mixed mode approaches.
- The survey should collect data on NRSs' views on awareness, motivations, drivers, and barriers to working in electricity network and green jobs. It should also explore participants' views on how to increase the number of NRSs considering careers in the network sector.
- Bidders should outline the minimum sample sizes they expect to achieve for both university route NRSs and non-graduate route NRSs. Bidders may also suggest a maximum sample size that is deliverable within the stated budget. Sample sizes must be sufficient to draw sound conclusions about the study population, to enable meaningful analysis of sub-groups (e.g. by university/non-university NRS, gender, ethnicity and by key courses/ groups of courses) and to undertake any statistical analysis proposed. We appreciate that final calculations may not be feasible prior to completion of phase 1, however initial estimates should be provided in bids.
- DESNZ expect that the survey would take maximum 15 minutes for participants to complete.
- Relevant data on demographics should be collected in the survey which will support analysis on research questions relating to diversity. We expect demographics to include gender, age, ethnicity, and socioeconomic background. We are open to suggestions of additional demographics to include. Other background data, including but not limited to course being studied, and year of study are also likely required to provide context, support analysis and weighting.
- It is essential that the data collected is representative of NRSs in the UK (demographics and by course characteristics). Bidders should outline how they will achieve this through their sampling approach and weighting. It is expected that existing statistics on NRSs compiled in phase 1 will need to be used to assess the representativeness of data (e.g. to develop quotas and weighting strategies).
- A suggestion of the type of sampling that could be used is listed below – this is just a suggestion, and we are open to alternatives. Bidders should outline their approach in detail.

- Quota sample: NRSs are recruited through non-probability methods (e.g. adverts to take part online, existing panel members, advertised through NUS, student groups, unis etc.) and quotas applied to key variables. Bidders should not assume that DESNZ or other departments can facilitate relationships with these organisations and are expected to set out how they will engage with these gatekeepers.
- The survey must be subject to cognitive testing. Bidders should outline their approach to this.

Qualitative Research Requirements

The qualitative element of this project requires research with the groups outlined below:

- NRSs currently studying or training.
- NRSs who have graduated and are in the workforce (both in network jobs and those who are in other fields).
- Other stakeholders such as educational institutions, careers advice services, and major networks employers (e.g. transmission owners and distribution owners)

We have outlined what we see as the purpose for data collection with each group, as well as indicative examples of data collection approaches in order to provide bidders with a clear understanding of what our expectations are from the qualitative research. The example approaches discussed below are based on initial cost estimates and our view of how budget could be prioritised across the different groups. Bidders should outline their qualitative approach in detail, which they can demonstrate achieves the research objectives to the highest standard within the available budget.

Group 1: NRSs currently studying or training – both from university and non-graduate routes**Purpose of qualitative research with this group**

- To understand in depth the attitudes, barriers, and drivers to working in networks jobs experienced by NRSs.
- To collaboratively develop ideas with NRSs for campaigns and other measures to promote the uptake of networks jobs and green jobs, for example through focus groups or workshops.
- To engage with specific groups that are currently under-represented in network jobs.

Data collection example

- In total at least five focus groups or workshops (more if appropriate and feasible). Some of the groups could be composed of participants representative of the population, and a number of groups could be composed only of those currently underrepresented within the networks sector (e.g. females and ethnic minorities); these demographic specific groups would be intended to create an open environment to discuss views and experiences specific to these groups.
- **Examples** of suggested focus group compositions are listed below.
 - At least 1 focus group with university NRSs (range of demographics)
 - At least 1 focus group with non-graduate vocational NRSs (range of demographics)
 - At least 1 focus group for women only
 - At least 1 focus group for those from ethnic minority backgrounds

Group 2: NRS who have graduated and entered the workforce (both in networks and other sectors)**Purpose of qualitative research with this group**

- To understand the views and experiences of NRSs who have entered the workforce, both in network jobs and other sectors. This will provide an important perspective of people who have made these career decisions recently and provide important learnings for the campaign and wider policy.¹⁴

Data collection example

- This could include around 10 interviews split between NRSs who have entered the networks workforce and NRSs who have entered the workforce in non-networks roles.
- Alternatively focus groups could be used (e.g. at least one focus group with NRSs in networks roles and at least one focus group with NRSs in non-networks roles).

Group 3: Other stakeholders

Examples of the types of stakeholders that we expect we could engage with are major network employers (e.g. Transmission Network Operators, members of the supply chain), trade-bodies, educational institutions (universities, technical colleges), training providers, and career services. Bidders should outline the stakeholders that they think are the most important to engage with, and how to best engage with them (note that it may be possible to collect some views from industry/ employers via phase 1).

Purpose of qualitative research with other stakeholders

- To gain key stakeholders' perspectives of the challenges they face training, recruiting and retaining NRSs, and their views on steps which could be taken to help encourage NRSs into networks jobs (e.g. overcoming barriers and raising awareness).

Data collection Example

- Around 10 interviews in total across the key stakeholders' bidders recommend engagement with.
- At least 1 workshop consisting of relevant staff from organisations such as Transmission Owners, National Grid Electricity System Operator, Distribution Network Operators, and industry bodies to explore the research questions from an industry lens

Overall requirements across the qualitative research

- A purposive sampling approach is required. Bidders should provide an outline of the potential composition of their sampling frame for each of the three groups, including the rationale for this approach. This should be broken down by potential variables of interest, which could include demographics and/ or attitudes. This should also be broken down by the data collection activities. For example, if focus groups and interviews are recommended, bidders should outline the sampling frame for both data collection activities. The sampling frames will be finalised with DESNZ and should be informed by any preceding data collection undertaken (e.g. if the survey phase comes first in the research design).
- For all groups, bidders should outline who they plan to sample and how they plan to recruit participants. The rationale for these decisions should also be provided.
- Bidders should outline and provide rationale for the number of data collection activities they are proposing (i.e. number of interviews, focus groups, workshops), the modes of data collection, and duration of data collection activities.

- For group activities, bidders should also outline details including: the number of participants per session, the composition of groups and consideration of how they will ensure diverse viewpoints are represented.
- Bidders should outline what expertise will be utilised to deliver these sessions as well as interviews, including how they will be facilitated and moderated.
- Bidders should expect to facilitate the DESNZ project team to observe some data collection activities if requested.

4. Deliverables**Phase 1: (August 2024)**

- Slides and presentation summarising findings from desk research and industry engagement.

Phase 2:**Interim output (October 2024)**

- Interim findings slides and presentation outlining top-level findings from any data collection undertaken in time to feed into an output which should be presented and signed-off by DESNZ in October 2024.
- The Phase 2 interim output is needed to feed into an internal DESNZ milestone

- Raw survey data to enable secondary analysis.
- Publishable survey data tables

Qualitative Research

- Data collection tools (e.g. interview topic guides, group activities, workshop slides etc.)

- Final presentation of results: presentation of slides outlining findings from the final report including focus on recommendations

Reporting and presentations

Bidders should outline their proposed approach to reporting and disseminating findings. In addition to the formal presentations listed above (after phase 1, interim phase 2, final presentation), we'd expect a briefing on emerging findings following completion of each wave of data collection. Interim outputs will also require DESNZ sign-off.

Contractors will also be expected to provide a presentation at the close of the project on the final report. Attendees are likely to include DESNZ stakeholders and other stakeholders involved in the project. Presentations are likely to take place online via MS Teams

We encourage the development of visually engaging elements within outputs (e.g. slides and reports), such as utilising diagrams and infographics where possible, with the view of increasing engagement with findings and the ease of dissemination.

It is important to note that some of the fieldwork for this project may run during summer and university holidays. We understand this could affect recruitment but do not assume engagement with students would not be possible during this time. Bidders should factor this into their recruitment strategy, timelines and fieldwork phasing. There is also the possibility that a General Election will take place during the project. Therefore, bidders need to be flexible to accommodate for pre-election periods where fieldwork may need to be postponed. DESNZ will be pragmatic and flexible if delays occur where steps have been taken to mitigate risks.

Quality assurance

Bidders must set out their approach to quality assurance (QA) in their response to this ITT with a QA plan. Sign-off for quality assurance and compliance must be conducted by someone sufficiently senior within the contractor organisation to be able to take responsibility for the work submitted. Where a consortium or sub-contractors are in place, DESNZ expect that they are included in relevant meetings, workshops, and review points to ensure their full engagement in the project. All contractors and sub-contractors are responsible for the delivery of outputs to the appropriate time and quality. It is expected that the lead contractor takes an active role in oversight of all workstreams and bears the overall responsibility for the delivery of the evaluation activities and outputs.

It is important that DESNZ are kept informed of emerging findings and project progress.

Bidders should assume that DESNZ take an active role in review and quality assurance of research materials, analysis, and outputs, beyond external peer review. It should be expected that research materials and outputs go through at least three iterations (i.e., two rounds of comments from DESNZ). Additional amendments may be required for published outputs.

We expect the winning bidder to be available to attend an inception meeting as soon as possible after the contract has been signed, ideally within the same week the contract is signed.

Ethics

All applicants will need to identify and propose arrangements for initial scrutiny and on-going monitoring of ethical issues. The appropriate handling of ethical issues is part of the tender assessment exercise and proposals will be evaluated on this as part of the 'consideration of challenges' criterion. Given that this research is being conducted with young people, bidders should discuss any particular ethical challenges associated with this.

We expect contractors to adhere to the following Government Social Research (GSR) Principles:

1. Sound application and conduct of social research methods and appropriate dissemination and utilisation of findings
2. Participation based on valid consent
3. Enabling participation
4. Avoidance of personal harm
5. Non-disclosure of identity and personal information

Data security

1. Definitions used in the contract

Interpret this Contract using Joint Schedule 1 (Definitions).

2. How the contract works

- 2.1. The Supplier is eligible for the award of Order Contracts during the DPS Contract Period.
- 2.2. CCS does not guarantee the Supplier any exclusivity, quantity or value of work under the DPS Contract.
- 2.3. CCS has paid one penny to the Supplier legally to form the DPS Contract. The Supplier acknowledges this payment.
- 2.4. If the Buyer decides to buy Deliverables under the DPS Contract it must use DPS Schedule 7 (Order Procedure) and must state its requirements using DPS Schedule 6 (Order Form Template and Order Schedules). If allowed by the Regulations, the Buyer can:
 - (a) make changes to DPS Schedule 6 (Order Form Template and Order Schedules);
 - (b) create new Order Schedules;
 - (c) exclude optional template Order Schedules; and/or

10. Ending the contract or any subcontract

10.2. Ending the contract without a reason

10.3.3. Where the Rectification Plan or revised Rectification Plan is rejected, the Relevant Authority:

- (a) must give reasonable grounds for its decision; and

10.3.4. If the Relevant Authority rejects any Rectification Plan, including any revised Rectification Plan, the Relevant Authority does not have to request a revised Rectification Plan before exercising its right to terminate its Contract under Clause 10.4.3(a).

10.4. When CCS or the buyer can end a contract

10.4.1. If any of the following events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:

- (a) there is a Supplier Insolvency Event;
- (b) there is a Default that is not corrected in line with an accepted Rectification Plan;
- (c) the Supplier does not provide a Rectification Plan within 10 days of the request;
- (d) there is any material Default of the Contract;
- (e) there is any material Default of any Joint Controller Agreement relating to any Contract;
- (f) there is a Default of Clauses 2.10, 9, 14, 15, 27, 32 or DPS Schedule 9 (Cyber Essentials) (where applicable) relating to any Contract;
- (g) there is a consistent repeated failure to meet the Performance Indicators in DPS Schedule 4 (DPS Management);
- (h) there is a Change of Control of the Supplier which is not pre-approved by the Relevant Authority in writing;
- (i) if the Relevant Authority discovers that the Supplier was in one of the situations in 57 (1) or 57(2) of the Regulations at the time the Contract was awarded; or
- (j) the Supplier or its Affiliates embarrass or bring CCS or the Buyer into disrepute or diminish the public trust in them.

10.4.2. CCS may terminate the DPS Contract if a Buyer terminates an Order Contract for any of the reasons listed in Clause 10.4.1.

10.4.3. If any of the following non-fault based events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:

- (a) the Relevant Authority rejects a Rectification Plan;
- (b) there is a Variation which cannot be agreed using Clause 24 (Changing the contract) or resolved using Clause 34 (Resolving disputes);
- (c) if there is a declaration of ineffectiveness in respect of any Variation; or
- (d) any of the events in 73 (1) (a) or (c) of the Regulations happen.

10.5. When the supplier can end the contract

The Supplier can issue a Reminder Notice if the Buyer does not pay an undisputed invoice on time. The Supplier can terminate an Order Contract if the Buyer fails to pay an undisputed invoiced sum due and worth over 10% of the annual Contract Value within 30 days of the date of the Reminder Notice.

10.6. What happens if the contract ends

- 10.6.1. Where a Party terminates a Contract under any of Clauses 10.2.1, 10.2.2, 10.4.1, 10.4.2, 10.4.3, 10.5 or 20.2 or a Contract expires all of the following apply:
 - (a) The Buyer's payment obligations under the terminated Contract stop immediately.
 - (b) Accumulated rights of the Parties are not affected.
 - (c) The Supplier must promptly repay to the Buyer any and all Charges the Buyer has paid in advance in respect of Deliverables not provided by the Supplier as at the End Date.
 - (d) The Supplier must promptly delete or return the Government Data except where required to retain copies by Law.
 - (e) The Supplier must promptly return any of CCS or the Buyer's property provided under the terminated Contract.
 - (f) The Supplier must, at no cost to CCS or the Buyer, co-operate fully in the handover and reprocurement (including to a Replacement Supplier).
- 10.6.2. In addition to the consequences of termination listed in Clause 10.6.1, where the Relevant Authority terminates a Contract under Clause 10.4.1 the Supplier is also responsible for the Relevant Authority's reasonable costs of procuring Replacement Deliverables for the rest of the Contract Period.
- 10.6.3. In addition to the consequences of termination listed in Clause 10.6.1, if either the Relevant Authority terminates a Contract under Clause 10.2.1 or 10.2.2 or a Supplier terminates an Order Contract under Clause 10.5:
 - (a) the Buyer must promptly pay all outstanding Charges incurred to the Supplier; and
 - (b) the Buyer must pay the Supplier reasonable committed and unavoidable Losses as long as the Supplier provides a fully itemised and costed schedule with evidence - the maximum value of this payment is limited to the total sum payable to the Supplier if the Contract had not been terminated.
- 10.6.4. In addition to the consequences of termination listed in Clause 10.6.1, where a Party terminates under Clause 20.2 each Party must cover its own Losses.

- 10.6.5. The following Clauses survive the termination or expiry of each Contract:
3.2.10, 4.2, 6, 7.5, 9, 11, 12.2, 14, 15, 16, 17, 18, 31.3, 34, 35 and any Clauses and Schedules which are expressly or by implication intended to continue.

10.7. Partially ending and suspending the contract

- 10.7.1. Where CCS has the right to terminate the DPS Contract it can suspend the Supplier's ability to accept Orders (for any period) and the Supplier cannot enter into any new Order Contracts during this period. If this happens, the Supplier must still meet its obligations under any existing Order Contracts that have already been signed.
- 10.7.2. Where CCS has the right to terminate a DPS Contract it is entitled to terminate all or part of it.
- 10.7.3. Where the Buyer has the right to terminate an Order Contract it can terminate or suspend (for any period), all or part of it. If the Buyer suspends a Contract it can provide the Deliverables itself or buy them from a third party.
- 10.7.4. The Relevant Authority can only partially terminate or suspend a Contract if the remaining parts of that Contract can still be used to effectively deliver the intended purpose.
- 10.7.5. The Parties must agree any necessary Variation required by Clause 10.7 using the Variation Procedure, but the Supplier may not either:
(a) reject the Variation; or
(b) increase the Charges, except where the right to partial termination is under Clause 10.2.
- 10.7.6. The Buyer can still use other rights available, or subsequently available to it if it acts on its rights under Clause 10.7.

10.8. When subcontracts can be ended

At the Buyer's request, the Supplier must terminate any Subcontracts in any of the following events:

- (a) there is a Change of Control of a Subcontractor which is not pre-approved by the Relevant Authority in writing;
- (b) the acts or omissions of the Subcontractor have caused or materially contributed to a right of termination under Clause 10.4; or
- (c) a Subcontractor or its Affiliates embarrasses or brings into disrepute or diminishes the public trust in the Relevant Authority.

11. How much you can be held responsible for

- 11.1. Each Party's total aggregate liability in each Contract Year under this DPS Contract (whether in tort, contract or otherwise) is no more than £1,000,000.

- 11.2. Each Party's total aggregate liability in each Contract Year under each Order Contract (whether in tort, contract or otherwise) is no more than one hundred and twenty five percent (125%) of the Estimated Yearly Charges unless specified in the Order Form.
- 11.3. No Party is liable to the other for:
- (a) any indirect Losses; or
 - (b) Loss of profits, turnover, savings, business opportunities or damage to goodwill (in each case whether direct or indirect).
- 11.4. In spite of Clause 11.1 and 11.2, neither Party limits or excludes any of the following:
- (a) its liability for death or personal injury caused by its negligence, or that of its employees, agents or Subcontractors;
 - (b) its liability for bribery or fraud or fraudulent misrepresentation by it or its employees;
 - (c) any liability that cannot be excluded or limited by Law;
 - (d) its obligation to pay the required Management Levy or Default Management Levy.
- 11.5. In spite of Clauses 11.1 and 11.2, the Supplier does not limit or exclude its liability for any indemnity given under Clauses 7.5, 8.3(b), 9.5, 31.3 or Order Schedule 2 (Staff Transfer) of a Contract.
- 11.6. In spite of Clauses 11.1, 11.2 but subject to Clauses 11.3 and 11.4, the Supplier's aggregate liability in each and any Contract Year under each Contract under Clause 14.8 shall in no event exceed the Data Protection Liability Cap.
- 11.7. Each Party must use all reasonable endeavours to mitigate any Loss or damage which it suffers under or in connection with each Contract, including any indemnities.
- 11.8. When calculating the Supplier's liability under Clause 11.1 or 11.2 the following items will not be taken into consideration:
- (a) Deductions; and
 - (b) any items specified in Clauses 11.5 or 11.6.
- 11.9. If more than one Supplier is party to a Contract, each Supplier Party is jointly and severally liable for their obligations under that Contract.

12. Obeying the law

- 12.1. The Supplier must use reasonable endeavours to comply with the provisions of Joint Schedule 5 (Corporate Social Responsibility).
- 12.2. To the extent that it arises as a result of a Default by the Supplier, the Supplier indemnifies the Relevant Authority against any fine or penalty incurred by the Relevant Authority pursuant to Law and any costs incurred by the Relevant Authority in defending any proceedings which result in such fine or penalty.

- 12.3. The Supplier must appoint a Compliance Officer who must be responsible for ensuring that the Supplier complies with Law, Clause 12.1 and Clauses 27 to 32.

13. Insurance

The Supplier must, at its own cost, obtain and maintain the Required Insurances in Joint Schedule 3 (Insurance Requirements) and any Additional Insurances in the Order Form.

14. Data protection

- 14.1. The Supplier must process Personal Data and ensure that Supplier Staff process Personal Data only in accordance with Joint Schedule 11 (Processing Data).
- 14.2. The Supplier must not remove any ownership or security notices in or relating to the Government Data.
- 14.3. The Supplier must make accessible back-ups of all Government Data, stored in an agreed off-site location and send the Buyer copies every 6 Months.
- 14.4. The Supplier must ensure that any Supplier system holding any Government Data, including back-up data, is a secure system that complies with the Security Policy and any applicable Security Management Plan.
- 14.5. If at any time the Supplier suspects or has reason to believe that the Government Data provided under a Contract is corrupted, lost or sufficiently degraded, then the Supplier must notify the Relevant Authority and immediately suggest remedial action.
- 14.6. If the Government Data is corrupted, lost or sufficiently degraded so as to be unusable the Relevant Authority may either or both:
- (a) tell the Supplier to restore or get restored Government Data as soon as practical but no later than 5 Working Days from the date that the Relevant Authority receives notice, or the Supplier finds out about the issue, whichever is earlier; and/or
 - (b) restore the Government Data itself or using a third party.
- 14.7. The Supplier must pay each Party's reasonable costs of complying with Clause 14.6 unless CCS or the Buyer is at fault.
- 14.8. The Supplier:
- (a) must provide the Relevant Authority with all Government Data in an agreed open format within 10 Working Days of a written request;
 - (b) must have documented processes to guarantee prompt availability of Government Data if the Supplier stops trading;
 - (c) must securely destroy all Storage Media that has held Government Data at the end of life of that media using Good Industry Practice;

- (d) securely erase all Government Data and any copies it holds when asked to do so by CCS or the Buyer unless required by Law to retain it; and
- (e) indemnifies CCS and each Buyer against any and all Losses incurred if the Supplier breaches Clause 14 and any Data Protection Legislation.

15. What you must keep confidential

15.1. Each Party must:

- (a) keep all Confidential Information it receives confidential and secure;
- (b) except as expressly set out in the Contract at Clauses 15.2 to 15.4 or elsewhere in the Contract, not disclose, use or exploit the Disclosing Party's Confidential Information without the Disclosing Party's prior written consent; and
- (c) immediately notify the Disclosing Party if it suspects unauthorised access, copying, use or disclosure of the Confidential Information.

15.2. In spite of Clause 15.1, a Party may disclose Confidential Information which it receives from the Disclosing Party in any of the following instances:

- (a) where disclosure is required by applicable Law or by a court with the relevant jurisdiction if, to the extent not prohibited by Law, the Recipient Party notifies the Disclosing Party of the full circumstances, the affected Confidential Information and extent of the disclosure;
- (b) if the Recipient Party already had the information without obligation of confidentiality before it was disclosed by the Disclosing Party;
- (c) if the information was given to it by a third party without obligation of confidentiality;
- (d) if the information was in the public domain at the time of the disclosure;
- (e) if the information was independently developed without access to the Disclosing Party's
- (f) Confidential Information;
- (g) on a confidential basis, to its auditors;
- (h) on a confidential basis, to its professional advisers on a need-to-know basis; or
- (i) to the Serious Fraud Office where the Recipient Party has reasonable grounds to believe that the Disclosing Party is involved in activity that may be a criminal offence under the Bribery Act 2010.

15.3. In spite of Clause 15.1, the Supplier may disclose Confidential Information on a confidential basis to Supplier Staff on a need-to-know basis to allow the Supplier to meet its obligations under the Contract. The Supplier Staff must enter into a direct confidentiality agreement with the Relevant Authority at its request.

15.4. In spite of Clause 15.1, CCS or the Buyer may disclose Confidential Information in any of the following cases:

- (a) on a confidential basis to the employees, agents, consultants and contractors of CCS or the Buyer;
- (b) on a confidential basis to any other Central Government Body, any successor body to a Central Government Body or any company that CCS

or the Buyer transfers or proposes to transfer all or any part of its business to;

- (c) if CCS or the Buyer (acting reasonably) considers disclosure necessary or appropriate to carry out its public functions;
- (d) where requested by Parliament; or (e) under Clauses 4.7 and 16.

15.5. For the purposes of Clauses 15.2 to 15.4 references to disclosure on a confidential basis means disclosure under a confidentiality agreement or arrangement including terms as strict as those required in Clause 15.

15.6. Transparency Information is not Confidential Information.

15.7. The Supplier must not make any press announcement or publicise the Contracts or any part of them in any way, without the prior written consent of the Relevant Authority and must take all reasonable steps to ensure that Supplier Staff do not either.

16. When you can share information

16.1. The Supplier must tell the Relevant Authority within 48 hours if it receives a Request For Information.

16.2. Within five (5) Working Days of the Buyer's request the Supplier must give CCS and each Buyer full cooperation and information needed so the Buyer can:

- (a) publish the Transparency Information;
- (b) comply with any Freedom of Information Act (FOIA) request; and/or (c) comply with any Environmental Information Regulations (EIR) request.

16.3. The Relevant Authority may talk to the Supplier to help it decide whether to publish information under Clause 16. However, the extent, content and format of the disclosure is the Relevant Authority's decision in its absolute discretion.

17. Invalid parts of the contract

If any part of a Contract is prohibited by Law or judged by a court to be unlawful, void or unenforceable, it must be read as if it was removed from that Contract as much as required and rendered ineffective as far as possible without affecting the rest of the Contract, whether it is valid or enforceable.

18. No other terms apply

The provisions incorporated into each Contract are the entire agreement between the Parties. The Contract replaces all previous statements, agreements and any course of dealings made between the Parties, whether written or oral, in relation to its subject matter. No other provisions apply.

19. Other people's rights in a contract

No third parties may use the Contracts (Rights of Third Parties) Act 1999 (CRTPA) to enforce any term of the Contract unless stated (referring to CRTPA) in the Contract. This does not affect third party rights and remedies that exist independently from CRTPA.

20. Circumstances beyond your control

- 20.1. Any Party affected by a Force Majeure Event is excused from performing its obligations under a Contract while the inability to perform continues, if it both:
- (a) provides a Force Majeure Notice to the other Party; and
 - (b) uses all reasonable measures practical to reduce the impact of the Force Majeure Event.
- 20.2. Either Party can partially or fully terminate the affected Contract if the provision of the Deliverables is materially affected by a Force Majeure Event which lasts for 90 days continuously.

21. Relationships created by the contract

No Contract creates a partnership, joint venture or employment relationship. The Supplier must represent themselves accordingly and ensure others do so.

22. Giving up contract rights

A partial or full waiver or relaxation of the terms of a Contract is only valid if it is stated to be a waiver in writing to the other Party.

23. Transferring responsibilities

- 23.1. The Supplier cannot assign, novate or transfer a Contract or any part of a Contract without the Relevant Authority's written consent.
- 23.2. The Relevant Authority can assign, novate or transfer its Contract or any part of it to any Central Government Body, public or private sector body which performs the functions of the Relevant Authority.
- 23.3. When CCS or the Buyer uses its rights under Clause 23.2 the Supplier must enter into a novation agreement in the form that CCS or the Buyer specifies.
- 23.4. The Supplier can terminate a Contract novated under Clause 23.2 to a private sector body that is experiencing an Insolvency Event.

- 23.5. The Supplier remains responsible for all acts and omissions of the Supplier Staff as if they were its own.
- 23.6. If CCS or the Buyer asks the Supplier for details about Subcontractors, the Supplier must provide details of Subcontractors at all levels of the supply chain including:
 - (a) their name;
 - (b) the scope of their appointment; and
 - (c) the duration of their appointment.

24. Changing the contract

- 24.1. Either Party can request a Variation which is only effective if agreed in writing and signed by both Parties.
- 24.2. The Supplier must provide an Impact Assessment either:
 - (a) with the Variation Form, where the Supplier requests the Variation; or
 - (b) within the time limits included in a Variation Form requested by CCS or the Buyer.
- 24.3. If the Variation cannot be agreed or resolved by the Parties, CCS or the Buyer can either:
 - (a) agree that the Contract continues without the Variation; or
 - (b) terminate the affected Contract, unless in the case of an Order Contract, the Supplier has already provided part or all of the provision of the Deliverables, or where the Supplier can show evidence of substantial work being carried out to provide them; or
 - (c) refer the Dispute to be resolved using Clause 34 (Resolving Disputes).
- 24.4. CCS and the Buyer are not required to accept a Variation request made by the Supplier.
- 24.5. If there is a General Change in Law, the Supplier must bear the risk of the change and is not entitled to ask for an increase to the DPS Pricing or the Charges.
- 24.6. If there is a Specific Change in Law or one is likely to happen during the Contract Period the Supplier must give CCS and the Buyer notice of the likely effects of the changes as soon as reasonably practical. They must also say if they think any Variation is needed either to the Deliverables, DPS Pricing or a Contract and provide evidence:
 - (a) that the Supplier has kept costs as low as possible, including in Subcontractor costs; and
 - (b) of how it has affected the Supplier's costs.
- 24.7. Any change in the DPS Pricing or relief from the Supplier's obligations because of a Specific Change in Law must be implemented using Clauses 24.1 to 24.4.
- 24.8. For 101(5) of the Regulations, if the Court declares any Variation ineffective, the Parties agree that their mutual rights and obligations will be regulated by the terms

of the Contract as they existed immediately prior to that Variation and as if the Parties had never entered into that Variation.

25. How to communicate about the contract

- 25.1. All notices under the Contract must be in writing and are considered effective on the Working Day of delivery as long as they are delivered before 5:00pm on a Working Day. Otherwise the notice is effective on the next Working Day. An email is effective at 9:00am on the first Working Day after sending unless an error message is received.
- 25.2. Notices to CCS must be sent to the CCS Authorised Representative's address or email address indicated on the Platform.
- 25.3. Notices to the Buyer must be sent to the Buyer Authorised Representative's address or email address in the Order Form.
- 25.4. This Clause does not apply to the service of legal proceedings or any documents in any legal action, arbitration or dispute resolution.

26. Dealing with claims

- 26.1. If a Beneficiary is notified of a Claim then it must notify the Indemnifier as soon as reasonably practical and no later than 10 Working Days.
- 26.2. At the Indemnifier's cost the Beneficiary must both:
 - (a) allow the Indemnifier to conduct all negotiations and proceedings to do with a Claim; and
 - (b) give the Indemnifier reasonable assistance with the claim if requested.
- 26.3. The Beneficiary must not make admissions about the Claim without the prior written consent of the Indemnifier which can not be unreasonably withheld or delayed.
- 26.4. The Indemnifier must consider and defend the Claim diligently using competent legal advisors and in a way that does not damage the Beneficiary's reputation.
- 26.5. The Indemnifier must not settle or compromise any Claim without the Beneficiary's prior written consent which it must not unreasonably withhold or delay.
- 26.6. Each Beneficiary must take all reasonable steps to minimise and mitigate any losses that it suffers because of the Claim.
- 26.7. If the Indemnifier pays the Beneficiary money under an indemnity and the Beneficiary later recovers money which is directly related to the Claim, the Beneficiary must immediately repay the Indemnifier the lesser of either:
 - (a) the sum recovered minus any legitimate amount spent by the Beneficiary when recovering this money; or
 - (b) the amount the Indemnifier paid the Beneficiary for the Claim.

27. Preventing fraud, bribery and corruption

- 27.1. The Supplier must not during any Contract Period:
- (a) commit a Prohibited Act or any other criminal offence in the Regulations 57(1) and 57(2); or
 - (b) do or allow anything which would cause CCS or the Buyer, including any of their employees, consultants, contractors, Subcontractors or agents to breach any of the Relevant Requirements or incur any liability under them.
- 27.2. The Supplier must during the Contract Period:
- (a) create, maintain and enforce adequate policies and procedures to ensure it complies with the Relevant Requirements to prevent a Prohibited Act and require its Subcontractors to do the same;
 - (b) keep full records to show it has complied with its obligations under Clause 27 and give copies to CCS or the Buyer on request; and
 - (c) if required by the Relevant Authority, within 20 Working Days of the Start Date of the relevant Contract, and then annually, certify in writing to the Relevant Authority, that they have complied with Clause 27, including compliance of Supplier Staff, and provide reasonable supporting evidence of this on request, including its policies and procedures.
- 27.3. The Supplier must immediately notify CCS and the Buyer if it becomes aware of any breach of Clauses 27.1 or 27.2 or has any reason to think that it, or any of the Supplier Staff, has either:
- (a) been investigated or prosecuted for an alleged Prohibited Act;
 - (b) been debarred, suspended, proposed for suspension or debarment, or is otherwise ineligible to take part in procurement programmes or contracts because of a Prohibited Act by any government department or agency;
 - (c) received a request or demand for any undue financial or other advantage of any kind related to a Contract; or
 - (d) suspected that any person or Party directly or indirectly related to a Contract has committed or attempted to commit a Prohibited Act.
- 27.4. If the Supplier notifies CCS or the Buyer as required by Clause 27.3, the Supplier must respond promptly to their further enquiries, co-operate with any investigation and allow the Audit of any books, records and relevant documentation.
- 27.5. In any notice the Supplier gives under Clause 27.3 it must specify the:
- (a) Prohibited Act;
 - (b) identity of the Party who it thinks has committed the Prohibited Act; and
 - (c) action it has decided to take.

28. Equality, diversity and human rights

- 28.1. The Supplier must follow all applicable equality Law when they perform their obligations under the Contract, including:
- (a) protections against discrimination on the grounds of race, sex, gender reassignment, religion or belief, disability, sexual orientation, pregnancy, maternity, age or otherwise; and
 - (b) any other requirements and instructions which CCS or the Buyer reasonably imposes related to equality Law.
- 28.2. The Supplier must take all necessary steps, and inform CCS or the Buyer of the steps taken, to prevent anything that is considered to be unlawful discrimination by any court or tribunal, or the Equality and Human Rights Commission (or any successor organisation) when working on a Contract.

29. Health and safety

- 29.1. The Supplier must perform its obligations meeting the requirements of:
- (a) all applicable Law regarding health and safety; and
 - (b) the Buyer's current health and safety policy while at the Buyer's Premises, as provided to the Supplier.
- 29.2. The Supplier and the Buyer must as soon as possible notify the other of any health and safety incidents or material hazards they are aware of at the Buyer Premises that relate to the performance of a Contract.

30. Environment

- 30.1. When working on Site the Supplier must perform its obligations under the Buyer's current Environmental Policy, which the Buyer must provide.
- 30.2. The Supplier must ensure that Supplier Staff are aware of the Buyer's Environmental Policy.

31. Tax

- 31.1. The Supplier must not breach any Tax or social security obligations and must enter into a binding agreement to pay any late contributions due, including where applicable, any interest or any fines. CCS and the Buyer cannot terminate a Contract where the Supplier has not paid a minor Tax or social security contribution.
- 31.2. Where the Charges payable under a Contract with the Buyer are or are likely to exceed £5 million at any point during the relevant Contract Period, and an Occasion of Tax Non-Compliance occurs, the Supplier must notify CCS and the Buyer of it within 5 Working Days including:
- (a) the steps that the Supplier is taking to address the Occasion of Tax Non-Compliance and any mitigating factors that it considers relevant; and
 - (b) other information relating to the Occasion of Tax Non-Compliance that CCS and the Buyer may reasonably need.

- 31.3. Where the Supplier or any Supplier Staff are liable to be taxed or to pay National Insurance contributions in the UK relating to payment received under an Order Contract, the Supplier must both:
- (a) comply with the Income Tax (Earnings and Pensions) Act 2003 and all other statutes and regulations relating to income tax, the Social Security Contributions and Benefits Act 1992 (including IR35) and National Insurance contributions; and
 - (b) indemnify the Buyer against any Income Tax, National Insurance and social security contributions and any other liability, deduction, contribution, assessment or claim arising from or made during or after the Contract Period in connection with the provision of the Deliverables by the Supplier or any of the Supplier Staff.
- 31.4. If any of the Supplier Staff are Workers who receive payment relating to the Deliverables, then the Supplier must ensure that its contract with the Worker contains the following requirements:
- (a) the Buyer may, at any time during the Contract Period, request that the Worker provides information which demonstrates they comply with Clause 31.3, or why those requirements do not apply, the Buyer can specify the information the Worker must provide and the deadline for responding;
 - (b) the Worker's contract may be terminated at the Buyer's request if the Worker fails to provide the information requested by the Buyer within the time specified by the Buyer;
 - (c) the Worker's contract may be terminated at the Buyer's request if the Worker provides information which the Buyer considers is not good enough to demonstrate how it complies with Clause 31.3 or confirms that the Worker is not complying with those requirements; and
 - (d) the Buyer may supply any information they receive from the Worker to HMRC for revenue collection and management.

32. Conflict of interest

- 32.1. The Supplier must take action to ensure that neither the Supplier nor the Supplier Staff are placed in the position of an actual or potential Conflict of Interest.
- 32.2. The Supplier must promptly notify and provide details to CCS and each Buyer if a Conflict of Interest happens or is expected to happen.
- 32.3. CCS and each Buyer can terminate its Contract immediately by giving notice in writing to the Supplier or take any steps it thinks are necessary where there is or may be an actual or potential Conflict of Interest.

33. Reporting a breach of the contract

- 33.1. As soon as it is aware of it the Supplier and Supplier Staff must report to CCS or the Buyer any actual or suspected breach of:
- (a) Law;

- (b) Clause 12.1; or
- (c) Clauses 27 to 32.

- 33.2. The Supplier must not retaliate against any of the Supplier Staff who in good faith reports a breach listed in Clause 33.1 to the Buyer or a Prescribed Person.

34. Resolving disputes

- 34.1. If there is a Dispute, the senior representatives of the Parties who have authority to settle the Dispute will, within 28 days of a written request from the other Party, meet in good faith to resolve the Dispute.
- 34.2. If the Dispute is not resolved at that meeting, the Parties can attempt to settle it by mediation using the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure current at the time of the Dispute. If the Parties cannot agree on a mediator, the mediator will be nominated by CEDR. If either Party does not wish to use, or continue to use mediation, or mediation does not resolve the Dispute, the Dispute must be resolved using Clauses 34.3 to 34.5.
- 34.3. Unless the Relevant Authority refers the Dispute to arbitration using Clause 34.4, the Parties irrevocably agree that the courts of England and Wales have the exclusive jurisdiction to:
- (a) determine the Dispute;
 - (b) grant interim remedies; and/or
 - (c) grant any other provisional or protective relief.
- 34.4. The Supplier agrees that the Relevant Authority has the exclusive right to refer any Dispute to be finally resolved by arbitration under the London Court of International Arbitration Rules current at the time of the Dispute. There will be only one arbitrator. The seat or legal place of the arbitration will be London and the proceedings will be in English.
- 34.5. The Relevant Authority has the right to refer a Dispute to arbitration even if the Supplier has started or has attempted to start court proceedings under Clause 34.3, unless the Relevant Authority has agreed to the court proceedings or participated in them. Even if court proceedings have started, the Parties must do everything necessary to ensure that the court proceedings are stayed in favour of any arbitration proceedings if they are started under Clause 34.4.
- 34.6. The Supplier cannot suspend the performance of a Contract during any Dispute.

35. Which law applies

This Contract and any Disputes arising out of, or connected to it, are governed by English law.
