Section 1 - FORM OF CONTRACT

CONTRACT FOR: ISF Somaliland: International Election Observation Mission

THIS CONTRACT is made

BETWEEN : The Secretary of State for Foreign, Commonwealth and Development Affairs
at the Foreign Commonwealth and Development Office, King Charles Street,
London SW1A 2AH ("**FCDO**");

AND : **UCL Consultants Ltd** ("**Supplier**") whose registered office is situated at 90

(and FCDO and the Supplier together shall be the "**Parties**").

WHEREAS:

- A.** FCDO requires the Supplier to provide the Services to Somaliland: International Election Observation Mission (the "Recipient"); and

No payment will be made to the Supplier under this Contract until a copy of the Form of Contract, signed on behalf of the Supplier, is returned to the FCDO Contract Officer.

3. Commencement Date and End Date of Initial Period

The Services shall commence on 18 October 2024 ("Start Date") and the end date of the Initial Period shall be 31 March 2025 ("End Date")

4. Financial Limit

Payments under this Contract shall not, in any circumstances, exceed £279,909 exclusive of
