Thank you for your request for Castons to submit a fee proposal to provide construction consultancy assistance on the above titled programme of works (full and final scope of works is to be defined).

Castons are suppliers to the SBS Consultancy Framework in the capacity of Project Managers, Quantity Surveyors, Building Surveyors and Ancillary Services Our reference number is noted as SBS/17/NH/PZR/9256/43.

For reference the proposed Backlog programme comprises 25Nr. individual projects with an anticipated financial commitment of £1,305,000 (excl. VAT, Fees etc).

We have outlined the basis of our fees as follows:

Programme Management - The service includes oversight and reporting on the entire BLM programme. This would entail a scheduled report on 2 weekly or monthly basis identifying programmed dates for commencement/completion, risks, blockers to progress, recommendation of actions and programme cost summary.

Individual Development Management - The service includes allowance for project management and quantity surveying services to deliver each individual project. In order to assess NHS SBS Framework fees, it is necessary to base on packaged works into approx. 5 groups of 5 average jobs:

 - 13.7.1 Cladding Claims: Any damage, loss, cost or expense or any other liability directly or indirectly arising from or in any way related to the combustibility of any composite panels, cladding or facades of building or structures, and/or internal or external wall systems and any associated core/filler/insulation material and/or any fixing systems.
 - 13.7.2 Fire Safety Claims: Any damage, loss, cost or expense or any other liability directly or indirectly arising from or in any way related to the fire safety performance or combustibility of a building or structure or any part of such building or structure, other than Cladding Claims.
 - 13.7.3 EWS1 Forms: The completion of an EWS1 form (or as revised) or any other services related to the completion of an EWS1 form (or as revised);
 - 13.7.4 Communicable Diseases: Coronavirus and any strain of Coronavirus or its sequalae; atypical pneumonia or any strain thereof.

The above is exclusive of Value Added Tax but includes all expenses and disbursements.

The above sums include all expenses and disbursements but exclude Valued Added Tax.
