(and DFID and the Supplier together shall be the "**Parties**").

The Services shall commence on **15 July 2020** and the end date of the Initial Period shall be **31 March 2025**.

## 4. Financial Limit

Payments under this Contract shall not, in any circumstances, exceed **£177,000,000** exclusive of UK VAT, if applicable (the "financial limit"). Of which **£17,414,527** is in respect of fees and expenses payable under the terms of this Contract, as detailed in section 5 and the balance of the financial limit of **£159,585,473** is the funds available for project financing, as detailed in the Terms of Reference.
