# CONTRACT FOR: Support to the Health System in DRC Programme (Appui au Systeme de Sante en RDC (ASSR)

### CONTRACT NUMBER: 8510

With reference to the contract dated 24<sup>th</sup> April 2019, both Parties have in principle agreed to the following variations to the Contract:

## Section 1, Form of Contract, Financial Limit, paragraph 4:

DELETE: "Payments under this Contract shall not, in any circumstances, exceed £35,000,000 exclusive of any government tax, if applicable."

INSERT: "Payments under this Contract shall not, in any circumstances, exceed £38,000,000 exclusive of any government tax, if applicable."

### Section 4, Special Conditions, Sub-contractors, paragraph 4:

These amendments relate to an increase of £3,000,000 to the Financial Limit, as updated in Section 1 and Section 5; the addition of sub-contractors, as updated in Section 4; and the addition of Annex A to Section 3. The purpose of the amendment is for an urgent Covid-19 response. Note that the Covid-19 related budget adds to £4,500,000 million – £3,000,000 from the increase in the Financial Limit and £1,500,000 from savings to date on the original Contract.

4. The Contract, including any previous variation, shall remain effective and unaltered except as amended by this letter.
