SPECIFICATION FOR THE GRAVE DIGGING IN TROWBRIDGE CEMETERY, THE DOWN, TROWBRIDGE TO BE USED AS THE BASIS FOR A FIXED PRICE PER EXCAVATION TO OPERATE FOR AN INITIAL 12 MONTHS COMMENCING THE 1<sup>st</sup> APRIL 2024 (WITH AN OPTION TO EXTEND TO 2 YEARS)

## GENERAL TERMS OF CONTRACT

- 1. The successful contractor shall satisfy the Town Council through the Facilities Operations Manager, Neighbourhoods Operations Manager and Cemetery & Allotments Officer.
  - a. That they have available suitable, well-maintained equipment to carry out the work.
  - b. That all persons to be engaged in the work have been properly trained in the use of equipment and other materials, and that they have been made fully aware of the nature of the equipment and materials, and possible dangers to themselves and others arising from their transport, storage, or application.
  - c. That they have adequate insurance cover against third-party claims which might arise from their negligence whilst performing the work.
  - d. That they have adequate Employer's Liability insurance cover in respect of the employees engaged in the work.
  - e. That they are able to comply with all statutory requirements concerning the performance of the contract.
- The successful contractor shall inform the Facilities & Neighbourhoods Manager immediately when they become aware of any deficiency concerning 1a to 1e as above and respond promptly to any questions or requests for evidence from the Facilities & Neighbourhoods Manager on matters relating to the contract.

#### WORK TO BE CARRIED OUT UNDER CONTRACT

3. The work to be carried out under the terms of the contract shall comprise the following.

## **GRAVE DIGGING CONTRACT**

- 3.1 The general requirements covering all operations in Trowbridge Cemetery.
- 3.2 The contractor will be required to undertake works in relation to interment of bodies and cremated remains.
- 3.3 The Cemetery is located at The Down, Trowbridge, BA14 7NH
- 3.4 Upon receipt of instructions from the supervising officer and agreed by the contractor, the contractor shall excavate graves within a minimum of 24 hours of receipt of instructions to the depth specified. The grave identification and location along with the coffin measurements will be given to the contractor by the supervising Officer.
- 3.5 To assist the contractor in locating the burial plots a map will be provided of the cemetery where burial works and excavations and associated works are to take place. The supervising officer will identify and mark the grave space at the cemetery to clearly show the position of the plot to be excavated.
- 3.6 To assist the town council in preparing a new budget the schedule of rates will be determined in November each year.
- 3.7 Conditions of Contract Definitions;
  - A. The burial authority shall mean Trowbridge Town Council. The Supervising Officer will be an employee of the authority.
  - B. The contractor employed for this work is ...... who is hereafter referred to as the Contractor.
  - C. The Contract will begin on 1<sup>st</sup> April 2024 and terminate on 31<sup>st</sup> March 2025 unless extended to 2 years, cessation of the contract for any reasons other than those of a disciplinary nature, shall be of 3 months duration by either party.
  - D. Payment will be made monthly in arrears for all works during the previous month.
- 3.8 The contractor should make himself fully aware of the site conditions and comply with all the requirements for statutory equipment. Any claims arising from the contractor's failure to comply with this clause will not be admitted.
- 3.9 The contractor will be responsible for the provision, maintenance and safe use of all tools and equipment required for the works.
- 3.10 The contractor must comply with all statutory requirements appertaining to Health & Safety legislation under the Health and Safety at Work Act 1974 (General Duties of Self-Employed Persons) (Prescribed Undertakings)

Regulations 2015, and shall be responsible for making the site a safe and tidy place of work for himself and any other persons working on his behalf.

- 3.11 All monies or other items of value found by the contractor or his employees at the site shall be handed to the supervising officer as soon as possible and a written receipt obtained.
- 3.12 The contractor shall comply with all legislation relating to the payment of income or other taxes and national insurance contributions arising from this contract with the Authority.
- 3.13 Due to the very sensitive nature of the work required in this contract, It is essential that a professional attitude and commitment is maintained throughout the contract. If the contractor fails to provide the service covered within this contract, the Authority, without prejudice, reserves the right to terminate the contract immediately.
- 3.14 The schedule of rates shall be reviewed in November annually and is inclusive of all necessary labour materials, transport and equipment for the proper execution of the works and includes all necessary safety equipment and shoring which may be required.
- 3.15 Specification of works

Operations should comply with Local Authority Cemetery Order 1977.

- I. No body shall be buried in a grave in such a manner that any part of the coffin is less than three feet below the level of any ground adjoining the grave: Provided that the burial authority may, where they consider the soil to be suitable, permit a coffin made of perishable materials to be placed not less than two feet below the level of any ground adjoining the grave.
- II. No body shall be buried in a grave unless the coffin is effectively separated from any coffin interred in the grave on a previous occasion by means of a layer of earth not less than six inches thick.
- III. When any grave is reopened to make another burial therein, no person shall disturb any human remains interred therein or remove them from any soil which is offensive.
- 3.16 The operation of grave digging shall include the following operations;
  - I. Excavation, Shoring & dressing of the grave
  - II. Backfilling of the grave
  - III. Reinstatement of the grave
- 3.17 Graves are to be dug on the day of the burial, no excavated graves are to be left overnight unless agreed with the supervising Officer.

- 3.18 Excavations of graves are to be performed by machine or hand when access by machines is not possible.
- 3.19 Any damage caused to grassed areas within the cemetery in connection with excavation operations will be put right and made good by the contractor at their own cost to the satisfaction of the supervising officer.
- 3.20 Standard sizes for graves are as follows :-

Single	7' Length	Х	2'4" width	х	4'3" depth
Double	7' Length	х	2'4" width	Х	6' depth
Cremated remains	1'2" Length	х	1'5" width	х	2' depth

These are a guide only, actual sizes may vary.

- 3.21 Having completed the excavation the grave should be covered with boards provided by the contractor to remove any element of danger to persons entering the burial ground. This task should be undertaken on each occasion where a grave is to be left unattended.
- 3.22 Before the arrival of the cortege the following tasks shall be undertaken, the grave being fully prepared not less than one hour before the arrival of the cortege at the burial ground.
- 3.23 The contractor shall empty the grave of any water that has been collected during or after the excavation.
- 3.24 The contractor should cover the base of the grave with a layer of wood shavings/ leaves approved by the supervising officer to absorb any remaining water. The layer of material shall be uniformly distributed over the whole surface of the grave base. The contractor must allow for the provision of wood shavings in his pricing.
- 3.25 The Grave surround shall be fitted with a standard raised platform provided by the contractor to give a firm footing for the funeral party/ bearers.
- 3.26 The platform and gravesides shall then be draped with grass matting approved by the supervising Officer. The matting shall be arranged so the sides of the grave are completely covered and that the surrounds are covered to an area extending 600mm beyond the edges of the grave. Grass mats shall be pegged as required and shall be neatly and tidily arranged.
- 3.27 Any spoil mound adjacent to the grave shall then be completely covered with grass matting, all storage boards being similarly covered. The matting for dressing the graves must be completed by the contractor and covered at their rates.
- 3.28 The area around the grave shall then be cleared of any debris or litter leaving the site in a tidy and presentable condition.

- 3.29 Coffin Lowering ropes/ webbing straps and coffin support bearing logs are placed in positions normally 2 or 3 of each being required placed at the centres appropriate to the size of the grave.
- 3.30 Coffin Lowering ropes/straps must be polyester or woven flax type (50-75mm wide) and a minimum of 7m in length.
- 3.31 Coffin support bearers 2 numbers required. These must be constructed of hardwood. Sizes approximately 914 x 100 x 60mm with one being marked to define head position.
- 3.32 A pot of fine/graded soil shall be provided by the contractor at the graveside to be used by the mourner, in a suitable container.
- 3.33 During the burial the contractor shall be present on the site to provide any assistance that may be required in the event of collapse of the grave shoring, unless by previous agreement with the supervising officer. During the burial any staff connected with the excavation of the grave shall remain out of sight of the mourners. Any tools and equipment shall be out of sight of the funeral party.
- 3.34 Immediately after the cortege has left the site the grave shall be backfilled. During backfilling, spoil shall not be allowed to fall onto the coffin in such a manner that will cause damage.
- 3.35 The surface of the grave should finally be mounded to produce a uniform and smooth mound of curved cross section standing 250mm proud of the surrounding surface. All work is to be completed on the day of the burial.
- 3.36 Any memorial which has been soiled during the excavation or backfilling of the grave should then be thoroughly cleaned to the satisfaction of the supervising officer.
- 3.37 All ropes grass matting and other equipment provided by the contractor should then be cleaned and retained for future use.
- 3.38 The contractor shall maintain the grave to make good settlement 8 weeks and 16 weeks after the funeral. The contractor has the option to store onsite or bring sufficient soil for the graves to reform the mound created. In carrying out this work the contractor should remove any floral tributes, replacing them upon completion of work. Similarly, the contractor should clean any memorials soiled during this operation.
- 3.39 After 16 weeks have elapsed following the burial, the contractor should level the grave by adding or removing soil as required, unless otherwise stated by the supervising Officer. The surface should then be dug to a depth of 150mm to produce a fine tilth, firmed and raked level.

#### 3.40 Reopens

I. Before any excavation or reopens, there will be a requirement to rod the grave to check that the appropriate depth is available for burial.

II. Rodding of existing grave spaces will be supervised by the council's supervising officer. If depth is available the supervising officer will instruct the contractor to excavate the grave to the size specified, and in accordance with the above specification.

#### 3.41 Cremated Remains

- I. Upon the receipt of instruction by the supervising officer, the contractor should excavate graves with a minimum of 24 hours of receipt of instruction. In carrying out this work the contractor shall ensure that all the requirements of good working practice are complied with.
- II. Any interment of cremated remains shall be at the depth of 45mm. The turf shall be lifted from the grave and the grave Excavated to the required depth. When the remains have been placed into the grave the grave should be backfilled and compressed and the turf replaced on the grave.
- III. Any grass matting and other equipment provided by the contractor should then be cleaned and retained for future use.

## 3.42 Performance of the contract

- I. In carrying out such works the contractor and his staff shall exhibit a caring attitude, showing the utmost respect for both mourners and to the staff employed by Funeral Directors and others visiting the cemetery or burial ground.
- II. The contractor shall provide and maintain a telephone communications system for the duration of the contract. This is an essential feature of this contract to ensure an efficient exchange of information between the supervision officer and the contractor so that changes in instruction which may affect the efficient management of the cemetery and the level of service provided can be maintained.
- III. Before carrying out any excavation the contractor should examine adjacent memorials to ensure they are in a safe condition. In the event of any memorials being unsafe, the contractor shall immediately inform the supervising officer.
- IV. The removal and replacement of memorial/kerb sets will be dealt with directly between the Supervising officer and the Funeral Director.
- V. Memorial adjacent to the excavation site shall be protected during the excavation and backfilling operations with boards provided by the contractor. Should any damage occur during excavations the supervising officer should be notified immediately, and the contractor will be held liable for the cost of the memorial repairs or replacement.
- VI. All tools and equipment shall, when not in use be stored or kept away from the grave sides.

- VII. The contractor may be required to undertake the removal of remains or special burials which shall be carried out following the relevant Home Office Licence and faculty issued by the Church Authority.
- 3.43 It is the responsibility of the contractor to acquaint themselves with and ensure all operations comply with all Statutory Regulations and recognised Codes of Practice relating to the works to be undertaken and in particular (for example but not by way of limitation)
  - A. Health & Safety at Work Act 1974
  - B. Construction (lifting operations) Regulations 1961 1998
  - C. Construction (general Provisions) Regulations 1961
  - D. Local Authorities Cemetery Order 1977

The Contractor shall ensure that all staff are fully trained, conversant, and skilled in the operation undertaken.

- 3.44 The contractor must supply a copy of their Public Liability Insurance and Health and Safety Policy at each renewal while under contract.
- 3.45 The contractor must follow the ICCM Code of Safe Working Practice for Cemeteries and must ensure the safety of all staff, contractors, and visitors to the cemetery as a result of their work.
- 3.46 Reporting Accidents
  - The contractor shall notify the supervising officer immediately of any notifiable accident or dangerous occurrences as defined in the reporting of injuries, diseases & Dangerous occurrences regulations 1985 No 2023 which occur on the authority's property or premises. Accidents will be recorded.
  - II. The Contractor shall immediately bring to the attention of the supervising officer anything which in their view constitutes a danger to persons or property.
- 3.47 Excess spoil from the graves is to be removed by the contractor from the site. An area designated by the town council will be available to store at an acceptable level to minimise the financial burden to the contractor and to minimise collection vehicles coming to the site. This is regarded as the most sustainable solution.

## OPTIONAL SERVICES FOR CONTRACT

4. The town council seeks costs from the contractor if within their portfolio to undertake ground maintenance services to the Cemetery. A contractor can provide costs to undertake both services being offered or just one of the two services.

#### SOFT GROUND MAINTENANCE SERVICES TO TROWBRIDGE CEMETERY

- 4.1 The contractor shall maintain all grassed areas of the cemetery throughout the contract period to the following specifications:
  - I. Maximum grass height of 40mm from 15<sup>th</sup> March until 30<sup>th</sup> September
  - II. Maximum grass height of 70mm from 1<sup>st</sup> October until 14<sup>th</sup> March
- 4.2 The contractor is expected to ensure the levels of cuttings are acceptable to preserve the sensitivity of the site but is not generally expected to collect grass cuttings. Excess cuttings may be stored in the designated bay as agreed by the supervising officer where they can be used for composting.
- 4.3 The contractor shall maintain all hedgerows within the boundary of the cemetery throughout the contract period to the following specifications:
  - I. Hedgerows including shrubbery maintained at a maximum height of 2m where it sits on the boundary to neighbouring properties.
  - II. Hedgerows including shrubbery maintained at a maximum distance of 2m from the boundary to neighbouring properties.
  - III. To control the invasion of brambles and ivy from any hedgerow where the hedgerow isn't formed by these two species.
- 4.4 The contractor shall maintain paths and roads to an acceptable level to preserve the sensitivity of the site for the following:
  - I. Control of weeds during the contract.
  - II. Control of Moss's growth to hard services during the contract.
  - III. Control of fallen leaves from October to March.
- 4.5 Leaf collection may be stored in the designated bay as agreed by the supervising officer where they can be used for composting.
- 4.6 The contractor will be responsible for the supply and maintenance of all equipment required to undertake the work.

#### REFERENCES

5. Applicants are required to supply examples of similar works undertaken.

## VARIATION TO COST

6. The Town Council will only consider an annual variation of the cost in November of the contract due to inflationary pressures.

#### SUBMISSION OF TENDER

7. Tenders must reach the Town Clerk, at the address given on the tender invite letter, in a sealed envelope endorsed '**GRAVE DIGGING AND GM SERVICES**' by no later than noon **Thursday 14<sup>th</sup> March 2024** 

8. Please ensure that you allow sufficient time to follow the instructions provided. Trowbridge Town Council is not obliged to accept the lowest or any tender during this process should all criteria not be met in full. Late applications will not be considered in any circumstances.

#### 9. **The Evaluation Process**

9.1 The contract will be awarded based on the value and the quality of the information provided in the tender submission.

The weightings assigned will be as follows:

Assessment	Score Awarded	Interpretation
Excellent	5	Excellent response with detailed supporting evidence and no weaknesses. Response demonstrates that the Tenderer will provide excellent services if awarded.
Good	4	Good response with good supporting evidence and minimal weaknesses. Response demonstrates that the Tenderer will provide good services if awarded.
Satisfactory	3	Satisfactory responses with satisfactory supporting evidence but lacks sufficient detail to award a higher mark. Response demonstrates that the tenderer will provide satisfactory services if awarded.

Poor	2	A response/answer/solution with reservations. Lacks convincing detail and the methodology to be applied. Medium risk that the proposed approach will not be successful
Very Poor	1	An unacceptable response with serious reservations. Limited detail of methodology to be applied. High risk that the proposed approach will not be successful
Unacceptable	0	Failed to address the question.

A score of 2 or less will render the submission ineligible and it will be withdrawn from process.

9.5 Unsuccessful suppliers may request feedback from the adjudication panel if required.

9.6 All costs and expenses associated with presentations shall be borne by the Tenderers

## FORMAT OF CONTRACT

10. The formal contract between the successful tenderer and the Town Council shall comprise this written specification, the written tender submitted by the contractor and the Town Council's written acceptance of the tender. Subsequent variations to the contract shall be by exchange of letters between the Council and the contractor.

11. Termination of contract can be exercised by either party by giving in writing three months notification or at any time where the provisions of this contract are not being served in the opinion of the council.
