**CONTRACT FOR: Delivering Effective Health Services**

With reference to the contractual letter dated 15th January 2011 (as most recently amended by the letter dated 7<sup>th</sup> April 2014) whereby your firm John Hopkins Bloomberg School of Public Health, was engaged to carry out the services as defined in Section 3 and with reference to the Concept Note for cross Research Programme Consortia Partnership on Gender, Ethics and Health Systems dated 3<sup>rd</sup> February 2014 and subsequent discussion, I confirm that the UK Government wishes to make the following further amendments to the letter of 15<sup>th</sup> January 2011:

### **Para 3, Commencement and Duration of Services**

Delete: The Supplier shall start Services on 1<sup>st</sup> January 2011 ("the Start Date") and complete them by 31<sup>st</sup> December 2017 ("the End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

Delete: The supplier shall start additional services for the Cross Research Programme Consortia Partnership on Gender, Ethics and Health Systems on 1<sup>st</sup> April 2014 ("the start date") and shall be completed by 30<sup>th</sup> September 2016 ("the end date") unless this contract is terminated earlier in accordance with its terms and conditions.

Insert: The Supplier shall start Services on 1<sup>st</sup> January 2011 ("the Start Date") and shall start additional services for the Cross Research Programme Consortia Partnership on Gender, Ethics and Health Systems (RINGS) on 1<sup>st</sup> April 2014. All services shall be completed by 31<sup>st</sup> December 2018 ("the End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

### **Para 4, Financial Limit**
