Section 1 - FORM OF CONTRACT

THIS CONTRACT is made

BETWEEN : The Secretary of State for International Development at the Department for International Development, Abercrombie House, Eaglesham Road, East Kilbride, G75 8EA, United Kingdom ("DFID");

AND : Carbon Trust Advisory Ltd ("Supplier")
whose principal place of business, or, where the Supplier is a company, whose registered office is situated at 4th Floor, Dorset House, 27-45 Stamford Street, London, SE1 9NT, United Kingdom.

(together "the Parties").

WHEREAS:

- A.** DFID requires the Supplier to provide the services as defined in Section 3 (the "Services") to (the "Recipient") as defined in Contract Section 3 – Terms of Reference
- B.** the Supplier has agreed to provide the Services on the terms and conditions set out in this Contract.

IT IS HEREBY AGREED as follows:

1. Documents

This Contract shall be comprised of the following documents:

This Contract constitutes the entire agreement between the Parties in respect of the Suppliers obligations and supersedes all previous communications between the Parties, other than as expressly provided for in Section 3 and/or Section 4.

2. Contract Signature

If the Original Form of Contract is not returned to the Contract Officer (as identified in Section 4) duly completed (including the applicable Purchase Order Number at the top of Section 1), and signed and dated on behalf of the Supplier within **15 working days** of the date of signature on behalf of DFID, DFID will be entitled, at its sole discretion, to declare this Contract void.

No payment will be made to the Supplier under this Contract until a copy of the Form of Contract, signed on behalf of the Supplier, is returned to the Contract Officer.

3. Commencement and Duration of the Services

The Supplier shall start the Services on 27th July 2017 (the "Start Date") and shall complete them by 21st January 2022 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

4. Financial Limit

Payments under this Contract shall not, in any circumstances, exceed £22,000,000 exclusive of any government tax, if applicable (the "Financial Limit") of which £2,669,288 is in respect to management fees due to the Supplier under the terms of this Contract, as detailed in Section 5 – Schedule of Payments and the balance of up to £19,330,712 of the Financial Limit is funds available for Phase 2 work.

5. Time of the Essence

Time shall be of the essence as regards the performance by the Supplier of its obligations under this Contract.
