TERMS & CONDITIONS

1. Event

The Event is ADAS 2024 to be held from 25 - 27 September, 2024 at the World Trade Centre, Metro Manila, Philippines.

2. Organizer

The Event is organized by APAC EXPO Pte Ltd ("the Organizer"), a Company registered in the Republic of Singapore with Company Registration No. 201327782K. All rights, power and discretion are exercised by APAC Expo Pte Ltd under this Licence Agreement.

Exhibitor

The Exhibitor and its employees and agents, as described in the Space Booking Form, are hereinafter referred to as "the Exhibitor".

4. Parties in the Agreement

The Organizer and the Exhibitor shall collectively be known as the "Parties", and each of them a "Party".

5. Licence

Upon the payment of the full Agreement Price the Exhibitor will have a conditional and revocable licence (the "Licence") to occupy the space allocated by the Organizer ("the Allocated Space") to exhibit the products it has notified the Organizer ("the Exhibiting Products") for the duration of the Exhibition ("the Period") during Show Hours (hereinafter defined). Nothing in this Agreement is intended nor shall be construed as granting to the Exhibitor any lease, tenancy or any other interest in the Allocated Space greater than a Licence.

Allocation of Space

The determination of the Allocated Space shall be at the sole discretion of the Organizer whose decision shall be final. If no Space is available for the Exhibitor, the Organizer shall refund to the Exhibitor the Agreement Price received from the Exhibitor without interest and the Organizer shall not have any liability to the Exhibitor whatsoever. The Organizer may from time to time change the Allocated Space to another space of comparable size by giving the Exhibitor three days written notice of such change. The terms of this Agreement shall nevertheless remain unchanged should the Organizer relocate the Exhibitor's Space.

7. Dates / Duration of Exhibition

The Exhibitor hereby acknowledges that the Organizer shall have the right, in its absolute discretion, to change or delay the dates or duration of the Exhibition at any time by serving on the Exhibitor a 14-day notice in writing without being liable to the Exhibitor for any damages or claims whatsoever. For the avoidance of doubt, with the exception of the cancellation of the Exhibition, no refund of any deposit, payment or part payment shall be given to the Exhibitor for any change or delay in the dates or duration of the Exhibition pursuant to this Clause.

Warranty

The Exhibitor represents, warrants and undertakes to the Organizer that it is entering into this Agreement as a principal and not as an

- agent or nominee of any third party, and that:
 a. the Exhibiting Products do not infringe any patent, trademark, copyright and other intellectual property right of any party, and so far as the Exhibitor is aware, no claim of such infringement has been made nor is the Exhibitor the subject of any litigation actual or threatened; and
- b. it has full power and capacity to enter into and perform this Agreement and that this Agreement when executed will constitute valid, binding and obligations of the Exhibitor.

The Exhibitor agrees that in the event of any breach of the representations, warranties and undertakings herein contained in this Agreement, the Licence may be revoked by the Organizer and this Agreement shall be terminated (without the Organizer being liable for any damages or claims whatsoever and without prejudice to the Organizer's rights and remedies hereunder) and the Exhibitor shall indemnify and keep the Organizer fully indemnified against any or all costs, claims, demands, losses, liabilities, charges, actions and expenses.

Booking & Payment Schedule

In order to book booth space, a 10% nonrefundable Booking Deposit is required. Once the Exhibitor's application has been received and the exhibition space has been allocated, the Exhibitor is legally contracted to the exhibit space and will comply with the following Payment Schedule:

- First Payment (Booking Non-refundable Deposit) 10% of Contract Price, due upon signing the Contract
- Second Payment 40% of Contract Price, due by 29 March, 2024
- Last Payment 50% of Contract Price, due by 28 June, 2024
- All Contracts signed AFTER 28 June 2024 - 100% of Contract Price due upon signing.

In the event that the Organizer extends the deadline for the payment of the full Contract Price to a later date at the request of the Exhibitor, the Exhibitor shall pay interest on the Contract Price to the Organizer at the prevailing interest rate plus

10. Cancellation & Withdrawal Policy

If the Exhibitor gives notice in writing of his intention to cancel or withdraw his booking, the Organizer shall be entitled to collect and/or retain payments that have already fallen due as stated in Clause 9 Booking and Payment Schedule.

11. Force Maieure

The Organizer will not be responsible for delays, damage, loss, increased costs or other unfavourable conditions arising by virtue of any cause not within the control of the Organizer. If, as a result of this, the Organizer is unable to perform any of its obligations under this Agreement, this Agreement shall be terminated and the Organizer shall not be liable to the

Exhibitor in any way and all monies paid shall not be refunded. For purposes hereof, the phrase "cause not within the control of the Organizer" shall include fire, flood, earthquake or other natural disasters, declaration of national mourning, epidemic, explosion or accident, blockade, embargo, governmental restraints, restraints or orders of civil defense or military authorities, act of public enemy, terrorist activities, riot or civil disturbance, strike, lockout, visitor boycott, low visitor attendance numbers, protest, or other labour dispute or disturbance, and any other circumstances beyond the reasonable control of the Organizer. The non-performance of this Agreement under this Clause shall not be deemed a breach or violation of the Terms of this Agreement.

12. Insurance Cover

The Organizer is not liable for any damages or losses caused by an Exhibitor to a third party or any damage suffered by the Exhibitor's property and the Exhibitor shall be responsible for taking out and meeting the costs of an adequate policy. Therefore, the Exhibitor hereby expressly acknowledges that it has subscribed to an insurance policy with an insurer that covers its third party liabilities and the liability of any person directly or indirectly participating in its activities and/or those of its company in respect of any physical injury and material and non-material loss or damage caused to others and arising directly as a consequence of the Exhibitor's participation and/or that of its company, in the Exhibition (including during the periods when the stands are being assembled and disassembled).

13. Marketing Materials

The Exhibitor expressly authorizes the Organizer To take photos and/or videos featuring the Exhibitor and/or members of its team, as

- well as any products exhibited at its stand; To use any such images freely on all media and in particular for the purpose of advertising (including on the internet) for a period of five (5) years beginning from the date of its Exhibition Space Booking and
- To use its trade mark and company name solely and strictly for the purpose of reasonably promoting, marketing and advertising the Exhibitor's participation in the Show on any media (including the internet) for a period of five (5) years beginning from the date of its Exhibition Space Booking.

14. Governing Law and Jurisdiction

The construction, validity and performance of this Agreement shall be governed by the laws of the Republic of Singapore. Each of the Parties hereby irrevocably and unconditionally submits to the exclusive jurisdiction of the Courts in Singapore and waives any objections to proceedings in such courts on the grounds of venue or on the grounds that the proceedings have been brought in an inconvenient forum.
