1. Introduction

Sandwell & West Birmingham Hospitals NHS Trust is an integrated care organisation. We have an outstanding reputation for teaching, innovation, and research. The Trust employs around 7,500 people, and serves a local population of 530,000 people across North-West Birmingham and Sandwell.

The Trust encompasses: City Hospital in Birmingham, which includes the Birmingham Treatment Centre, the Birmingham and Midland Eye Centre, the Pan Birmingham Gynae-Cancer Centre, Sickle Cell and Thalassaemia Centre, and the national Poisons Information Service; and, Sandwell General Hospital providing inpatient paediatrics, most general surgery and a Stroke Specialist Centre. There are A&E departments at both City Hospital and Sandwell hospital sites, and community teams deliver a number of services across Sandwell and West Birmingham. The Trust is also completing the construction of the new Midland Metropolitan University Hospital (MMUH), which is due to open in Spring 2024.

Your Trust Charity is the registered charity of Sandwell & West Birmingham Hospitals NHS Trust. Your Trust Charity has the following mission: "To enhance the experience of all people using our services including staff, patients and their families. We will do this by providing additional facilities and supporting innovative projects that create a comfortable and secure environment". Your Trust Charity exists to achieve 4 main priorities: Infrastructure, Education, Innovation and Community Resilience.

Your Trust Charity, the registered charity of Sandwell and West Birmingham NHS Trust (SWB), require a provider to design, fabricate and install an inspirational sculpture for the Midland Metropolitan University Hospital by 1st April 2024 (the end date).
