SAP and Customer agree that this Order Form is a binding agreement for Services governed by the SAP Services General Terms and Conditions ("GTCs") made available on http://www.sap.com/company/legal/index.epx, and incorporating the Service Descriptions pre-defined (the descriptions services http://www.sap.com/servicedescriptions) in effect as of the Effective Date of this Order Form. Together this Order Form, the GTC, the Service Descriptions and, to the extent the Services involve the processing of personal data, the Personal Data Processing Agreement for SAP Support and Professional Services ("DPA") made available on http://sap.com/agreement-services-support-professional-services-dpa form the "Agreement". 3.1.1. Termination

Section 7.4 of the GTCs (Termination of an Order Form for Convenience) shall not apply to SAP Value Assurance Support Services.

3.2. Taxes

Fees and other charges described in this Order Form do not include VAT, withholding or any other tax ("Taxes") now or hereafter levied, all of which shall be for Customer's account. Any applicable direct pay permits or valid tax-exempt certificates must be provided to SAP prior to the execution of this Order Form. If SAP is required to pay Taxes, Customer shall reimburse SAP for such amounts.

All taxes or customs duties except income or corporation taxes will be borne by Customer. If any such tax or duty has to be withheld or deducted from any payment under this Order Form, Customer will increase payment under this Order Form by such amount as shall ensure that after such withholding or deduction SAP shall have received an amount equal to the payment otherwise required.

Income taxes will be borne by SAP. If Customer is required to withhold income or corporation tax or a similar tax according to local law and respective double taxation treaties for royalties from payment to SAP, Customer shall be entitled to withhold or deduct such tax from the gross amount to be paid. SAP shall not commence work on any such change unless and until the Contract Change Note has been agreed to in writing by both parties.

5. Term

The term of this Order Form is the VA Services Term, as defined in Exhibit 1 Section 5 ("Term").

6. Validity of Offer

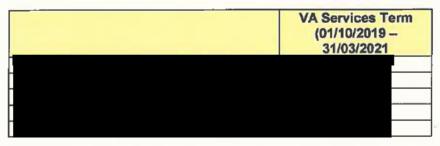

SAP Value Assurance Support Services. SAP Value Assurance Support Services ("VA Services") are in addition to the services provided under the Support Schedule to the License Agreement, and may provide professional expertise onsite and/or remotely as specified herein solely in support of Licensee's Future Of Shared Services project for the SAP Software that Licensee has licensed from SAP under the License Agreement unless specified otherwise herein.

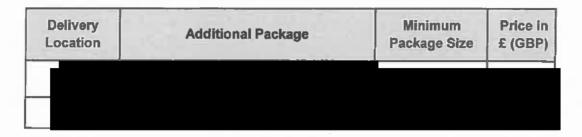
VA Services include the following components:

- 1.2 SAP Support Services. SAP Support Services will be provided in accordance with the VASSD for the quota of SAP Support Services days specified in Section 2 below during the VA Services Term ("Support Services Quota").
- **1.3 SAP Expertise on Demand.** SAP Expertise on Demand ("EoD" or "EoD Services") will be provided in accordance with the VASSD for the quota of EoD days specified in Section 2 below during the VA Services Term ("EoD Quota").
- **1.4 SAP On-Call Duty Services.** SAP On-Call Duty Services will be provided in accordance with the VASSD for the quota of SAP On-Call Duty sessions per Period specified in Section 2 below during the VA Services Term ("On-Call Duty Quota").

- 6. Additional Terms.
 - 6.1 In the event Customer requests additional Support Resources, Support Services, EoD days or On-Call Duty sessions in excess of the respective Support Resources, Support Services, EoD or On-Call Duty Quotas stated herein, such requested Support Resources, Support Services, EoD days or On-Call Duty sessions shall be delivered and invoiced to Customer as follows:



- 6.2 This VA Services Scope Document will terminate effective the same date as: (i) any termination of the Support Schedule under the License Agreement or (ii) any Customer change in its SAP support (i.e.; SAP Enterprise Support or SAP Product Support for Large Enterprises) subscription to SAP Standard Support.
- 6.3 Any unused Embedded Resources, Support Services, OCD or EoD Quota days shall expire at the end of the VA Services Term.
- 6.4 Licensee and SAP Engagement Managers can, with SAP's consent not to be unreasonably withheld, and within the same period and the same delivery country, transfer days (defined in Section 2 Quotas) between Embedded Resources, Support Services and, within reasonable limits, EoD on a 1:1 ratio. Provided that such reallocation shall not result in any change to the total number of Quota days within the affected period and EoD not being more than ten (10) per cent of the total period's Quota, or beyond the Scope of the services. Based on the before mentioned conditions, OCD sessions can also be transferred into days (defined in Section 2 Quotas) and vice versá, on a 1:1 ratio, if this is solely applied within a UK delivery location and Licensee has not more than 100 OCD sessions contracted. In case Customer has more than 100 On-Call Duty Quota sessions, an OCD transfer request will be subject to a separate ratio and will require a separate change request.
