Your Response must contain sufficient information to enable the Authority to evaluate it fairly and effectively. You should ensure that you have prepared your Response fully and accurately and that prices quoted are arithmetically correct for the units stated.

By submitting a Response, you, the supplier, are deemed to accept the terms and conditions provided in the RFQ. Confirmation of this is required in Annex 2.

Failure to comply with the instructions set out in the RFQ may result in the supplier's exclusion from this quotation process.

Acceptance of Quotations

By issuing this RFQ the Authority does not bind itself to accept any quotation and reserves the right not to award a contract to any supplier who submits a quotation.

Costs

The Authority will not reimburse you for any costs and expenses which you incur preparing and submitting your quotation, even if the Authority amends or terminates the procurement process.

Self-Declaration and Mandatory Requirements

The RFQ includes a self-declaration response (Annex 1) which covers basic information about the supplier, as well as any grounds for exclusion. If you do not comply with them, your quotation will not be evaluated.

Any mandatory requirements will be set out in Section 2, Specification of Requirements and, if you do not comply with them, your quotation will not be evaluated.

Clarifications

Any request for clarification regarding the RFQ and supporting documentation must be submitted via email no later than the deadline for clarifications set out in the Timetable. The Authority shall be under no obligation to respond to queries raised after the clarification deadline.

The Authority will respond to all reasonable clarifications as soon as possible but cannot guarantee a minimum response time. The Authority will publish all clarifications and its responses to all suppliers via email unless deemed commercially sensitive.

If a supplier believes that a request for clarification is commercially sensitive, it should clearly state this when submitting the clarification request. However, if the Authority considers either that:

the clarification and response are not commercially sensitive; and all suppliers may benefit from its disclosure,

then the Authority will notify the supplier (via email), and the supplier will have an opportunity to withdraw the request for clarification by sending a further message requesting the withdrawal of the clarification request. If not withdrawn by the supplier within 2 working days of the Authority's notification, the Authority may publish the clarification request and its response to all suppliers and the Authority shall not be liable to the supplier for any consequences of such publication.

Prices

Prices must be submitted in £ sterling, exclusive of VAT.

Specification of Requirements

Background to Natural England

Natural England (NE) is the Government's advisor on the natural environment. It provides practical advice, grounded in science, on how best to safeguard England's natural wealth for the benefit of everyone. Natural England's remit is to ensure sustainable stewardship of the land and sea so that people and nature can thrive. It is our responsibility to see that England's rich natural environment can adapt and survive intact for future generations to enjoy. Further information about the Authority can be found at: <u>Natural England</u>.

Background to Nutrient Neutrality

Investing in nature generates prosperity. A healthy environment and a vibrant economy must go hand in hand - our economic prosperity and well-being depends upon doing so. Through Nutrient Neutrality Natural England and Government are working with local planning authorities to enable the homes the country needs to be built while cleaning up our waterways.

Nutrient pollution is an urgent problem for freshwater habitats and estuaries which provide a home to wetland birds, fish, and insects. Increased levels of nutrients like nitrogen and phosphorus can speed up the growth of certain plants, disrupting natural processes and devastating wildlife. The impacts for people are also significant, with dirty waterways spoiling enjoyment of the outdoors.

While the government has taken substantial steps to tackle the issue, this scheme will fast track progress in hotspot areas alongside existing approaches including nutrient credit trading schemes, Local Planning Authority (LPA)-led mitigation schemes and onsite mitigation solutions integrated into the design of housing developments to unlock homebuilding across the country.

It will provide additional mitigation where it is needed and can work in combination with schemes that are currently in place or under development.

To this end Natural England is working with landowners and partners in order to establish constructed wetlands in appropriate locations within priority catchments in order to generate nutrient credits that property developers will be able to purchase in order to fulfil planning requirements.

The key deliverables for this contract will be:

Further feasibility work should provide the following information in report form. The work should be informed by the initial pre-feasibility report, 'Pre-Feasibility Assessment of the Potential for the Development of Constructed Wetlands' dated 03/05/2023. The report should provide the confidence to proceed to 'design and build' phases or the rationale for not proceeding with wetland implementation.

The key deliverable for this contract will be:

- I. Build on the 'pre-feasibility reduction figures' through identification of the possible range, ie minimum and maximum, for nutrient reduction capacity of the site, via wetland creation, for Nitrogen and Phosphorus using:
 - a. Transfer abstraction of water from the relevant watercourse and;

with generated reductions calculated using:

- *i.* One of the following methods with a supporting narrative
 - P-k-C* model
 - k-C* model
 - regression equation
- ii. Details of potential Flow
 - Flows of water from the relevant source
 - Inflow of other water sources
 - Variability of flow with time
- *iii.* Details of Concentration within Flow
 - Nitrogen and Phosphorus loads within all water sources considered
 - Variability of the quality with time
- *iv.* Refinement should enhance reduction calculations by ensuring the most relevant/localised data is used. Including:
 - A water balance calculation
 - Estimated sediment accumulation rates
- 2. Clarification of design objectives in terms of the site's capacity to generate nutrient reductions for N and P in the context of:
- Define the potential biodiversity impacts of:
 - o potential loss of ditch/stream (where relevant)
 - water impoundment/abstraction
 - o water temperature impacts through wetland transfer
- Carry out soil substrate investigations to determine:
 - o potential for groundwater interaction
 - o the extent of clay onsite
 - whether the wetland requires a clay or artificial liner
 - o if soil nutrient levels pose a risk of 'treatment liability' in terms of nutrient leaching
- Development of a monitoring and baselining strategy, including:
 - o identification of suitable monitoring points at in-flow and potential out-flows

- o flow and nutrient concentration monitoring
- Ranged cost estimates of:
 - o implementation and construction
 - o performance monitoring to equilibrium
 - o annual wetland maintenance
- Carry out a desk-based assessment to identify any risks that may impact design or construction of the wetland from:
 - o archaeological areas on-site
 - o utilities on-site
- Define the potential impacts of 'urban runoff' on wetland effectiveness (where relevant) including but not limited to:
 - o contaminate collection and discharge risk
 - o contaminate effect on biological processes on wetland plants
- 3. Feasibility Assessment including constraints and options assessment covering:
 - Topography
 - On-site Soil & Water sampling and analysis
 - Geology & Hydrogeology
 - Groundwater protection,
 - Hydrology & drainage
 - Flood risk
 - Protected sites & species
 - Land use, Historic landfill & Contaminated Land
 - Estimated costs of potential wetland design, construction, monitoring and maintenance

The above should be influenced by the provided 'site pre-feasibility' report and be undertaken within scope of the '<u>Wetland Mitigation Framework</u>'

Payment

The Authority will raise purchase orders to cover the cost of the services and will issue to the awarded supplier following contract award.

The Authority's preference is for all invoices to be sent electronically, quoting a valid Purchase Order number. Payment can be made in two instalments, with 25% to be invoiced upon receipt of the inception note, and the remaining 75% to be invoiced upon agreement of the final deliverables.

It is anticipated that this contract will be awarded for a period of 2 months, to end no later than 05/01/2024. Prices will remain fixed for the duration of the contract award period. We may at our sole discretion extend this contract to include related or further work. Any extension shall

be agreed in writing in advance of any work commencing and may be subject to further competition.

Evaluation Methodology

This section sets out the contract requirements. Suppliers must explain how they will deliver the required outputs within the specified timeframe and to budget. They must further demonstrate that they have the required skills and experience. Information on how this will be evaluated can be found below under Quotation Submission.

Purpose of this Contract

To support the Nutrient Neutrality project's habitat delivery enabling Natural England, landowners and other interested parties to understand constraints and likely costs of progression towards the design and build phase of schemes.

Aims of this Contract

To enable Natural England and partners to determine risks, options and estimated costs associated with the development of a constructed wetland(s) for phosphate and nitrogen reduction within Norfolk (Maps and information on exact area available on request).

Outputs and Contract Management

The main outputs for this project will be:

- A project inception meeting by video call (e.g. MS Teams/Zoom) within the first week of the project start. All costs associated with attending the inception meeting must be incorporated into the fixed price. The successful Tenderer must identify individuals who will manage the project and nominate a representative for day-to-day contact with the authority's project officer.
- Monthly calls with the project steering group to provide updates on progress in line with agreed deliverables and milestones, emerging findings, get knowledge input and feedback on deliverables.
- To complete a feasibility assessment of the potential for delivery of a constructed wetland(s) within Norfolk including a constraints and options assessment to enable Natural England to understand key risks associated with the site.
- Quality-assured final report and any tools developed to be provided to project manager in Word and/or Excel format. If any other format is to be used, this has to be agreed with the project manager at the start of the project and would need to be something which is accessible to all NE staff.

The outputs of the contract are included in the specification above. Fortnightly check-ins with the Project Officer via a Teams call or email, to discuss progress and/or any issues, will be required from July 2023 onwards, for the duration of the contract.

The project outputs are to be produced in a written final report in Word and pdf formats, as well as any accompanying visuals/graphics, spreadsheets and models. All reports will be clearly presented, concise, written in plain English with a target audience of an educated lay person. Reports will be supplied by email in Microsoft Word 97-2003 and pdf formats.

It is NE's expectation that all final project reports are published, NE however reserves the right to determine if and how results should be published.
