1. The Financial Reporting Council (FRC)

- The Financial Reporting Council (FRC) regulates auditors, accountants and actuaries and sets the UK's Corporate Governance and Stewardship Codes. We seek to promote transparency and integrity in business; our work is aimed at investors and others who rely on company accounts, audit, and high-quality risk management. As the Competent Authority for audit in the UK, the FRC sets auditing and ethical standards and monitors and enforces audit quality. Further information can be found at https://www.frc.org.uk/
- The Secretary of State for the Department of Business, Energy and Industrial Strategy (BEIS) (Secretary of State) delegated the functions relating to influencing, endorsing and adopting international accounting standards for application in the UK to the UKEB in May 2021. The UKEB influences, endorses and adopts new or amended international accounting standards issued by the International Accounting Standards Board (IASB) for use by UK companies. The UKEB consults publicly with stakeholders that have an interest in financial reporting in the UK so that it can develop and represent evidence-based UK views with the aim of acting as the UK voice on IFRS financial reporting. https://www.endorsement-board.uk/
- FRC has oversight responsibility in respect of the UKEB's adherence to robust governance and due processes. The FRC does not have the power to direct the UKEB in relation to the determination of its programme of work or the outcome of its technical decision-making, however the FRC provides operational support to UKEB (such as procurement and access to contractual agreements).

2. Background

- The FRC's Economics, Strategy and Analytics (ESA) team provides operational support to various departments at the FRC. These services include but are not limited to: -
 - Providing market intelligence and analysis on markets, companies, and the general business landscape in the UK
 - Leading on the FRC's research strategy, aligning research to priorities and commissioning projects
 - o Providing economic advice, including on Regulatory Impact Assessments
- To fulfil the activities undertaken by the ESA team, access to a near real-time financial market data platform that provides financial data, company data, financial news and financial analysis and country and economic data for public UK & International entities. This data must be accessible via web or desktop app and Excel plug ins.

3. Our Requirement

- The FRC requires, on an ongoing basis, a source of financial market data. Our requirement is
 therefore an ongoing* subscription with a database provider (with the breadth and depth of
 the data we require) that can provide the following content within the following data
 categories (See Annex 1 example parameters that fall within these categories; note our
 requirements are not limited to these named parameters):
 - o Financial statements and accounting standards data
 - o Asset data
 - \circ Debt data
 - o Audit data
 - Ownership data
 - o Operation and profit data
 - o Registration and identifier data
 - o Index data
 - Sector data
 - o Stock market / shares data
 - o Governance data
 - o Regulatory news data
 - o Press releases
 - o Broker reports
 - o Annual reports
- The FRC will require licences for 15 named users
- The FRC will require the rights to publish or reproduce small extracts from, or summaries of, the financial market data and will attribute the database supplier as the source of the information

* Likely initial Term of three years.

6. Submitting a tender

- Potential providers must submit their tender response within the deadline to procurement@frc.org.uk please see Tender evaluation below.
- A Tender must remain valid and capable of acceptance by the Authority for a period of 120 days following the Tender Submission Deadline. A Tender with a shorter validity period may be rejected.

7. Tender evaluation

- Please submit your proposal to reflect how your organisation can meet the FRC's requirement (including cost). You should also complete the "02 Standard_Selection_Questionnaire"
- Existing brochures of your offer will be accepted (however it must cover all the core stated Requirements).
- The FRC will award to the supplier that best meets the FRC's requirements (as per 3. Our Requirements). You should provide the proposed Terms & Condition for review.
- Note: The FRC is a public body therefore no onerous terms can be accepted (for example, high/ uncapped liability).
- Our evaluation will be based on quality 70% cost 30% (see further information below).

8. Outcome letters and call off contracts

• Upon contract award potential providers will be notified of the outcome by written communication. The Authority will undertake a Standstill period.

9. Further information

- Evaluation criteria
 - The information / response you provide should demonstrate that your organization has the track record and transferrable experience and expertise in providing Services aligned to the FRC's requirement. 15%
 - The information / response you provide should demonstrate that your organization has / will provide high levels of customer services, in particular, highly responsive to queries we may raise. 10%
 - The information / response you provide should demonstrate that your organization can and will supply the breadth and depth of financial market data the FRC requires. 45%
 - Pricing / cost 30%
 - Note: We expect bidders to have good industry standards relating to Information Security. Shortlisted suppliers may be requested to provide information upon request.

The Quality scoring approach that will be used is:

0	Unacceptable - Does not satisfy any part of the requirement.
25	Poor - Satisfies only minor aspects of the requirement.
50	Fair - Satisfies part of the requirement only, not the full requirement.
75	Good - Satisfies the requirement, with minor additional benefits.
100	Excellent - Satisfies the requirement, with major additional benefits.
