## 1. CONTRACT DETAILS

- **1.1 Contract Commencement Date:** The Contract shall commence on 1<sup>st</sup> April 2025.
- **1.2 Services Commencement Date:** Notwithstanding the date of execution, the Services Commencement Date shall be 1st April 2025.

#### **1.3** Contract Price ((i) breakdown and (ii) payment profile):

- 1.3.1 The maximum value of the services, for the instruments stated in clause 2.1 (the "Instruments") of this Order Form, that can be ordered under this Contract is £1,459,235.53 (one million, four hundred and fifty-nine thousand, two hundred and thirty-five pounds and fifty-three pence) only (excluding VAT). (the "Contract Price"). Full details of the Contract Price per annum are contained in Annex 2- Contract Price Breakdown, below. For the avoidance of doubt, the Authority is not committed to pay the full Contract Price.
- 1.3.2 The Contract Price is exclusive of VAT at the applicable rate but is inclusive of travel, expenses including subsistence, replacement parts and labour expenses.

#### **1.4 Term of Contract:**

- 1.4.1 The Contract shall commence on the Services Commencement Date unless terminated earlier, or extended, in accordance with its terms, expire on 31<sup>st</sup> March 2027 (the "Term").
- 1.4.2 The Authority may terminate the Contract for convenience at any time pursuant to clause 10 (Termination for convenience) of Appendix H (Further Optional Additional Call-off Terms and Conditions) of this Contract provided the Authority gives the Supplier not less than 3 (three) months written notice.

#### (1.5) Term extension options:
