Thank you for your interest in our requirement to carry out the Mystery Shopping Programme on behalf of the National Careers Service to the Education & Skills Funding Agency (ESFA).

We are pleased to advise you that the Agency is awarding Kantar TNS a contract based on your tender received through the DPS RM6018 in response to the ESFA's Invitation to tender dated October 2018. - 2. Invitation to tender (including the Service Specification) for the Provision of assurance dated September 2018.
- 3. Your service specification tender response and schedule of daily rates dated October 2018.

4. Following the inception meeting in December 2018 and the attached Statement of Work, the deliverables will be reviewed in January 2020.

ESFA Purchase Orders – The Agency will shortly confirm an official purchase order to cover the work requirements. Any purchase orders issued will be under the Terms and Conditions of the Framework Agreement and shall be endorsed with the Terms and Conditions of the DPS RM6018 apply to the Services provided against this purchase order, you should ensure that any invoices raised contain the DPS Framework reference and your ESFA contract number as stated above. It would be appreciated if you could confirm within 10 days of the date of this letter, your acceptance of this award subject to the provisions set out above.
