Section A – Introduction

Definitions

A1. This requirement is issued on behalf of the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland, (referred to in this document as "the Authority"). In this Agreement, the Authority is acting as part of the Crown.

A2. "You / Tenderer" means the economic operator or group of operators in the form of a consortium, including subcontractors, which has been invited to submit a response to this Invitation to Tender.

A3. "Invitation to Tender" (ITT) refers to the first document that the Authority sends out to potential Tenderers that initiates a tender response, competitive dialogue or negotiation.

A4. A "Tender" is the offer that you are making to the Authority.

A5. "Contractor Deliverables" means the works, goods and / or the services, including packaging (and Certificates(s) of Conformity supplied in accordance with any Quality Assurance (QA) requirements if specified) which the Contractor is required to provide under the contract in accordance with the Schedule of Requirements, but excluding incidentals outside the Schedule of Requirements such as progress reports.

A6. "Schedule of Requirements" Schedule 2 means that part of the contract which identifies, either directly or by reference, the Contractor Deliverables to be supplied or carried out, the quantities involved and the price or pricing terms in relation to each Contractor Deliverable.

A7. The "Statement of Requirement" details the technical requirements and acceptance criteria **Schedule 8 in Standardised Contracting (SC2)** of the Contractor Deliverables. The Statement of Requirement is attached to this DEFFORM 47. This may include the System Requirements Document (SRD).

A8. "Conditions of Tendering" means the Conditions set out in the DEFFORM 47 that govern the competition.

A9. "Contract Conditions" means the attached conditions that will govern any resultant contract.

A10. A "Third Party" is any person who is not an employee of the Tenderer as defined at A2.

Purpose

A11. The purpose of this ITT is to invite you to propose a solution / best price to our requirement. This documentation explains and sets out the:

- a. tender process and timetable for the next stages of the procurement;
- b. instructions and conditions that govern this competition;
- c. information you must include in your Tender and the required format;
- d. administrative arrangements for the receipt and evaluation of Tenders; and
- e. Contract Conditions that shall apply in the event that the Authority awards a contract following this competition.

A12. The sections in this ITT and associated documents are structured in line with a generic tendering process and do not indicate importance / precedence.

A13. This ITT has been issued to all potential Tenderers chosen during the supplier selection stage, listed on page 2 of this DEFFORM 47.

A14. This ITT is exempt from the Public Contract Regulations 2006 under the Regulation 8. The requirement was advertised by the Authority in the DCO dated 08-DEC-14.

ITT Documentation and ITT Material

A15. ITT Documentation means any information in any medium or form (for example drawings, handbooks, manuals, instructions, specifications and notes of pre-tender clarification meetings), issued to you, or to which you have been granted access, by the Authority for the purposes of responding to this ITT. ITT Material means any other material (including patterns and samples), equipment or software issued to you, or to which you have been granted access, by the Authority for the purposes of responding to this ITT. ITT Documentation, ITT Material and any intellectual property rights (IPR) in them shall remain the property of the Authority or other Third Party owners and is released solely for the purposes of enabling you to submit a Tender. You must:

- a. take responsibility for the safe custody of the ITT Documentation and ITT Material and for all loss and damage sustained to it while in your care;
- b. not copy or disclose the ITT Documentation or any part of it to anyone other than the bid team involved in preparing your Tender, and not use it except for the purpose of responding to this ITT;
- c. seek approval from the Authority if you need to provide access to any ITT Documentation or ITT Material to any Third Party;
- d. abide by any reasonable conditions imposed by the Authority in giving its approval under sub-paragraph A15.c, which at a minimum will require you to ensure any disclosure to a Third Party is made by you in confidence. Alternatively, due to IPR issues for example, the disclosure may be made, in confidence, directly by the Authority;
- e. accept that any further disclosure of ITT Documentation, or further use of ITT Documentation or ITT Material, without the Authority's written approval may make you liable for a claim for breach of confidence and / or infringement of IPR, a remedy which may involve a claim for compensation;
- f. immediately destroy all ITT documentation, ITT Material and derived information of an unmarked nature, should you decide not to participate in responding to this ITT, or you are notified by the Authority that your Tender has been unsuccessful; and
- g. consult the named Commercial Officer to agree the appropriate destruction process if you are in receipt of ITT Documentation and ITT Material marked 'OFFICIAL-SENSITIVE' or 'SECRET'.

A16. Some or all of the ITT Documentation and ITT Material may be subject to one or more confidentiality agreements made between you and either the Authority or a Third Party, for example a confidentiality agreement established in the form of DEFFORM 94. The obligations contained in any such agreement will be in addition to, and not derogate from, your obligations under paragraph A15 above.

Tender Expenses

A17. You will bear all costs associated with preparing and submitting your Tender. If the Tender process is terminated or amended by the Authority, the Authority will not reimburse you.

Material Change of Control from Supplier Selection

A18. You must inform the Authority in writing if there is any material change in control, composition or membership of your organisation and / or consortium members, including any sub-contractors at any time during the procurement process. This may affect your right to stay in the competition.

Conditions of Contract

A19. Standardised Contracting (SC2) Conditions are attached. These conditions are non-negotiable.

Consultation with Credit Reference Agencies

A20. The Authority may consult with credit reference agencies to assess your creditworthiness. This information may be used to support and influence decisions to enter into a contract with you.

Other Information

A21. The Tenderers' attention is drawn to the following other information:

STATEMENT OF REQUIREMENTS

GENERAL

1. This Statement of Requirement covers the replacement of the existing Electrically Driven 10/50 High Pressure Air Compressor (HPAC) and cylinder charging panel used solely in support of training equipment and delivery of training within Wyke Regis Training Area, Wyke Regis, Dorset.
2. The existing HPAC is used to supply breathing air for diver training and as such the output air must meet the standard defined by Defence Standard 68-284 Issue 3.

SCOPE

3. To replace existing electrically driven 10/50 High Pressure Air Compressor's (HPAC) with a similar or better alternative to the following specification:
 - a. **Capacity:** 300 Ltr/min (10.5 Cfm).
 - b. **Max Working Pressure:** 350 Bar (5,075 PSI).
 - c. **Motor Power:** 7.5 kW 415v 3 phase 50Hz.
 - d. **Control:** Semi Automatic (Manual push button start / auto stop via pressure switch control).
 - e. **Instrumentation:** Interstage and final stage pressure gauges.
 - f. **Condensate drain:** Automatic with integrated vent / silencer and oil/water condensate collection.
 - g. **Paint finish:** Compressor painted surfaces finished prepared in an 'Off Shore' paint system inclusive of Zinc Spray to bare metal with high build paint system top coat.
 - h. **Purification:** Final stage mechanical separator and Single tower Breathing Air purifier featuring disposable filter cartridge system.
4. To manufacture a single piece Cylinder Charging Panel to replicate existing currently in operation at Deepwater facility at Defence Diving School, Horsea Island, Cosham. The following 'Free Issue' items may be utilised:
 - a. Pressure Gauges
 - b. Isolation Valves
 - c. Stop / Vent Valves
 - d. Non-Return Valves

The charging panel for Wyke Regis training Areas should comprise the following:

- Double outlet 232 Bar charging panel including double Block and Bleed isolation valve.
- 1 off Stainless Steel panel back plate
 - Installation of new "Free Issue" Hale Hamilton isolation valves, stop/release valves and pressure relief valves onto the new panel back
 - Install new sections of 8 mm OD Stainless Steel tube and Swagelok fittings as required
 - Installation of "Free Issue" cylinder flexible charging hoses
 - Panel assembly and test to be completed Off Site
 - Installation and commissioning of panel at site
 - Leak test panel at maximum working pressure

The main components will be assembled on a Stainless Steel back plate and function and pressure tested. The panel shall feature either 2 off or 4 off flexible charging hose assemblies complete with 200 Bar DIN cylinder connectors.

5. To fabricate, supply and install a compressor sub base of Stainless Steel material to lift the replacement HPAC off the deck of the compressor room. The sub base assembly shall feature:
 - a. Single piece, welded construction, manufactured from Stainless Steel Box Section.
 - b. Suitable for mechanical fixing directly to the deck of the compressor room using securing lugs and rawl bolts.
 - c. Installation of 'Teko' Anti-vibration resilient mounting gasket between the upper face of the sub base assembly and compressor base frame.
 - d. Electrical earth bonding straps to be fitted between compressor base assembly and earth point / deck of compressor room.
6. The replacement units must be able to provide high pressure breathing air as required by Defence Standard 68-284 Issue 3.
7. To deliver, install and commission the supplied units.

Note:

 - a. The air system pipework will be isolated and the units will be electrically isolated by others. Tag-outs will be in place as required.
8. Supply installation and commissioning documentation and certification on completion.
9. Supply all operating and maintenance manuals.
10. Update existing Written Scheme of Examination (WSE 99/01/2894) to reflect changes to the High Pressure Air System.
11. Make good in wake of works any infrastructure damage and paint coatings. All waste to be removed by contractor and compressor house to left be clean on completion.
12. An UKAS Air Quality Test to be carried out on completion
13. Air Quality Test certification shall be provided to Defence Diving School on completion.

ADDITIONAL REQUIREMENTS

14. Contractor shall have ISO 9001 accreditation with a suitable scope for the work required.
15. All work shall be carried out in accordance with current Regulations & standards appertaining to the type of work undertaken.
16. The contractor shall supply all tools and lifting equipment (with current certification) and any other equipment as necessary to complete this task.
17. The whole of the work covered by this specification shall be undertaken without MoD assistance unless otherwise stated.
18. All materials required to carry out the task shall be supplied by the contractor unless otherwise stated.

HEALTH AND SAFETY

19. Prior to starting work the contractor will be required to forward the following:
- a. Risk Assessment:
It should be noted that the Risk Assessment should include the following elements
 - i. The tasks should be identified.
 - ii. All hazards should be identified
 - iii. Hazards should be eliminated where possible.
 - iv. Persons at risk should be identified.
 - v. All risks should be evaluated.
 - vi. Controls should be developed for these risks.
 - vii. The Assessment should be recorded.
 - viii. Controls should be implemented.
 - ix. The Assessment should be reviewed and monitored as necessary.
 - b. Proposed Safe System of Work / Method Statement
It should be noted that the Method Statement should include the following elements:
 - i. Details of work to be done.
 - ii. Method of doing this work
 - iii. Location of the worksite.
 - iv. Project timing and phasing.
 - v. Details of Personnel, their skills, training and competence.
 - vi. Details of equipment to be used including Maintenance procedures and records.
 - c. Copy of the company's Health and Safety Policy.
 - d. History of the Company's safety performance.
 - e. Certification and Tests of Plant and Equipment being employed.
 - f. COSHH assessments for any hazardous materials being brought and used on site.

WORKING HOURS

20. The contractor will normally be required to work within the normal working hours of the Establishment i.e. 0800-1600 Monday to Friday. Work outside of normal working hours must be agreed with Engineering Support Officer (ESO) and Base staff.

WORKSITE

21. The Worksite is to be kept clean and tidy at all times.

Notes

1. A Bidders Conference is where the Authority presents the requirement to all Tenderers at the same time. A copy of the presentation will be issued to all Tenderers regardless of attendance. It gives you an opportunity to ask questions about the requirement. The Tenderer must provide the name(s) of those attending the Bidders Conference to the above named contact, by the date shown, so that access to the site can be arranged.
2. The Tenderer must make requests for an extension in writing (email is sufficient) to the above named contact, by the date and time shown. Any extension is at the sole discretion of the Authority and if granted will be granted to all Tenderers.
3. The Authority will automatically copy questions and answers to all Tenderers, removing the names of those who have raised the questions. If you do not want your question disclosed you must inform the Authority of this and the reason why when submitting the question. The Authority may choose to discuss with you whether it is appropriate to disclose the question or response, or both, to other bidders. If the Authority decides to disclose, you will be given the opportunity to withdraw your question. Where a question reveals a piece of information that could significantly impact the Tenderers responses this may result in an extension of the Tender return date.
4. Negotiations are only permitted under the Negotiated procedures, unless the procurement is exempt from advertising under the Public Contracts Regulations 2006 or Defence and Security Public Contracts Regulations 2011.

Section C - Instructions on Preparing Tenders

Tenders for Selected Contractor Deliverables

C1. You must Tender for all the Contractor Deliverables listed in the attached Schedule of Requirements. The Authority reserves the right to reject your Tender where you have not tendered for all of the Contractor Deliverables.

Construction of Tenders

C2. Your Tender must be written in English, using Arial font size 11. Prices must be in £GBP. Prices must be Firm Price .

C3. To assist the Authority's evaluation please set out your Tender response in accordance with Section D (Tender Evaluation).

Validity

C4. In accordance with F3, your Tender must be valid / open for acceptance for 90 calendar days from the Tender return date. If successful, your Tender must be open for acceptance for a further thirty (30) calendar days.

Variant Bids

C5. You may only submit a variant bid where the Contract Notice states that variant bids will be considered (or where the requirement is exempt from the EU Regulations). A variant bid is a Tender that offers an alternative approach to, or method of, meeting the Authority's requirements as set out in the ITT Documentation. The Authority will give full and careful consideration to any permitted variant bids received. Any variant bid should, as far as possible, meet the attached Conditions of Tendering and Contract Conditions.

C6. Where variant bids are permitted, and you submit a variant bid, you are required to submit two Tenders, one against the Statement of Requirement and one variant bid. The standard Tender must meet the 'minimum' tender evaluation criteria as set out in Section D (Tender Evaluation), and must be submitted in accordance with the Conditions of Tendering. Variant bids will be evaluated in accordance with the tender evaluation criteria as set out in Section D (Tender Evaluation) and must be submitted in accordance with the Conditions of Tendering.

C7. Any Tender made subject to additional or alternative Conditions of Contract alone is not a variant bid. Where the tender evaluation has a pass / fail for the contract conditions the Authority may reject the Tender on the grounds of such additional or alternative contract conditions.

Section D – Tender Evaluation

Section E – Instructions on Submitting Tenders

Submission of your Tender

E1. Tenders must be sent to the Tender Board by the date and time stated in the covering letter to this DEFFORM 47. You must provide paper/CD copies unpriced and paper/CD copies priced copies of your Tender and copies of supporting documents. You must not email electronic copies until after the Tender Board has taken place. If you email your Tender before the Tender Board date, your Tender may be excluded from the competition.

E2. .

E3. You must complete and include DEFFORM 47 Annex A (Offer) (excluding Appendix 1) with your Tender. Where you select 'Yes' to any questions you must attach the relevant information.

E4. You must include the original signed DEFFORM 47 Annex A (Offer) with one paper copy of your Priced Tender.

E5. You must submit your paper and CD copies in a sealed envelope or box. For health and safety reasons, no individual envelope or box should weigh more than 11 kilos.

E6. You must attach the enclosed Tender Return Label (DEFFORM 28) to the outer packaging of each envelope or box that contains your Tender.

E7. If you intend to hand deliver your Tender you must inform the named Commercial Officer of your intention and seek further delivery instructions. Failure to do so may result in your Tender being refused and / or returned.

E8. You must ensure you include all relevant information in your Tender. The Authority can only evaluate information that you include in your Tender.

E9. Please provide audited evidence of your company's financial performance over the last complete accounting year.

Samples

E10. Where samples are required for evaluation purposes you must be prepared to submit them without charge. You should clearly label samples with the following particulars:

- a. your name and address;
- b. the Tender Reference Number and due date for return of the Tender; and
- c. the Description and Item Number as shown in the Schedule of Requirements.

E11. You should send any samples to the named Commercial Officer after the Tender return date.

E12. The Authority may retain all samples for twelve (12) months from the Tender return date. After this period, the Authority will destroy the samples unless you specifically state you require their return. The Authority may keep samples associated with a successful Tender indefinitely.

E13. Samples that are consumed will not be returned.

Section F – Conditions of Tendering

F1. The issue of ITT Documentation is not a commitment by the Authority to place a contract as a result of this competition or at a later stage. Any expenditure, work or effort undertaken prior to an offer of contract and acceptance of that, is a matter solely for your commercial judgement. The Authority reserves the right to:

- a. seek clarification or additional documents in respect of a Tenderer's submission;
- b. disqualify any Tenderer that does not submit a compliant Tender in accordance with the instructions in this ITT;
- c. disqualify any Tenderer that is guilty of misrepresentation in relation to its Tender, expression of interest, the dynamic Pre-Qualification Questionnaire (PQQ) or the tender process;
- d. re-assess your suitability to remain in the competition, for example where there is a material change of control from supplier selection;
- e. withdraw this ITT at any time, or to re-invite Tenders on the same or any alternative basis;
- f. choose not to award any Contract as a result of the current procurement process;
- g. award a Contract for some of the Contractor Deliverables, unless you specifically oppose this in your Tender or state any minimum order quantities; and/or
- h. ask for a price breakdown where the Tender price is low.

F2. The contract will be entered into when the Authority sends written notification of its entry into the Contract. Written notification will be issued, to the address you provide, on or before the expiration of the period specified in paragraph C4 and subject to paragraph F3.

F3. It is a Condition of Tendering that the winning Tenderer holds their Tender open for acceptance for the period stated in C4. This period starts on the day the Authority announces its decision to award the contract to the winning Tenderer in accordance with the Tender. In the event that legal proceedings challenging the award of the contract are instituted, prior to entry into contract, it is a condition of this ITT that you hold your Tender open for acceptance during this period, and up to fourteen (14) days after the result of the legal proceedings. In the event of such legal challenge, the Authority agrees to use all reasonable measures to accelerate proceedings.

Conforming to the Law

F4. You must comply with the UK Competition Act 1998, the UK Bribery Act 2010, applicable EU and UK legislation and any equivalent legislation in a third state.

F5. Your attention is drawn in particular to legislation relating to the canvassing of a public official, collusive behaviour and bribery. If you act in breach of this legislation then your Tender may be disqualified from this procurement. Disqualification will be without prejudice to any civil remedy available to the Authority or any criminal liability that your conduct may attract.

Bid Rigging and Other Illegal Practices

F6. You must report any bid rigging, fraud, bribery, corruption, or any other dishonest irregularity in connection to this tendering exercise to:

Conflicts of Interest

F7. You must notify the Authority immediately of any Conflicts of Interest (COI) that have arisen or that arise at any point prior to contract award decision.

- F8. Where there is an existing or potential Conflict of Interest (COI) you must include a proposed Compliance Regime in your Tender. As a minimum this must include:
- a. manner of operation and management;
 - b. roles and responsibilities;
 - c. standards for integrity and fair dealing;
 - d. levels of access to and protection of competitors sensitive information and Government Furnished Information;
 - e. confidentiality / non-disclosure agreements (e.g. DEFFORM 702);
 - f. the Authority's rights of audit; and
 - g. physical and managerial separation.

Should your Tender be accepted your proposed Compliance Regime will become part of the Contract Conditions and shall be legally binding.

Government Furnished Assets

F9. Where the Authority provides Government Furnished Assets (GFA) in support of this competition, you must include details of the GFA in your Public Store Account and treat it in accordance with Def Stan 05-99. If unsuccessful in this competition, you must seek disposal instructions for that GFA from the named Commercial Officer.

Standstill Period

F10. The Authority is obliged under certain circumstances to allow a space of ten (10) calendar days between the date of dispatch of its notice to Tenderers before entering into a contract, known as the standstill period. This period is to give unsuccessful Tenderers an opportunity to make a legal challenge before the contract is entered into if there has been, or it is alleged that there has been, a breach of the Regulations. The standstill period ends at midnight at the end of the 10th day after the date the DEFFORM 158 is sent. Where this is not a working day it extends to midnight of the next working day.

Publicity Announcement

F11. The Authority will publish notification of the contract and may publish contract documents under the FOI Act except where publishing such information would hinder law enforcement; would otherwise be contrary to the public interest; would prejudice the legitimate commercial interest of any person, or might prejudice fair competition between suppliers. You should complete and return DEFFORM 539A as explained in the DEFFORM 47 Annex A and associated Appendix 1.

F12. If you wish to make a similar announcement, you must seek approval from the named Commercial Officer.

F13. Under no circumstances should you confirm to any Third Party the Authority's acceptance of an offer of contract prior to either informing the Authority of your acceptance or the Authority's announcement of the award of contract, whichever occurs first.

Sensitive Information

F14. All Central Government Departments and their Executive Agencies and Non Departmental Public Bodies are subject to control and reporting within Government. In particular, they report to the Cabinet Office and HM Treasury for all expenditure. Further, the Cabinet Office has a cross-governmental role delivering overall Government policy on public procurement, including ensuring value for money and related aspects of good procurement practice.

F15. For these purposes, the Authority may share within Government any of the Contractor's documentation / information (including any that the Contractor considers to be confidential and/or commercially sensitive such as specific bid information) submitted by the Contractor to the Authority during this Procurement. Contractors taking part in this competition must identify any sensitive material in the DEFFORM 539A and consent to these terms as part of the competition

process. This allows the MOD to share information with other Government departments whilst complying with our obligations to maintain confidentiality.

Remedies for Breach of Contract

F16. You should be aware of the contractual remedies set out in SC2 Conditions of Contract F.6.a. which may apply in the event of a breach of contract by the Contractor. Damages for breach of contract are not limited under the contract.
