Section 4 – Specification and about this procurement

National Oceanography Centre (NOC) has several requirements to refurbish & redecorate the existing window facades, especially those located on the quayside of the Southampton site. The previous redecoration of the windows was undertaken in 2011 and during a site condition survey undertaken by NOC in 2016, the recommendation for further redecoration works was raised.

The works will be managed as a design and build project and must be fully completed by 23 March 2018.

INTRODUCTION

National Oceanography Centre (NOC) has several requirements to refurbish & redecorate the existing window facades, especially those located on the quayside of the Southampton site. The previous redecoration of the windows was undertaken in 2011 and during a site condition survey undertaken by NOC in 2016, the recommendation for further redecoration works was raised.

There are more than 900 double glazed windows on site that require redecoration, mastic joint repairs & replacement of the double glazed units (as applicable). The tender seeks unit prices for the services as described, a decision will be made based on affordability of the number of windows that will be redecorated, have mastic joint repair work and those that will be replaced. Further details duly noted below in the scope.

OBJECTIVES

The work requirements will be managed as a design & build project. This is to avail the services of a contractor who shall also undertake the responsibilities of the Principal Designer in order to facilitate the completion of this project as per the requirements of CDM 2015.

The primary objectives of the project is to attain unit prices for the following requirements –

- Painting & Redecoration of more than 900 external windows (please note exact number to be redecorated will be based on assessment of affordability), which are divided into 4 x types as stated below, within the defined areas.
- Undertake mastic joints repair of the windows as required and stated in the schedule.
- Undertake a review of the existing double glazed units located across site within the defined locations on site.
- Include for all associated costs & parts of project requirements for completion, eg. Window replacement, ironmongery, sealants, access equipment.

Responsibilities

- The Principal Contractor would be required to provide a project specific scope of works after contract award, in accordance with the design & build criteria of the project. This may also include obtaining information from the client as required.

- Within the role of Principal Designer, you would be required to liaise with the client and all contractor personnel to ensure EH&S management on site and ensure information flow between the contractor (& sub-contractor) personnel & the client.
- Principal Contractor must ensure that they carry a valid Public Liability insurance certification of £10,000,000.00 and professional indemnity certificate of £5,000,000.00 to operate on NOCS site.
- The project shall follow the CDM2015 regulations and NEC3 Engineering and Construction Short Contract (ECSC) – June 2005 contract terms & conditions.
- Once a Purchase Order has been issued, the contractor is required to submit a detailed and coordinated construction works package, programme and a construction phase plan.
- The contractor will liaise closely with NOC Estates who will coordinate with the building users likely to be affected by the project works, especially in the quayside working areas & offices.
- Appointment of Sub-Contractors (if necessary) - The Principal Contractor is responsible for the appointment of sub-contractors as necessary to fulfil the Scope.

Site Specific Terms of Responsibility –

- Ensure NOC Estates Permit Systems (if applicable), are followed by the Principal contractor and sub-contractor personnel.
- Ensure a thorough inspection of all overlapping systems which might have an impact due to the project commencing on site.
- Weekly meetings to ensure project update which would include taking minutes and site inspection during construction period.
- As the client, NOC is required to ensure all Long Term Maintenance/Capital projects include sustainability procurement within the scope of works, which implies that the market has been tested to provide sustainable options for (all) products, with a focus on whole life costs for long-term utility, energy consumption and waste production. All paint used to be low Volatile Organic Compound (VOC requirements) unless agreed otherwise with the client.
- Contractor to also ensure the NOCS Site Waste Management Plan (as Appendix B) is completed and is part of contractor O&M handover information.

APPROACH

The scope of works for the Principal Contractor as part of this design & build project would include the following requirements –

- Attend site and meet with the client to discuss the project in detail.
- Provide a phased programme for the project works.
- Suggest any necessary pre-requisites for programme and design criteria finalisation - before issue of construction phase plan & contractor works commencement. Ensure sign-off from the client.

- To include and allow for remedial decoration/ make good of the building fabric during completion of works.
- Overview project until completion (Minimum one visit to site per week for on site programme).
- Produce an initial snagging list for each plate area section where works have been completed, as demarcated in the scope before handover.
- Agree sign-off on documents for inclusion in Maintenance Manual and Health & Safety File.
- Undertake defects rectification during the defects liability period (three visits to be included).
- Undertake the role of Principal Designer as detailed under the CDM Regulation 2015.
- Liaising with building controls you would be required to ensure compliance under BS9990:2015, BS9999:2017; Regulatory Reform (Fire Safety) Order 2005; as well as industry guidelines such as ASFP guidelines and recommendations, which is available for review by the public, consultants and contractors. Any certifications on the project would require review & compliance under these guidelines. Any fire control dampers and associated products installed within the project - as part of passive fire protection measures, have to be compiled in the O&M handover documentation to be handed over top NOC Estates.
- As part of the Tender Process -Tenderers are given the opportunity to attend an site visit. This will consist of a conducted tour around the site, the work areas and the access to and from reception. The date for the site visit is 06 November 2017. Bidders are required to message via the e-sourcing system in order to secure a place. There will be a limit of two representatives per tenderer.

As part of the design & build project, the Principal Designers duties shall include-

- Notify details of the project to HSE where applicable
- Co-ordinate health and safety aspects of the design work and cooperate with others involved with the project inclusive of:
 - Client liaison to establish the existing hazards
 - Detail hazards associated with the works
 - Undertake a risk assessment
 - Facilitate good communication between the client and the contractors
 - Prepare and issue pre-construction information
 - Ensure there are suitable management arrangements for the project welfare facilities
 - Ensure information relating to the Construction Phase Health and Safety Plan is made available
 - Ensure the Health and Safety File is made available at the end of the works.


SCOPE

Unit prices are requested for the following:

- Painting & redecoration of all windows, on all levels, located on the quay side of NOC Southampton Site
- Painting & redecoration of all windows, on all levels, located between node 4 & node 7 – near the A1 & A3 building.
- Painting & redecoration of all windows on level 1 of the internal courtyards.

(Please refer to Appendix C & D)

The windows installed on site have been divided into four types, bidders are required to provide unit prices for each window style.



The works shall include -

- Supply & application of low VOC Paint, Sealant & Primer colour to match existing building standards. All products must be low VOC and suitable for marine environment. Contractor to provide the paint and associated products as part of the project works. The Contractor is required to follow manufacturer's guidelines & instructions for redecoration of the windows.
- Bead replacement per linear metre – supply materials & labour costs
- Filling per linear metre - supply materials & labour costs
- Silicone sealants per linear metre (as applicable) – supply materials & labour costs

- Costs for access equipment throughout the duration of the project, to safely carry out the works.
- Costs for a heated and suitable ventilation containerised storage space to paint the windows on site (as per the manufacturer's guidelines to ensure recommended drying time). A compound space for container storage will be provided by the client.
- Supply & install ironmongery where window replacements are agreed (hinges, brackets, handles) – In order to maintain building standards, colour & finishing must match existing ironmongery installed on site.
- Allow costs for disconnecting & re-instating alarm sensors for cabling (as applicable) per window costs.
- Costs for repair of mastic joints (per unit price for each window type) – aperture to aperture joints at all external locations around the windows.
- Allow for review of all double glazed windows in the areas falling within the scope of works; namely quayside, node 4 to node 7 & the internal courtyards lvs 1 (Please refer to Appendix C & D)
- Recommend replacement options to the client for windows that have suspected vacuum breach, leaks, condensation, cracks or apparent draught conditions seeping through the windows and/or window frames.
- Supply & install temporary Perspex screen into the window opening to stop the resulting draught whilst project works are ongoing.

Schedule of Works

- Remove all opening sash windows to be painted in heated container in a phased manner to reduce heat loss from the building and discomfort to building users.
- Supply and install temporary Perspex screen into opening to stop the draught. Please note that this could compromise the security of the building if the paint does not dry within the recommended time. Contractor required to update the client with a list of all ground floor windows and their programmed phase of works.
- Prepare and decorate the window frames as per specification & manufacturer's guidelines.
- Undertake mastic joint repairs.
- Decorate the sash windows in the heated container.
- Undertake installation of new ironmongery as required.
- Reinstating the opening sashes into position and make sure is operating correctly.
- Review the double glazed windows in the area and report findings to the client.
- To incorporate thermal validation as part of project works, to ensure window installation has been undertaken correctly.

Redecoration Requirement –

- Topcoats Colour - Blue Green – colour & finishing must match existing (current

paint is 'Tecknos' paint, specification of paint to be supplied and utilised must match this specification or equivalent).

- Suitable end grain sealer – colour & finishing must match existing
 - Primer – colour & finishing must match existing
 - Window Ironmongery – colour & finishing must match existing (current ironmongery is provided by 'Granthaze' specification of ironmongery to be supplied and utilised must match as provided by this supplier or equivalent).
 - Include details for any structural sealing joint profile and the associated physical properties requirements as part of project completion.

- Note the requirements for any fabrication & discuss the same with NOC Estates.

CONSTRAINTS

All works shall be completed by 23rd March 2018.

It is thereby the duty of the principal contractor to ensure that the availability of site and manufacturer lead times are considered when offering the best value solution as part of the tender package. You will also need to suggest recommended timeframes for access to each phase of works as part of your programme.

DEPENDENCIES

Project end date is 23rd Mar 2018, which has several dependencies due to concurrent projects running on site.

Please note - Any envisaged delay or impact on the programme will be deliberated jointly between the Principal Contractor and the NOCS Project Manager, to ensure minimal cascade effect on overall completion of works.

Principal Designer to allow 2 working days notice to the NOC Project Manager for Return and Flow of Information, before any issue of Early Warning Notices or programme slippage.

Principal Contractor to liaise with the client to agree upon a Meeting Agenda, Project Handover and O&M Handover template(s).

Section 5 – Evaluation model

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Example

Evaluator 1 scored your bid as 60

Evaluator 2 scored your bid as 40

Evaluator 3 scored your bid as 80

Evaluator 4 scored your bid as 60

Your final score will $(60+40+80+60) \div 4 = 60$

Price elements will be judged on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the price criterion.

For example - Bid 1 £100,000 scores 100.

Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80

Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.

Bid 4 £175,000 differential £75,000 remove 75% from price scores 25.

Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.

Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 $(80/100 \times 50 = 40)$

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

7.1. Introduction

- 7.1.2 The Contracting Authority is procuring the Contract for add for its exclusive use.
- 7.1.3 UK SBS and the Contracting Authority logo, trademarks and other identifying marks are proprietary and may not be incorporated in the Companies response without or the Contracting Authority’s written permission.
- 7.1.4 The Bidder shall indemnify and keep indemnified UK SBS and the Contracting Authority against all actions, claims, demands, proceedings, damages, costs, losses, charges and expenses whatsoever in respect of any breach by the Bidder of this document.
- 7.1.5 If there is any doubt with regard to the ambiguity of any question or content contained in this questionnaire then PLEASE ASK a clarification question, but please ensure that your question is via the formal clarification process in writing to the UK SBS representative nominated. No approach of any kind in connection with this opportunity should be made to any other person within, or associated with UK SBS or the Contracting Authority. All information secured outside of this named contact shall have no legal standing or worth and should not be relied upon.
- 7.1.6 It remains the responsibility of the Bidder to keep UK SBS and the Contracting Authority informed of any matter that may affect continued qualification
- 7.1.7 Prior to commencing formal evaluation, Submitted Responses will be checked to ensure they are fully compliant with the Pass / Fail criteria within the Evaluation model. - 7.1.10 The Contracting Authority reserves the right not to conclude a Contract as a result of the current procurement process. Bidders should review the contents of Section 7 paragraph 7.8.1 when considering submitting their Response.
- 7.1.11 The works covered by this procurement exercise have NOT been sub-divided into Lots.

There will be no electronic auction following the conclusion of the evaluation of the Request for Proposal (RFP) responses. - 7.1.14 Bidders should read this document, RFx attachments, messages and the evaluation questionnaires carefully before completing the Response submission. Failure to comply with any of these instructions for completion and submission of the Submitted Response may result in the rejection of the Response. Bidders are advised therefore to acquaint themselves fully with the extent and nature of the goods/services/goods and services and contractual obligations. These instructions constitute the Conditions of Response. Participation in the RFP process automatically signals that the Bidder accepts these Conditions.
- 7.1.15 All material issued in connection with this RFP shall remain the property of the Contracting Authority and/or as applicable relevant OPB and shall be used only for the purpose of this procurement. - 7.1.16 The Bidder shall ensure that each and every sub-contractor, consortium member and adviser abides by the terms of these instructions and the Conditions of Response.
- 7.1.17 The Bidder shall not make contact with any other employee, agent or consultant of UK SBS or the Contracting Authority or any relevant OPB or Customer who are in any way connected with this procurement during the period of this procurement, unless instructed otherwise by the Contracting Authority.
- 7.1.18 The Contracting Authority shall not be committed to any course of action as a result of:
- 7.1.18.1 issuing this RFP or any invitation to participate in this procurement;

- 7.1.18.3 communicating with a Bidder or a Bidder's representatives or agents in respect of this procurement; or

- 7.1.20 The Contracting Authority reserves the right to amend, add to or withdraw all or any part of this RFP at any time during the procurement.
- 7.1.21 Bidders should not include in the Response any extraneous information which has not been specifically requested in the RFP including, for example, any sales literature, standard terms of trading etc. Any such information not requested but provided by the Bidder shall not be considered by the Contracting Authority.
- 7.1.22 If the Bidder is a consortium, the following information must be provided: full details of the consortium; and the information sought in this RFP in respect of each of the consortium's constituent members as part of a single composite response.  - 7.3.1.1 Bidders shall at all times treat the contents of the RFP and any related documents (together called the 'Information') as confidential, save in so far as they are already in the public domain;
 - 7.3.1.2 Bidders shall not disclose, copy, reproduce, distribute or pass any of the Information to any other person at any time or allow any of these things to happen;

- 7.3.1.3 Bidders shall not use any of the Information for any purpose other than for the purposes of submitting (or deciding whether to submit) a Response; and
- 7.3.1.4 Bidders shall not undertake any publicity activity within any section of the media in relation to this procurement
- 7.3.2 Bidders may disclose, distribute or pass any of the Information to the Bidder's advisers, sub-contractors or to another person provided that either:
 - 7.3.2.1 This is done for the sole purpose of enabling a Response to be submitted and the person receiving the Information undertakes in writing to keep the Information confidential on the same terms as if that person were the Bidder; or
 - 7.3.2.2 The disclosure is made for the sole purpose of obtaining legal advice from external lawyers in relation to the procurement or to any Contract arising from it; or
 - 7.3.2.3 The Bidder is legally required to make such a disclosure
- 7.3.3 In paragraphs 7.3.1 and 7.3.2 above the term 'person' includes but is not limited to any person, firm, body or association, corporate or incorporate.
- 7.3.4 UK SBS and the Contracting Authority may disclose detailed information relating to Responses to its employees, agents or advisers and they may make any of the Contract documents available for private inspection by its officers, employees, agents or advisers. UK SBS and the Contracting Authority also reserve the right to disseminate information that is materially relevant to the procurement to all Bidders, even if the information has only been requested by one Bidder, subject to the duty to protect each Bidder's commercial confidentiality in relation to its Response (unless there is a requirement for disclosure as explained in paragraphs 7.4.1 to 7.4.3 below).

- 7.3.7 The Contracting Authority reserves the right to amend any security related term or condition of the draft contract accompanying this RFP to reflect any changes introduced by the GSC. In particular where this RFP is accompanied by any instructions on safeguarding classified information (e.g. a Security Aspects Letter) as a result of any changes stemming from the new GSC, whether in respect of the applicable protective marking scheme, specific protective markings given, the aspects to which any protective marking applies or otherwise. This may relate to the instructions on safeguarding classified information (e.g. a Security Aspects Letter) as they apply to the procurement as they apply to the procurement process and/or any contracts awarded to you as a result of the procurement process.

7.4 Freedom of information

7.7.1 Unless stated otherwise in these Instructions or in writing from UK SBS or the Contracting Authority, all communications from Bidders (including their sub-contractors, consortium members, consultants and advisers) during the period of this procurement must be directed through the e-sourcing tool to the designated UK SBS contact.

7.7.2 All enquiries with respect to access to the e-sourcing tool may be submitted to Crown Commercial Service, Telephone 0345 010 3503.

7.7.3 Bidders should be mindful that the designated Contact should not under any circumstances be sent a copy of their Response outside of the e-sourcing tool. Failure to follow this requirement will result in disqualification of the Response.

7.8. Preparation of a Response

7.8.1 Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. Bidders are solely responsible for all costs, expenses and other liabilities arising in connection with the preparation and submission of their Response and all other stages of the selection and evaluation process. Under no circumstances will UK SBS or the Contracting Authority, or any of their advisers, be liable for any such costs, expenses or liabilities borne by Bidders or their sub-contractors, suppliers or advisers in this process.

7.8.2 Bidders are required to complete and provide all information required by the Contracting Authority in accordance with the Conditions of Response and the Request for Proposal. Failure to comply with the Conditions and the Request for Proposal may lead the Contracting Authority to reject a Response.

7.8.3 The Contracting Authority relies on Bidders' own analysis and review of information provided. Consequently, Bidders are solely responsible for obtaining the information which they consider is necessary in order to make decisions regarding the content of their Responses and to undertake any investigations they consider necessary in order to verify any information provided to them during the procurement.

7.8.4 Bidders must form their own opinions, making such investigations and taking such advice (including professional advice) as is appropriate, regarding their Responses, without reliance upon any opinion or other information provided by the Contracting Authority or their advisers and representatives. - 7.9.3 Any extension to the RFP response period will apply to all Bidders.

- 7.9.4 Any financial data provided must be submitted in or converted into pounds sterling. Where official documents include financial data in a foreign currency, a sterling equivalent must be provided. Failure to adhere to this requirement will result in the Response not being considered.

- 7.9.5 and the Contracting Authority do not accept responsibility for the premature opening or mishandling of Responses that are not submitted in accordance with the instructions of this document.

- 7.9.6 The Response and any documents accompanying it must be in the English language

- 7.9.7 Bidders must submit their response through the e-sourcing tool:

- 7.9.8 Responses will be submitted any time up to the date indicated in [Section 3](#). Responses received before this deadline will be retained in a secure environment, unopened until this deadline has passed.

- 7.9.9 Responses received after the date indicated in [Section 3](#) shall not be considered by the Contracting Authority unless the Bidder can justify the reason for the delay.

7.9.9.1 The Bidder must demonstrate irrefutable evidence in writing they have made best endeavours to ensure the Response was received on time and that the issue was beyond their control.

7.9.9.2 Any request for a late Response to be considered must be emailed to bids@uksbs.co.uk in advance of 'the deadline' if a bidder believes their Response will be received late.

7.9.9.3 The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.

7.10. Canvassing

- 7.10.1 Any Bidder who directly or indirectly canvasses any employee, or agent of UK SBS, the Contracting Authority or its members or any relevant OPB or any of its employees concerning the establishment of the Contract or who directly or indirectly obtains or

attempts to obtain information from any such officer, member, employee or agent or concerning any other Bidder, Response or proposed Response will be disqualified.

7.11. Disclaimers

7.11.1 Whilst the information in this RFP, Due Diligence Information and supporting documents has been prepared in good faith, it does not purport to be comprehensive nor has it been independently verified.

7.11.2 Neither UK SBS, the Contracting Authority, nor any relevant OPB's nor their advisors, nor their respective directors, officers, members, partners, employees, other staff or agents:

7.11.2.1 makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or

7.11.2.2 accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.

7.11.3 Any persons considering making a decision to enter into contractual relationships with the Contracting Authority and/or, as applicable, relevant OPB following receipt of the RFP should make their own investigations and their own independent assessment of the Contracting Authority and/or, as applicable, relevant OPB and its requirements for the goods/services/goods and services and should seek their own professional financial and legal advice. 7.12.1.3 enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or

7.12.1.4 enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or

7.12.1.5 offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be

done in relation to any other Response or proposed Response, any act or omission,

shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.14.1 The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within **5 days** of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.

7.14.2 The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

7.15.1 All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Emptoris or Crown Commercial Service system maintenance or failure when a clarification by email to the contact defined in [Section 3](#).

7.15.2 The Contracting Authority will endeavour to answer all questions as quickly as possible, but cannot guarantee a minimum response time.

7.15.3 In the event of a Bidder requiring assistance uploading a clarification to the e-sourcing portal they should use the contact details defined in [Section 3](#).

7.15.4 No further requests for clarifications will be accepted after 5 days prior to the date for submission of Responses.

7.15.5 In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.

7.15.6 Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:

7.15.6.1 invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or

7.15.6.2 request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.

7.15.7 The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

7.16.1 At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

7.17.1 Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.

7.17.2 Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to UK SBS at UK Shared Business Services Ltd, Procurement Policy Manager, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

7.18.1 The Contracting Authority reserves the right to reject or disqualify a Bidder where

7.18.1.1 the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or

7.18.1.2 the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or

7.18.1.3 there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

7.19.1 The Contracting Authority reserves the right to:

7.19.1.1 cancel the evaluation process at any stage; and/or

7.19.1.2 require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20.. Notification of award

7.20.1 The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union

in accordance with the Regulations within 30 days of the award of the contract.

7.20.2 As required by the Regulations all unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.
