DFID Kenya – Delivering Increased Family Planning Across Rural Kenya

Terms of Reference – Procurement of Family Planning Commodities Procurement Agent – Charles Kendall and Partners Ltd Supplier ID 11392

Introduction

1. The United Kingdom's Department for International Development (DFID) is supporting the Government of Kenya's (GOK) efforts towards attaining the country's development goals. DFID's investments in health are primarily targeted at strengthening health systems, preventing malaria and HIV, and improving reproductive health.

DFID is implementing a family planning programme (from 2013 - 2017) aimed at increasing family planning uptake in Kenya. The outcome of the programme will be an increased contraceptive prevalence rate. The impact will be to reduce maternal and newborn deaths. The goal of the programme is to increase uptake of Family Planning (FP) service with specific emphasis on reaching rural women and to increase the proportion of young adolescent girls served (age 15-19 years). This programme will support both public and private sector interventions (which includes services provided by non-governmental organisations).

DFID Kenya is seeking the services of DFID's assigned procurement agent to deliver output 5 of this programme - procurement of family planning commodities.

Objective

2. DFID Kenya's procurement agent, Charles Kendall and Partners Limited (CKP), is to procure family planning commodities at a total cost of up to £1,628,000, excluding procurement agent fees and logistics costs. A complete schedule of prices is on Annex 1.

Recipient

3. The primary recipients of the family planning commodities are the Government of Kenya – Reproductive and Maternal Health Services Unit (RMHSU), through DFID Kenya. Population Services Kenya (PS/K) will be responsible for storage and onward distribution of the commodities.

Scope of Work

- <u>CKP will procure 291,000 pieces of implanon NXT and provide the full range of services associated with the procurement of the commodities, to remove the procurement burden from DFID Kenya and partners. This will include, but is not limited to:</u>
- arranging purchasing of the 291,000 pieces of NXT implanon,

- Direct communication with suppliers (including with clearing agents), on behalf of DFID.
- expediting, shipping, insurance and customs clearance of the goods in accordance with DFID guidelines
- Delivery to PS/K Warehouses in Nairobi.
- Quality assurance and inspection to check that the commodities are free of defects.
- Management of all suppliers/service providers contracts and reviewing and issuing supplier/service provider payments.
- Participation in the National Contraceptive Security Committee1 by joining the committee and sharing the DFID family planning commodity procurement plans
- Safe keeping of all original documents related to the procurement, and handing them over to DFID by the end of the contract.

Requirements

- 5. CKP will
- Undertake all sourcing as per the terms and conditions of framework agreement 4448/5758 with DFID.
- Ensure that the goods are delivered to the specified address, at the earliest opportunity after the start of the contract (an anticipated date will be provided at the time of providing the Instruction to Proceed) and that they are in the specified quantities² and of good quality in line with the Technical Specifications for Implanon NXT attached as Annex 2, and DFID's Reproductive Health Quality Policy, attached as Annex 3.
- Contract with the supplier with the appropriate Incoterms to ensure that they maintain responsibility of the goods until they are delivered at the PS/K warehouse.

Performance requirements

- 6. CKP will
 - a. Undertake clarification work in order to ensure that the ToR/Goods specification is clear, complete and suitable for the purpose of the procurement
 - b. provide a draft service level agreement which details the procurement plan, shipment schedules, schedule of prices, communications, approval and reporting arrangements to facilitate performance management.
 - c. submit a risk matrix to DFID detailing the possible risks to the procurement process and mitigating actions. The risk matrix will be updated quarterly until the end of the contract.
- 7. CKP will also:

- be proactive in communicating any potential late deliveries, putting in place remedial solutions in order for these deliveries not to impact the rest of the project.
- Where applicable, give advice on the most economical and expedient procurement procedures available
- Familiarise with local customs clearance and tax waiver procedures, and ensure suppliers/service providers are familiar with the same and carry out all processes efficiently. DFID will provide any necessary documentation to enable duty & tax free Customs clearance.
- Unless subsequently advised otherwise by DFID K, instruct the supplier to invoice RDL charges and provide CKP with the original RDL payment documents to enable DFID K to process an RDL refund from the Kenyan Government. CKP will advise DFID K, at the time of presenting the Instruction to Proceed, if the supplier is unable to provide this documentation.
- Demonstrate efforts to maximise cost savings and Value for Money in the procurement process
- Ensure the right staff with the right commercial and interpersonal skills manage the procurement on behalf of CKP
- Demonstrate flexibility and a willingness to adapt to unforeseen circumstances. As and when necessary, CKP will present to DFID Kenya a variety of considered solutions to programmatic and management challenges, identifying the advantages and disadvantages of each option, for final decision making.
- 8. At any stage during the procurement if the goods are found not to be conforming to the product specifications, the contractor shall be liable to replacement with goods acceptable to DFID and RMHSU.

Financial Management

- 9. Payments will be linked to commodity deliveries to PS Kenya. 100% of the value of the shipment will be payable upon satisfactory receipt at the PS/K warehouse. (Should the supplier reject these payment terms CKP will negotiate the most advantageous for DFID and seek their approval before proceeding). CKP fees will be 3.5% of the value of the procured items.
- 10. In accordance to the Overarching Framework Agreement 4448/5758, any procurement which is subject to the EU Directives will be subject to the minimum timescales set out under the relevant EU procedure. The procurement agent will place a Prior Indicative Notice in OJEU wherever possible in order to reduce the minimum timescales. Where the EU Directives do not apply, and unless agreed otherwise at the project conception stage and stated in the procurement plan, response times for key procurement activities against which the agents' performance shall be measured as follows:

- 12. The report shall also include detailed work plans for the next month and expected deliverables to be achieved within the month.

13. CK will be contracted for a period commencing not later than 15 April 2015, with the indicative delivery date of 31 July 2015.
