This Contract is made between:

The **HEALTH AND SAFETY EXECUTIVE** (acting as part of the Crown) of Redgrave Court, Merton Road, Bootle, Merseyside, L20 7HS (hereinafter called 'the HSE' of the one part) and

NPIS EDINBURGH, whose registered office is at Royal Infirmary of Edinburgh, 51 Little France Crescent, Edinburgh, EH16 4SA (hereinafter 'the Contractor' of the other part), in accordance with the details, terms and conditions stated herein.

WHEREAS

The Contractor was successful as a result of a quotation exercise to deliver a UKwide Monitoring Scheme for ill health incidents related to pesticides and biocides

1 GENERAL CONDITIONS

1.1 This Contract will be subject to the Terms and Conditions stated herein. The Clauses in this Contract will also govern all Purchase Orders placed against this Contract.

2 ENTIRE AGREEMENT

2.1 This contract constitutes the entire agreement and understanding between the parties concerning the subject matter hereof and supersedes all prior agreements, both oral and written, representations, statements, negotiations and undertakings.

3 STATEMENT OF SERVICE REQUIREMENTS

- 3.1 The Contractor will carry out on behalf of the HSE a Statement of Services (hereinafter called the "Services") as detailed in Schedule A to this Contract.
- 3.2 The Contractor shall organise and conduct the entire Services in consultation with the HSE where appropriate, and provide all necessary resources of personnel, materials, services and equipment, except for such resources that may be provided by the HSE at its discretion.
- 3.3 No undertaking shall be deemed to have been made by the HSE in respect of the total quantities or values of the services to be ordered pursuant to this contract and the Contractor acknowledges and agrees that it has not entered into this contract on the basis of any such undertaking.

4 MANAGEMENT OF THE CONTRACT

4.1 The Contract Managers responsible for liaison and delivery of the services are identified at Annex 1.

5 DURATION

5.1 The Services shall commence on 01 April 2018 and shall be completed by 31 March 2021, with the option to extend up to a maximum of 2 years, in yearly increments.

6 COSTS

6.1 The total amount to be paid by the HSE to the Contractor for the services shall not exceed £299,704.00, exclusive of VAT, broken down as follows:

6.2 Any additional costs will be agreed in advance and in writing with the HSE Contract Manager and subject to clause 9 Variation to Contract.

7 INVOICING AND PAYMENTS

7.1 All invoices raised <u>must</u> include the relevant Purchase Order number which will be issued by HSE Commercial Services. Failure to include the Purchase Order Number may delay payment. Invoices should be submitted electronically in pdf format to the following address:

- 7.2 The Contractor shall send a copy invoice along with details of any work satisfactory carried out to the HSE Contract Manager identified at Annex 1.
- 7.3 Invoices should also include details of work satisfactorily carried out and any VAT properly chargeable.
- 7.4 Shared Services shall make payment of agreed costs, in arrears, within 30 days of the acceptance of the invoice.

8 DELIVERABLES

8.1 The Contractor shall provide a UK-wide Monitoring Scheme for ill health incidents related to pesticides and biocides.

9 VARIATION TO CONTRACT

- 9.1 Except where expressly stated in this contract, no change, amendment or modification shall be effective unless in writing and signed by the duly authorised representatives of both parties.
- 9.2 Any agreed changes to the Contract or Schedule A (Statement of Service Requirement) will be in the form of a Contract Change Note (CCN), which will be raised and issued by the HSE Commercial Services.
