## **Background**

At Salisbury District Hospital (SDH), Salisbury NHS Foundation Trust provides a range of clinical care, which includes general acute and emergency services, to approximately 225,000 people in Wiltshire, Dorset and Hampshire. Specialist services, such as burns, plastic surgery, cleft lip and palate, genetics and rehabilitation, extend to a much wider population of more than three million people. Trust staff provide outpatient clinics in other locations in Dorset and Hampshire. Specialist staff hold outreach clinics in hospitals within the Wessex area and, in total, the Trust employed 3,890 staff at 30 September 2014. This includes full and part-time staff.

## **This Procurement**

Block 29 (Occupational Health) is one of the older single storey buildings now used for administration functions. It is planned to replace a number of the windows within this facility in accordance with the Specification listed below.

## **Specification and Requirements**

### **Occupational Health, Block 29.**

#### **Scope of works.**

To replace existing aluminium windows set in wood frames with new white PVCu windows.

To replace existing doors with new aluminium and PVCu doors.

#### **WINDOWS**

All new windows to be “A” rated PVCu frames and “A” rated double glazed units, argon gas filled with a warm edge spacer to give an 'A' rated insulation value.

All glazing beads to be chamfered finish.

Cover strips to be fitted to internal reveals.

#### **Style A.**

Top hung sash above transom.

All units to be clear glass.

Size W 900mm x H 1175mm, transom height to match existing PVCu windows.

Located on drawing as No's 11,12,13,14,15,16,20,21,23,24,25,26.

#### **Style B.**

1 x side hung sash, 1 x top hung sash above transom, 1 x fixed pane below transom.

All units to be clear glass.

Size W 1800mm x H 1175mm, transom height to match existing PVCu windows.

Located on drawing as No's 4,5,6,7,8,17,18,19,22.

### **Style C.**

Top hung sash.

Units to be obscure glass.

Size W 900mm x H 930mm.

Located on drawing as No's 1,2,3,9,10.

### **Doors**

All doors to be "A" rated frames and DGU's to be as per window spec "A" rated.

All glazing beads to be chamfered finish.

Cover strips to be fitted to internal reveals.

### **Style D.**

White Aluminium frame with low threshold

Top sash above transom, fixed pane. L/H side screen flush bolted. R/H door, opening out with door closer.

Lock to be supplied by Guardian Security and fitted at manufacturing stage.

All units to be clear glass.

Size W 1880 x H 2500mm.

Located on drawing as D.

### **Style E.**

White PVCu frame with low threshold.

Single door with fixed side screen and above transom fixed sash.

All units to be clear glass.

Deadlock with euro cylinder key/ thumbturn

Size W 1500mm x H 2500mm.

Located on drawing as E.

**Style F.**

White Aluminium frame with low threshold.

Single door with fixed side screen and above transom fixed sash.

All units to be clear glass.

Lock to be supplied by Guardian Security and fitted at manufacturing stage.

Size W 1925mm x H 2500mm.

**Located on drawing as F.**

**Existing Salto locks to be set aside for reuse and handed to ETS Project Officer.**

**PLEASE NOTE all sizes are approximate, site measurement is required.**

**Each room to be left clean and tidy after each installation.**

**All rubbish and unwanted materials to be cleared from site on completion of the contract.**

**To be read in conjunction with document FE1035 Replacement Windows Block 29 Style & Location Drawing.**
