

# Annex to EdTech ToR – May 2020

## Background

1. A contract amendment is required to bring the EdTech Programme into Implementation, introduce COVID-19 deliverables and add in a new Managing Director role.

## COVID-19

- 2. Due to COVID-19 school closures, over 1.6 billion children are out of school. Education technology has the potential to provide an effective emergency response to support out of school learners and teachers, and to prompt them to return to the classroom once schools reopen.
- 3. The Hub is uniquely placed to convene and catalyse a global response to this crisis, to ensure policy makers and governments are well informed to make effective decisions on the role of EdTech in distance learning.
- 4. The Hub's deliverables associated with COVID-19 over the next year (2020/21) will include the below:
  - a. CONVENING: Catalyse an improved collaborative international response by working with other organisations to bring together the global EdTech community.
  - b. CURATION: Support decision-making by documenting, synthesising, sharing, and amplifying information and evidence.
  - c. NEW EVIDENCE: With partners, generate new evidence and learning to help guide global and country response
  - d. DIRECT COUNTRY SUPPORT: Provide direct support to countries including to partners at the World Bank, DFID, BMGF and Ministries of Education.
  - e. GLOBAL GOODS and learning from innovation in low income countries: Help mitigate the impact of COVID-19 on global learners by partnering to create practical guidance for UK Department of Education officials and global policymakers.

## **Managing Director Role**

5. Following an external organisation review, the Hub were advised to recruit a Managing Director into the consortium to provide strategic leadership and overall coordination to solve critical challenges with the current flat structure of the Hub. DFID endorse this recruitment and believe that this is timely to the Hub moving into Implementation and scaling up work for COVID-19.

- 6. The Managing Director will be responsible of the below:
  - a. Lead overall strategy of the Hub and overall coordination of Directors' Group
  - b. Work closely with Directors
  - c. Resolve internal disputes around high-level budget, planning, and strategic choices
  - d. Lead donor management on behalf of Directors
  - e. Recommend directors to hire and dismiss
  - f. Represent the Hub with outside players, with strong support from Director team
