1. You are hereby informed of the Department's requirement and you are invited to accept the Offer of the Contract, in accordance with the References above, details of which are set out in the attached Modifications Contracting Form (MCF) - Issue 1. The MCF describes the requirements and sets out the contract terms and conditions which will take effect upon acceptance by you of the Department's offer.

2. Following submission of both BRE Proposals at References E & F, and the closure of all POCs under References G & H, the Contractor submitted its LOL actuals at Reference I for the Proposals Preparation Costs. As a result the Authority hereby agrees to a firm price of Redacted Under FOIA 2000 Section 43 ex VAT which is pegged on the basis that the 2021 labour hourly rate for Leonardo UK Limited may be subject to change should any revision be agreed between the Authority and the Contractor. All other costs are agreed as firm and will not be subject to change. This price is agreed without prejudice to any future negotiation on this or any other Ministry of Defence Contract.

3. Due to the current COVID-19 pandemic, the Authority proposes to accept the above contract offer exceptionally by an exchange of emails rather than signing hard copies of the same. I confirm that I am

authorised by the Authority to accept the terms of the attached contract offer and this email expresses my intention to authenticate the contract.

4. Please arrange for a person the Supplier authorises to sign contracts on its behalf to confirm by email, from their own individual email account to **Redacted Under FOIA 2000 Section 40** using the heading **Contract Offer for the Wildcat & Merlin KY-100 ECU-M Replacement BRE Proposals (LH20370 & LH20370CA1 - Contract Number: 701543401) between the Secretary of State for Defence acting as part of the Crown via Wildcat Delivery Team (the Authority) and Leonardo UK Limited (the Supplier)** that they are authorised by the Supplier to accept the terms of the attached contract offer on its behalf, that their email expresses their intention to authenticate the contract and that the Supplier agrees to be bound by those terms. The contract start date will be on acceptance of the Contract Offer provided your authorised signatory returns their email to me before then. Until I receive your authorised signatory's email, the contract will not come into force.

5. Further to the above, Leonardo UK Limited and the Authority acknowledge that the contracts, contract amendments and tasks contracted during this period do not take into account, and may be adversely affected by, the impact of COVID-19 and the exceptional measures being put in place by the UK and other Governments. Leonardo UK Limited will continue to use reasonable endeavours to mitigate such impacts, however should both parties be adversely impacted Leonardo UK Limited will notify the Authority of the extent of such impact on a case by case basis and the Parties will agree an appropriate revision in due course.

6. Your Acceptance of the Department's offer must be unqualified and within 10 (ten) working days of the date of this letter. If you do not accept the Department's offer within the period specified, then the Department's offer shall lapse.

7. When you have accepted the Department's offer in accordance with the above Paragraphs above, the Authority shall raise and notify you of the Purchase Order on CP&F against which you should then proceed with submitting your invoice for subsequent payment.
