	 Nominated Contractor personnel who will conduct the work must also have or be able to obtain a valid NATO Personal Security Clearance Certificate (PSCC) up to and including NATO Secret. These Contractors must also have performed at least one contract within the last five years substantially similar in scope and magnitude to the requirement described in NIFC's IFB.
