Section 2 – About the Contracting Authority

South Tees Site Company

On 2 October 2015 the SSI steel works in Redcar was placed into compulsory liquidation and an official receiver (OR) was appointed as liquidator. On 12 October, following no buyer for the steel works being found, the decision was taken by the official receiver to set about the hard closure of the site. Since that time the official receiver undertook a protracted liquidation of SSI and, in the absence of a new owner, he has been overseeing the safe and secure closure of the former SSI site whilst maintaining the delivery of services to other site residents. Government, through the Department for Business, Energy and Industrial Strategy, provided an indemnity to the OR so that he could carry out his duties as liquidator of the company and ensure its ongoing safety and security.

On the 1st December 2016, the Department established a Government company, known as the South Tees Site Company Ltd, in order to take forward the safety and security of the site from the OR. STSC have a management team as well as a board of directors, accountable to the BEIS Secretary of State. In order to allow the board of directors and management team to carry out their duties, as well as funding the operation of the Company, BEIS has agreed to indemnify them against all claims, proceedings, costs - including the cost of defending proceedings - and expenses.

Section 4 – Specification and about this procurement

Lot 1 – Security and Medical Rescue

Overview of Requirement

South Tees Site Company (STSC) are seeking a manned guarding service provision to include all manned security, medical rescue response, front of house, and site induction processes.

On the site there are a number of operating ventures including, Redcar Bulk Terminal, Tata Steel and British Steel, with STSC providing Security Services and technologies via a historical contract that was in place before the liquidation of SSI UK.

Due to the topography of the site, the surrounding land and areas provide varying levels of natural defence, however, the majority of incursions on to site have been conducted by pedestrians on foot, as due to the layout the land within the site boundaries, a 4 wheel drive vehicle would be required to traverse large parts of the site.

The site boundary is approximately 13.5 miles (including River Tees border) in circumference and consists of a mixture of wooden bars, palisade, chain link fencing – all in various states of repair and degradation. There are lengths of perimeter where no fence line or demarcation exists.

Further, more detailed information in relation to this requirement can be found within Appendix D – Site Map.

The South Tees Site Company (STSC) site covers an area of approximately 8 square miles, directly located on the South side of the River Tees between the towns of Redcar and South Bank. The site is accessible from the National road infrastructure via the A1085 Trunk Road and the A66 arterial thoroughfare. In addition the site is also served by a railway station within its boundary, currently with a limited service (2 trains a day) operated by Network Rail.

Site Security Scope of Works

Typical duties are as follows

- To conform with all SIA and BSIA regulations, including as a minimum, ACS status
- Control access & egress to site
- Carry out vehicle searches & identity checks
- Control manual & automatic security barriers
- Control & issue keys, access cards
- Deliver visitor, HGV & contractor inductions
- Conduct physical security patrols by both foot and vehicle
- Carry out routine vehicle searches and perimeter fence line patrols
- Attend reported crimes and investigate accordingly, taking guidance & direction from the STSC Head of security
- Perform road safety duties including speed monitoring
- Lock & alarm vehicles & buildings on site
- Escort the emergency services (Fire, Police & Ambulance) to emergency incidents on site
- Attend & investigate security intruder alarm & access control alarm activations

- Observe and report persons acting unlawfully
- Perform CCTV duties to monitor intruders, trespassers on that site; and for the protection of buildings and/or vehicles against theft or damage to the actual premises or property.
- Control site Fire, intruder alarm systems ensuring correct response is given to all alarms.
- Provide correct resource in the event of Major Incident.

Security & Safety Support

- Site Inductions for residents, contractors and visitors.
- Front of house Reception duties at Teesside Management Offices (TMO)
- Issuing & controlling Badging & Access Cards
- Administrating & operating ANPR System
- Sorting & collating Incoming and outgoing mail for STSC
- Delivery & collection of mail for STSC
- Reprographics & laminating service
- Manning & operating STSC Despatch Control Centre (DCC) Mon – Fri 0600-1800
- HGV Driver Inductions (DCC)

The list of service duties is indicative & by no means comprehensive and any other reasonable requests would be applicable.

Headcount

Current manning and organisation charts are detailed within Appendix B. Any changes made to manning levels or organisation charts during the contract must be agreed by the STSC Head of security

Additional Security

The site will continue to be broken into protection zones and each area is protected by a dedicated resources plus a site roaming team. (See Attached Site Map – Appendix D). The manning will be reviewed based on risk and crime related incidents every month. The additional security provides support to the core security and allows mobile and foot patrols in each main asset zone.

The additional security team provide 156 hours every 24 hours over 7 days, the zones areas are given 60 hours per day, 96 hours per night; this must be flexible in order to ensure you can support the risk profile of the STSC site. These requirements are subject to change.

The crew commander is responsible for daily security manning and will ensure additional security is given to areas of site which are deemed high risk.

Please review Appendix C – Security Zones for full details.

Medical Rescue Services Scope of works

Provision of a dedicated Emergency Medical Technician Service 24/7, 365 days a year to STSC. Emergency Standby Rescue Team which provides rescue cover, Monday to Friday 0800 - 1600hrs.

The team would provide 'first response' to any medical or rescue incidents during these hours.

The crew commander will manage day to day security strategies, supportive technologies

and medical rescue operations.

To include provision of:

- Support STSC with ensuring safe practices and reasonable measures are taken during high risk activities, through creating and refreshing rescue plans.
- Guaranteed cover for the entire team to include industrial dispute matters, holidays, sickness.
- Completion of risk assessments for each entry in conjunction with the respective STSC contacts.
- Management support to address any operational matters.
- Management support to attend Client review meetings as required.
- Must be competent to undertake Drug and Alcohol Testing in the out of hour's periods.

All personnel to be trained to emergency medical technician level (EMT or ITLS) and with confined space rescue, working at height/line rescue qualifications that are mentioned within the quality questionnaire.

In the event of an emergency incident occurring, incidents that may involve trapped persons in distress, then the services team will have the ability to carry out a rescue and delivery of the necessary Medical care.

Provision of one fully equipped Ambulance for on board treatment (mobile treatment room) and or transport of any casualties to the STSC Medical facilities

Provision of one marked up Emergency 'rapid response / Rescue' (4x4 or multi terrain type) vehicle to include all the necessary equipment to undertake the works, consisting of, but not limited to;

Immediate trauma package
Oxygen resuscitation bag
Entonox bag
Burns kit
Spinal immobilisation equipment
Rescue stretchers
Rope rescue equipment
Confined space access equipment
Breathing apparatus
Intrinsically safe search light and radio
Blood glucose monitoring
Eye irrigation

Supplier Minimum Service Obligations (as above provisions) to include but not limited to:

Provision of a suitably trained/experienced and skilled team to deliver the services in a professional and competent manner in line with Industry Best Practice

Supply on site team to assess on site patient condition at incident scene and decide on level of assistance required form external agencies and request the attendance of Local Authority Ambulance Service (NEAS) where required.

Supplier will provide Emergency medical care to stabilise medical emergencies and perform any required critical interventions e.g. decontamination, defibrillation etc., up to the point of patient transfer to the appropriate hospital via the NEAS.

Fleet Requirement

The security vehicle requirements for the STSC site are required to meet the requirements below, STSC will be responsible for providing and maintaining any other vehicles needed for this requirement:

- Ambulance x 1
- Emergency 'rapid response / Rescue' (4x4 or multi terrain type) vehicle x 1

The successful supplier will be responsible for maintaining the above mentioned vehicles.

Due to the ever changing nature of this requirement there will be situations in which new KPIs will need to be incorporated in to this contract to ensure the safety of both staff and members of the public. For this reason during contract mobilisation and after there may be the need to add in revised KPIs that will be mutually agreed between STSC and the successful supplier.

An NDA – Appendix J (that can be found attached within the RFX attachments section of this tender) must be completed and returned to UK SBS prior to receiving appendix E and F, bidders will also need to ensure this has been completed and returned prior to attending the site visit. No bidders will be permitted site access unless this document has been signed and returned prior to this visit.

Bidders will be required to provide their own PPE for the site visits. All bidders must bring hard hats, eye protection, High Viz jacket and boots.

Contract Duration

The Contract duration shall be for a period 2 years with optional extension of a 1 year period from commencement of the Contract.

Lot 2 – Provision of Security Cameras

Overview of Requirement – Wireless Outdoor Motion Viewer Cameras

The below scope provides detail on the current cameras in situ on this site, however the Contracting authority are prepared to accept bids for cameras that meet the below scope as a minimum any bidder that is able to provide added value to improve this service should provide the details of the proposed camera within the response.

Any bidder proposing a different suite of cameras should including a full specification of the camera as part of their proposal.

Scope of Requirement

Wireless outdoor motion viewer camera equipment is required to support STSC in the detection and prevention of crime, c600 passive infrared cameras are required to assist in the detection and monitoring of unauthorised personnel on the STSC site. This technology will be required to operate inside & outside buildings, including at height, 24/7 365 days per year security operations. The technology will support the security team and provide early warning detection. The desired approach of this system is to provide an early warning alarm which will be confirmed to our onsite control room, once the system has gone into alarm your control centre will confirm time, date and location camera number to the onsite security control room, very quickly followed by the video clip of confirmation.

As a minimum the equipment should have the ability to comply with the following requirements;

- Compliance to **BS5979 CAT II/BS8484 (2011)** or equivalent as a minimum.
- Provide maintenance schedule for the contract duration on all systems provided
- Wireless technology
- Outdoor monitoring capabilities
- Battery operated supplied with lithium batteries
- Colour images
- Anti – tamper
- Provide signal from both internal and external plant areas
- Be utilised in vacant property
- Alert STSC (on-site control room) within 4minutes as a minimum
- The ability to be deployed in high and low risk areas
- Provide a recording which may need to be used in both criminal and civil prosecution
- 8 meter detection using two infrared LED
- Motion detector from which deliver 90 degree coverage of up to 12 meters
- Rapid detection and begins recording within 100 milliseconds
- Self-supervised transmitting on a 8 minute continued status
- The software provided must allow you to record the activation history of our property

- The software provided must allow you to provide full incident reports and audit trails, including audio and video footage where necessary?
- Provision for a 24 hour manned listening station
- The proposed cameras must have the facility to turn off cameras via a locally sited key pad, this must be a capability offered, and detailed, in the specification you submit.

The system must be fully installed by the contractor, and have the ability to be monitored via an offsite or onsite location. Cameras will be on a lease basis and the contractor will remove at the end of the contract period. The offsite alarm centre recording must be delivered to the STSC control room via email .The information must adhere to all data protection legislation and meet the accredited association, This technology is being utilised as an essential tool, to protect the assets and infrastructure. STSC reserve the right to increase and decrease the number of cameras required, depending on operational changes. For example we may have some high risk areas due to new projects where we require further cameras to be installed.

Contract Duration

The Security Cameras Contract duration shall be for a period of 2 years with the option to extend for a further year

Award Evaluation of criteria

Non-Price elements

Each question will be judged on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

$$\text{Score} = \{\text{weighting percentage}\} \times \{\text{bidder's score}\} = 20\% \times 60 = 12$$

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Example

Evaluator 1 scored your bid as 60
 Evaluator 2 scored your bid as 40
 Evaluator 3 scored your bid as 80
 Evaluator 4 scored your bid as 60
 Your final score will $(60+40+80+60) \div 4 = 60$

Price elements will be judged on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the price criterion.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 $(80/100 \times 50 = 40)$

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

 - 7.3.1.2 Bidders shall not disclose, copy, reproduce, distribute or pass any of the Information to any other person at any time or allow any of these things to happen;
 - 7.3.1.3 Bidders shall not use any of the Information for any purpose other than for the purposes of submitting (or deciding whether to submit) a Response; and
 - 7.3.1.4 Bidders shall not undertake any publicity activity within any section of the media in relation to this procurement

- 7.3.2 Bidders may disclose, distribute or pass any of the Information to the Bidder's advisers, sub-contractors or to another person provided that either:

7.4 Freedom of information

7.4.1 In accordance with the obligations and duties placed upon public authorities by the Freedom of Information Act 2000 (the 'FoIA') and the Environmental Information Regulations 2004 (the 'EIR') (each as amended from time to time), UK SBS and the Contracting Authority may be required to disclose information submitted by the Bidder to the to the Contracting Authority.

7.4.2 In respect of any information submitted by a Bidder that it considers to be commercially sensitive the Bidder should complete the Freedom of Information declaration question defined in the Question FOI1.2.

7.4.3 Where a Bidder identifies information as commercially sensitive, the Contracting Authority will endeavour to maintain confidentiality. Bidders should note, however, that, even where information is identified as commercially sensitive, the Contracting Authority may be required to disclose such information in accordance with the FoIA or the Environmental Information Regulations. In particular, the Contracting Authority is required to form an independent judgment concerning whether the information is exempt from disclosure under the FoIA or the EIR and whether the public interest favours disclosure or not. Accordingly, the Contracting Authority cannot guarantee that any information marked 'confidential' or "commercially sensitive" will not be disclosed.

- 7.7.3 Bidders should be mindful that the designated Contact should not under any circumstances be sent a copy of their Response outside of the e-sourcing tool. Failure to follow this requirement will result in disqualification of the Response.

7.8. Preparation of a Response

- 7.8.1 Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. Bidders are solely responsible for all costs, expenses and other liabilities arising in connection with the preparation and submission of their Response and all other stages of the selection and evaluation process. Under no circumstances will UK SBS or the Contracting Authority, or any of their advisers, be liable for any such costs, expenses or liabilities borne by Bidders or their sub-contractors, suppliers or advisers in this process.
- 7.8.2 Bidders are required to complete and provide all information required by the Contracting Authority in accordance with the Conditions of Response and the Request for Proposal. Failure to comply with the Conditions and the Request for Proposal may lead the Contracting Authority to reject a Response.
- 7.8.3 The Contracting Authority relies on Bidders' own analysis and review of information provided. 7.9.4 Any financial data provided must be submitted in or converted into pounds sterling. Where official documents include financial data in a foreign currency, a sterling equivalent must be provided. Failure to adhere to this requirement will result in the Response not being considered.

7.9.5 The Contracting Authority do not accept responsibility for the premature opening or mishandling of Responses that are not submitted in accordance with the instructions of this document.

7.9.6 The Response and any documents accompanying it must be in the English language

7.9.8 Responses will be submitted any time up to the date indicated in [Section 3](#). Responses received before this deadline will be retained in a secure environment, unopened until this deadline has passed.

7.9.9 Responses received after the date indicated in [Section 3](#) shall not be considered by the Contracting Authority unless the Bidder can justify the reason for the delay.

7.9.9.1 The Bidder must demonstrate irrefutable evidence in writing they have made best endeavours to ensure the Response was received on time and that the issue was beyond their control.

7.9.9.2 Any request for a late Response to be considered must be emailed to the Buyer in [Section 3](#) in advance of 'the deadline' if a bidder believes their Response will be received late.

7.9.9.3 The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.

7.11.2.1 makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or

7.11.2.2 accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.

7.12.1.2 communicates to any party other than UK SBS, the Contracting Authority or, as applicable, relevant OPB the amount or approximate amount of its proposed Response or information which would enable the amount or approximate amount to be calculated (except where such disclosure is made in confidence in order to obtain quotations necessary for the preparation of the Response or insurance or any necessary security); or

7.12.1.3 enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or

7.12.1.4 enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or

7.12.1.5 offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to

any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission, shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

7.13.1 The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

7.14.1 The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 5 days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.

7.14.2 The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

7.15.1 All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Emptoris or Crown Commercial Service system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in [Section 3](#).

7.15.2 The Contracting Authority will endeavour to answer all questions as quickly as possible, but cannot guarantee a minimum response time.

7.15.3 In the event of a Bidder requiring assistance uploading a clarification to the e-sourcing portal they should use the contact details defined in [Section 3](#).

7.15.4 No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.

7.15.5 In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.

7.15.6 Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:

- 7.15.6.1 invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
- 7.15.6.2 request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.

7.15.7 The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

7.16.1 At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

7.17.1 Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.

7.17.2 Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

7.18.1 The Contracting Authority reserves the right to reject or disqualify a Bidder where

- 7.18.1.1 the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
- 7.18.1.2 the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
- 7.18.1.3 there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

7.19.1 The Contracting Authority reserves the right to:

- 7.19.1.1 cancel the evaluation process at any stage; and/or
- 7.19.1.2 require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

7.20.1 The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union in accordance with the Regulations within 30 days of the award of the contract.

7.20.2 As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.
