#### 1. Introduction

- 1.1 This appendix contains information on the current (Table 1), projected (Table 2), and Incremental ULEZ Central (Table 3) volumes of specific transactions for Business Operations.
- 1.2 In the next few years TfL will be actively moving customers from using post, retail and phones to online (web) self service transactions. The projected volumes in Table 2 are TfL's best estimate of these and other changes.
- 1.3 The information in both Table 1, Table 2 and Table 3 contain information on scanning and processing. Please note this information applies to both Business Operations and Enforcement Operations as it is not possible to distinguish the volumes for each operation.
- 1.4 The information in Table 1, Table 2 and Table 3 contains combined Business Operations and Enforcement Operations information for the size of the document stores. It was not possible to provide the information solely for Business Operations so the following information is provided on the average size and volumes of PCNs, Representations, and Appeals for Enforcement Operations in order to project the size of the storage requirements for Business Operations without Enforcement Operations included:
