Job Background

The MIRRLEES K Model: 16 KV MAJOR Diesel Generator at Redcar Power station was used to generate electricity during a total power outage for SSI –UK operations.

Since the liquidation of SSI-UK the generator has supported the site during triad periods to help generate electricity for the South Tees Site to avoid charges.

The generator has low running hours and the general condition of the engine is good, however due to its age and its importance to the site, STSC need to carry out some essential repairs and create annual maintenance routines to avoid costly and lengthy breakdowns and to ensure the availability and reliability of the generator.

The diesel generator is located in its own building c/w overhead crane.

Scope

All work to be carried out during the non-triad periods between Monday to Friday.

The supplier is to include costs for:

Labour (including estimated normal and overtime hours, any travelling time and accommodation)

All parts and equipment.

- Supply and install and reseal 15 x fuel injectors
- Supply and install and reseal 16 x fuel pumps
- Supply and install and reseal 8 x oil filters •
- Replace lube oil (STSC will provide the required Rimula 30 oil) Contractor to drain off & flush • out the old oil

- Carry out annual maintenance & health checks which must include the following :
 - Crankshaft Deflections to be taken and recorded
 - Carry out lube oil analysis (not required first visit)
 - Remove and inspect/test oil pressure relief valve
 - Inspect/test Lube oil thermostats.

 - Overhaul & reseal of injectors (not require first visit)
 Overhaul & reseal of fuel pumps (not require first visit)
 - o Monitoring of the cylinder liner O rings (due to age). STSC accept that the O rings are in poor condition but these do not warrant a costly strip and rebuild at this time unless monitoring identifies a major problem.
 - o On completion of the annual maintenance and health checks STSC to be provided with a detailed report on the condition of the generator and any recommendations.
- Supply of one spare cylinder head including a full set of cylinder head gaskets and stretch bolts to be held on stock at Redcar in the event of a failure so that downtime is minimal. Bidder to confirm process and procedure to allow for the above to be fitted should an issue occur.

STSC will provide a work request form (initiator for safety documentation) c/w hazard ID for area location

All personnel must complete a visitor request form prior to arriving at site and attend a site induction (at Redcar security Gate).

Contractor to provide all method statements and RAs taking into account the hazards for the area location prior to commencing the work. Each member of the working party must sign the documents and a copy of the method statements and RAs must be readily at hand in case for any reference required.

Minimum PPE includes safety boots, hard hat, LEP and overalls.

A Daily Permit to Work will be issued to the working party each day by the STSC Site Manager to ensure all controls are in place prior to commencing any work.

Washing and Mess facilities will be provided by STSC.
