GRASS CUTTING 1st April 2024 to 31st March 2027

You are invited to submit a quote on the enclosed form for cutting various areas of grass within the village of Roade.

The areas to be cut are those shown in dark green on the attached map.

The Contract will run for a 3-year period commencing on 1st April 2024 to 31st March 2027 and the stipulated number of cuts must be carried out at regular intervals throughout the season.

Depending on growth, more frequent cuts may be required and ordered by the Parish Council. These additional cuts will be at the price shown for "Single cuts" on the tender form.

If you would be interested in being awarded the contract for a three-year period, could you please include quotes for grass cutting for the next three years on the understanding that the price remains as quoted for the season 2024/25, 2025/26, 2026/27.

All work carried out must be to the satisfaction of the Parish Council who reserve the right to terminate the contract by giving one months' notice in writing.

The successful contractor must agree to comply with the standards detailed in the specification and must forward a copy of their Public Liability insurance and herbicide certificate to the Parish Clerk before commencing the contract.

Prices to be quoted for a three-year contract, using own machinery and fuel.

NO. 1 ROADE VILLAGE VERGES – April 2024 – March 2027

To be cut with a Mulch cutter mower, and trimmed around hedge bottoms, street furniture and street lighting poles, within the 30mph limit as per the map.

Trees to be sprayed around the base 3 times per year to prevent trimmer damage.

NO.2 CHURCHCROFT PLAY AREA – April 2024 – March 2027

To be cut to a height of 25mm and trimmed around play equipment and furniture.

Monthly trim of Churchcroft Drainage gully.

Weed kill along paths round base of trees and along perimeter fences 3 times per year.

Weedkill along end of path leading up Croft Lane at bottom of Churchcroft to A508 x 3/yr.

NO.3 CEMETERY GRASS CUTTING - April 2024 – March 2027

Grass cuttings to be collected and removed every time, and mowings blown off grave stones to keep them clean, the Cemetery to be cut in its entirety on the day of mowing.

Special care to be taken when working in the cemetery.

NO.3B. CEMETERY EXTENSION GRASS CUTTING – Autumn 2024 – March 2027

Special care to be taken when working in the cemetery and extension.

SPECIFICATION AND PROCEDURE FOR PARISH GRASS MOWING.

By undertaking to cut their own grass, parish councils are in effect acting as the agents for the County Council, and therefore must ensure that the same standards are met.

1. FREQUENCY

Highway verge grass in villages will be cut 18 times.

2. AREAS TO BE CUT:

The grass will be cut as follows: -

- i) All grass on fully developed frontages
- ii) The full area of roundabouts and splitter islands except where planted.
- iii) A minimum of 2.4m wide strip on undeveloped frontages immediately adjacent to the carriageway, except where there is a road junction where the full verge width should be cut for 100m either side of the centre point of any road junction, on the same side as the junction.
- iv) A minimum of 1.2m wide strip immediately adjacent to both sides of footways/footpaths. Where a verge exists between the carriageway and the footway, the whole area will be cut.
- v) Planted areas (such as daffodils and other spring flowering bulbs) will not be mown until advised to do so by the supervising officer.
- vi) Where a visibility splay at a junction extends outside the urban area the full visibility splay will be cut to the urban frequency.

Notes for guidance: An urban boundary is defined as the speed limit sign or village nameplate whichever may be furthest.

3. STANDARDS

Cutting of grass verges

- a) The Contractor will cut all grass areas as specified, so that the height of vegetation does not exceed 50mm. The whole area will be cut leaving no areas uncut between rows or ribbing.
- b) Grass adjacent to walls and around street furniture, safety fencing and statutory undertakers and other apparatus (e.g., Markers) will be cut using hand strimmers or similar. Alternatively, the immediate area around such obstructions may be treated with weed killer on the first cycle only. All items of street furniture within areas to be cut will be treated in a similar fashion.
- c) Cutting may be carried out either by manual or mechanical means. All machinery will be suitable for the purpose and fitted with all appropriate screens and safety guards as specified by the manufacturer. All blades will be kept sharp and will cut and not rip the grass. No machinery shall be refuelled or lubricated on the grass area and must also be carried out away from buildings.
- d) Cuttings will be removed from metalled surfaces such as footways and carriageways and other areas as directed.
- e) When the verge on one side of any section of road is cut, the verge on the opposite side will be cut within two (2) days.
- f) The Contractor shall be required to re-cut any area, deemed by the Supervising Officer to be unsatisfactorily mown, at their own expense, and by the time specified by the Supervising Officer.

- g) In the case of prolonged inclement weather or adverse conditions, contact the supervising officer for advice.

4. INSURANCE

A public liability insurance of ten million pounds (£ 10,000,000) for any one incident has to be taken out by those undertaking the mowing and a copy sent to the Clerk of the Parish Council prior to commencement of the contract.

Weed Killing will be carried out by a suitably qualified person and a copy of the Herbicide certificate forwarded to the Parish Clerk.

5. TRAFFIC MANAGEMENT

Should comply with Chapter 8 of the Department of Transport's Traffic Manual i.e., any mowing outside a 30mph limit is signed, ride on mowers/vehicles are fitted with rotation amber beacons and are switched on when vehicle is in use, operatives will wear hi-visibility clothing, mowers will travel with the flow when cutting from the road. Operators should be aware of pedestrians and not impede progress.

6. HEALTH AND SAFETY

The contractor is expected to comply with all current Health and Safety Legislation. This is the responsibility of the contractor.

7. CLAIMS FOR PAYMENT

Payment will normally be made in the month following submission of invoice.

Invoices to be received by the first Tuesday of the month for payment following that month's parish council meeting.

Invoices must be submitted monthly and itemised.
