Joint Schedule 3 (Insurance Requirements)

1) The insurance you need to have

- (a) The Supplier shall take out and maintain, or procure the taking out and maintenance of the insurances as set out in the Annex to this Schedule, any additional insurances required under a Call-Off Contract (specified in the applicable Order Form) ("**Additional Insurances**") and any other insurances as may be required by applicable Law (together the "**Insurances**"). The Supplier shall ensure that each of the Insurances is effective no later than:

- 42.1.1** ensure that that all wages and benefits paid for a standard working week meet, at a minimum, national legal standards in the country of employment;
- 42.1.2** ensure that all Supplier Staff are provided with written and understandable Information about their employment conditions in respect of wages before they enter employment and about the particulars of their wages for the pay period concerned each time that they are paid;
- 42.1.3** not make deductions from wages:
 - 42.1.3.1 as a disciplinary measure
 - 42.1.3.2 except where permitted by law; or
 - 42.1.3.3 without expressed permission of the worker concerned;
- 42.1.4** record all disciplinary measures taken against Supplier Staff; and
- 42.1.5** ensure that Supplier Staff are engaged under a recognised employment relationship established through national law and practice.

43. Working Hours

43.1 The Supplier shall:

- 43.1.1** ensure that the working hours of Supplier Staff comply with national laws, and any collective agreements;
- 43.1.2** that the working hours of Supplier Staff, excluding overtime, shall be defined

by contract, and shall not exceed 48 hours per week unless the individual has agreed in writing;

43.1.3 ensure that use of overtime used responsibly, taking into account:

- (1) the extent;
- (2) frequency; and
- (3) hours worked;

by individuals and by the Supplier Staff as a whole;

5.2 The total hours worked in any seven day period shall not exceed 60 hours, except where covered by Paragraph 5.3 below.

5.3 Working hours may exceed 60 hours in any seven day period only in exceptional circumstances where all of the following are met:

5.3.1 this is allowed by national law;

5.3.2 this is allowed by a collective agreement freely negotiated with a workers' organisation representing a significant portion of the workforce;

5.3.3 appropriate safeguards are taken to protect the workers' health and safety; and

5.3.4 the employer can demonstrate that exceptional circumstances apply such as unexpected production peaks, accidents or emergencies.

5.4 All Supplier Staff shall be provided with at least one (1) day off in every seven (7) day period or, where allowed by national law, two (2) days off in every fourteen (14) day period.
