Appendix 2: Specification/Description

1) To refurbish existing ST65

Test hydraulics and engine for any obvious faults

Strip down of complete machine

Shot blasting and repainting of chassis, undercarriage, cab etc

Strip down and modify rear body and re-galvanize. Fit new flooring and front panels.

Service of hydraulic system and engine. (Does not include any replacement of parts or major rebuilds of engine or hydraulic system)

Re-assemble cab with new roof, screens, door rubbers, gas struts and cab mounts. Modify rear light mounts so rear lights can be fitted with chip bin. Using existing seats.

Reassemble chassis

Reassemble undercarriage, fitting new seals to track rollers where required. Fit new sprockets.

Change track tension rams to new type with accumulators to allow front idler to retract if stone or foreign object gets lodged in the track

Fit engine and transmission with new hydraulic hoses, All new filters, AV mounts and other rubber hoses.

Updated Cooling system. This requires modification to chassis, rear body, chip bin headboard and a new style air intake duct.

Joystick with hydraulic pilot control to replace existing cable system.

Fit cab and run up engine and transmission and test.

Refit body.

Fit tracks and then do run in test for 3 hours

Full PDI

To modify existing forager and fit cameras
