STAR PACKAGE ORDER PPRO 04/101/057: Thameslink Assurance Advisor

THIS AGREEMENT is made on the 27th January 2017

BETWEEN:

- (1) **Department for Transport, Great Minster House, 33 Horseferry Road, London SW1P 4DR (“the Employer”)**
- (2) **Gutteridge Haskins & Davey Limited, 4 Innovation Close, York Science Park, York, YO10 5ZF, United Kingdom (“the *Supplier*”).**

WHEREAS:

- (A) The Supplier has been appointed to the Specialist Technical Advice for Rail (STAR) Framework and has entered into a framework agreement in relation to its appointment (the “Framework Agreement”).
- (B) The *Employer* wishes to appoint the Supplier to provide certain services outlined in the Department’s Service Description issued on 21st October 2016 and subsequent clarifications. The contract will commence from 30th January 2017 and conclude 30th January 2019.

(C) The Supplier has submitted a Proposal dated 17th November 2016, and subsequent clarification dated 23rd November 2016, 9th December 2016, and 23rd December 2016 in response to the *Employer's Work Package Request Form* in accordance with terms of the Framework Agreement. The *Employer* has examined the Supplier's said tender and subject to the provisions of this contract is willing to engage the Supplier to carry out those services in accordance with this contract.

NOW IT IS AGREED THAT:

1. In this Agreement, unless the context otherwise requires, words and expressions have the same meanings as set out in the *NEC Conditions of Contract*.
2. This contract shall mean this document and the following documents which are hereby incorporated into and shall comprise this contract:
 - (i) The *NEC Conditions of Contract* are the *NEC Professional Services Contract* (Third Edition April 2013 with amendments June 2006 and September 2011) together with and as amended by *Dispute Resolution Option W2*, and *Secondary Option Clauses* as specified in the *Contract Data Part One, Y(UK)2* (with amendments dated September 2011);
 - (ii) The *Contract Data Part One* (including, the *Option Z* clauses set out in the *Contract Data Part One*);
 - (iii) The *Contract Data Part Two*;
 - (iv) The terms of the *Framework Agreement* insofar as they relate to the provision of services;
 - (v) Your resource and pricing schedule under your reference *Table 1a "Multiple rates - Proportions"* dated 23rd December 2016.
 - (vi) Your signed *COI* declarations dated 17th November 2016.
3. The *Supplier* shall provide the *scope* of services (as set out in the *Contract Data Part 1*) in accordance with this contract.
4. The *Supplier* reaffirms that, under *Section 14* of the *Framework Agreement*, the *Supplier* acknowledges and agrees that it does not have an interest in any matter where there is

or is reasonably likely to be a conflict of interest with the Services and that (except as provided below) it shall not act for any person, organisation or company where there is or is reasonably likely to be a conflict of interest with the Services.

5. In consideration of the provision by the Supplier of the [Services] the *Employer* shall pay to the *Supplier* the amount due in accordance with this contract.
6. You must be in possession of a purchase order (PO), before commencing any work under this contract. You will be informed of the PO for this contract in due course. Invoices submitted to the Department **must also quote the PO number** and must be submitted as directed **in the PO to:**

7. This contract supersedes and extinguishes any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature whatsoever in relation to this contract. No variation to this contract, after the date hereof, will be made except with the written consent of the Parties provided that this is without prejudice to the *Employer's* rights to issue instructions in accordance with this contract.
