There is a need to amend this Call-Off Contract to extend and uplift it's value due to the team's continued and increased need for the tool.

Full Details of the proposed changes;

- The current contract expiry date is on **25 April 2022**.
The new contract end date is now **25 April 2023**.
- The Initial Call-Off Contract value was **\$9,340**
This Contract Variation Number One for a further 12 months extension and an additional 10 licences is quoted at **\$14,010**
So, the new Total Call-Off Contract Value is now **\$23,350**.

Likely impact, if any, of the change on other aspects of the Call-Off Contract;

The Call-Off Contract expiry date and value is amended as shown above and milestone deliverables will be mandatory and will be reviewed regularly throughout the contract and potentially amended at least each quarter.
