2 Call-Off Contract Specification - Deliverables Context

Simpler Better Funding - Brief for UCD Supplier

The Simpler and Better Funding (SBF) programme is a major transformation programme within UKRI. It is designing and delivering a unified Funding Service for UKRI to replace legacy systems and provide a simpler user experience for its applicants, assessors, and internal users. Legacy systems are no longer fit for purpose and do not reflect UKRI's current and future needs as the largest provider of research and innovation funding to UK organisations.

The SBF Programme includes key change areas within it that aim to simplify and harmonise processes across the 9 research councils to provide a single and unified platform with common processes and a new target operating model. Once delivered into Live Continuous Improvement, the Service will transition to and be managed by UKRI and internal digital teams.

Currently in Private Beta we are running pilot opportunities through an MVP for the application and assessment phases to test and iterate, whilst latter phases of the Service are still being designed and built.

We expect our UCD supplier to work collaboratively as part of blended Teams, made up of existing UKRI staff, contractors, and other suppliers to deliver against our vision and roadmap working in an agile way. Working in agile can mean that priorities and deliverables can change over time, therefore we will be working to quarterly Statements of Work, aligned to our planning cycles. We will support delivery progress by putting in place regular engagement meetings (frequency TBD) to review the ongoing collaboration and provide the opportunity for both UKRI and the Supplier to review ongoing delivery, resources, and finances.

Our upcoming key milestone is the delivery of an MVP for the end-to-end journey for the 7 research councils, which enables migration from legacy systems by December 2023. Beyond this we will look to iterate and improve the service while expanding its use to Innovate UK and Research England by March 25 and work with UKRI internal teams to agree the transition and operation of the Service as BAU

Key areas of focus will be:

- Supporting the delivery teams by producing wireframes, prototypes and design outputs that help the team to build key functionality to meet our roadmap outcomes
- Initiating and delivering user research and testing that helps us understand what our users need in line with UKRI requirements including our EDI strategy
- Continuing our work to simplify and standardise content within our service as a whole Running forward look discoveries in partnership with our colleagues across the Simpler
- and Better Funding programme Continuing the work of simplifying our funding types
- Helping to define, document and roll-out our new target operating model, providing suggestions and feedback where there's opportunity for improvement
- Making sure the end-to-end service is continuously designed, monitored, and reviewed

vve expect our UCD supplier to work collaboratively as part of blended Teams, made up of existing UKRI staff, contractors and other suppliers to deliver against our vision and roadmap working in an agile way.
