- The Enterprise License [REDACTED] is to be invoiced annually in advance with the charge for years 2 onward (if extension options are used) invoiced on the contract anniversary.
- On-going Support [REDACTED] shall be invoiced annually in advance.
- Training Package for up to 100 system administrators [REDACTED] shall be invoiced in advance and shall be used within the initial 2-year term.
- The "Price per Participant" [REDACTED] per participant) shall be invoiced half-yearly in arrears based on actual participants in events. An itemized list is to be provided to Innovate UK with the invoice.

Salesforce API Integration:

- Due to changes in internal UKRI strategy since the contract award, Innovate UK can no longer confirm that API integration with Salesforce will be required within the 2-year contract term. Therefore, associated charges of Event Meeting Brokerage Tool One-off Cost (£5,000.00) and Implementation (£8,000.00) will not apply.

Should circumstances change and API integration with Salesforce be required, B2Match have requested a minimum of 3-months' advance notice.
