
Scrub clearance: Scrub to be flailed as close to the ground as possible, leaving a fine mulch.

Bunding:

Bunding Process


- · Remove vegetation and degraded peat. Set aside.
- · Dig into peat, up to 1.5m depth.
- Move excavated peat back into trench and compact peat on a frequent basis.

 Use a borrow pit for additional peat as required.
- Build bund up to a maximum of 40cm above ground
- · Replace original vegetation on top of bund.
