 - commits or has committed any prohibited act or any offence under the Prevention of Corruption Acts 1889 – 1916, under sub sections 108 – 109 of the Anti-Terrorism or Crime and Security Act 2001 before these Acts or sub sections are revoked or an offence under the Bribery Act 2010 with or without the knowledge or authority of the Contractor in relation to this Contract or any other contract with the Crown;
 - has entered into this or any other contract with the Crown in connection with which commission has been paid or has been agreed to be paid by it or on its behalf, or to its knowledge, unless before the contract is made particulars of any such commission and of the terms and conditions of any such agreement for the payment thereof have been disclosed in writing to the Authority.

 In exercising its rights or remedies to terminate the Contract under
- Clause 14.a. the Authority shall:
 (1) act in a reasonable and proportionate manner having regard
 - to such matters as the gravity of, and the identity of the person committing the prohibited act;

- give due consideration, where appropriate, to action other than termination of the Contract, including (without being limited to):
 - requiring the Contractor to procure the termination of a subcontract where the prohibited act is that of a Subcontractor or anyone acting on its or their behalf, requiring the Contractor to procure the dismissal of an
 - employee (whether its own or that of a Subcontractor or anyone acting on its behalf) where the prohibited act is that of such employee.
