This Notice is published as a corrigendum to the Contract Award Notice to confirm the Authority's award of this contract to ABL Health Ltd (Co. reg. 07074944) .The contract term is for 5 years from 1st September 2024, with the option to extend up to 31st August 2031.Total contract value and potential extensions is £2,238,250.70.The evaluation was undertaken by: Finance Manager for Public Health - Resources, Social Value Programme Manager - CPS, Interim Head of Commissioning – Public Health, PH Contract Manager & Commissioning Support Officer, Senior Commissioning Manager. Recommendation to award was approved by Director of Public Health, Education and Inclusion. There were no declared or potential conflicts of interest, and decision makers were required to complete a Conflict of Interest Undertaking.
