


The Authority's preference is for all invoices to be sent electronically, quoting a valid Purchase Order number.</p> <p>Payment of 50% of the total contract value will be made on receipt of a detailed invoice following completion (to the satisfaction of the Natural England Nominated Officer) of the field work and draft GIS outputs. The remaining 50% of the total contract value will be made on receipt of a detailed invoice following completion (to the satisfaction of the Natural England Nominated Officer) of all the milestones detailed above, and formal acceptance by them of the specified outputs i.e. final reports. All invoices should be dated no later than 20<sup>th</sup> December 2024.</p> <p>It is anticipated that this contract will be awarded for a period of 36 weeks (~ 8 months) to end no later than 20<sup>th</sup> December 2024. Prices will remain fixed for the duration of the contract award period. We may at our sole discretion extend this contract to include related or further work. Any extension shall be agreed in writing in advance of any work commencing and may be subject to further competition.</p>
